Test Procedure: The procedure uesd was ANSI Standard C63.4-2001. The receive was scanned from 30MHz to 1000MHz. When an emission was found, the table was roated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. The worst case emissions were reported.

The following measurements were performed on the EUT on 7 May 2004: Test the EUT in transmitting mode.


