## 1. GENERAL INFORMATION

### 1.1 Product Description

The HUGES HI-TECH INC. Model: 332A, 307 (referred to as the EUT in this report) is Bluetooth Headset.

The EUT is compliance with Bluetooth Standard.

B). Rated output power: 3 dBm

C). Modulation type: Frequency Hopping Spread Spectrum (FHSS)

D). Antenna Designation: Dipole Antenna, 1 dBi, Non-User Replaceable (Fixed)

E). Power Supply: Input: 5V DC by AC/DC Power Adapter

### 1.2 Related Submittal(s) / Grant (s)

This submittal(s) (test report) is intended for FCC ID: **RKH-HS332A** filing to comply with Section 15.247 of the FCC Part 15, Subpart C Rules. The composite system (receiver) is compliance with Subpart B is authorized under a Doc procedure.

### 1.3 Test Methodology

Both conducted and radiated testing were performed according to the procedures in ANSI C63.4 (1992). Radiated testing was performed at an antenna to EUT distance 3 meters.

### 1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located on the address of SGS Taiwan Ltd. No. 134, Wu Kung Rd., Wuku Industrial Zone, Taipei Country, Taiwan. The Open Area Test Sites and the Line Conducted labs are constructed and calibrated to meet the FCC requirements in documents ANSI C63.4: 1992 and CISPR 22/EN 55022 requirements. ## 2. SYSTEM TEST CONFIGURATION

### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2 EUT Exercise

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

### 2.3 Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-1992. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and Average detector mode.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-1992.

### 4. DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

Test program used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

Channel low (2402MHz) 、mid (2441MHz) and high (2480MHz) with 741k highest data rate are chosen for full testing with AC/DC power adaptor, which was the worse condition.

### 5.1 Standard Applicable

### 5.2 EUT Setup

1. The conducted emission tests were performed in the test site, using the setup in accordance with the ANSI C63.4-1992.
2. The AC/DC power adapter of EUT was plug-in LISN of the back edge on the test table.
3. The system was connected with 110Vac/60Hz power source.

### 5.3 Measurement Procedure

1. The EUT was placed on a table which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. Repeat above procedures until all frequency measured were complete.

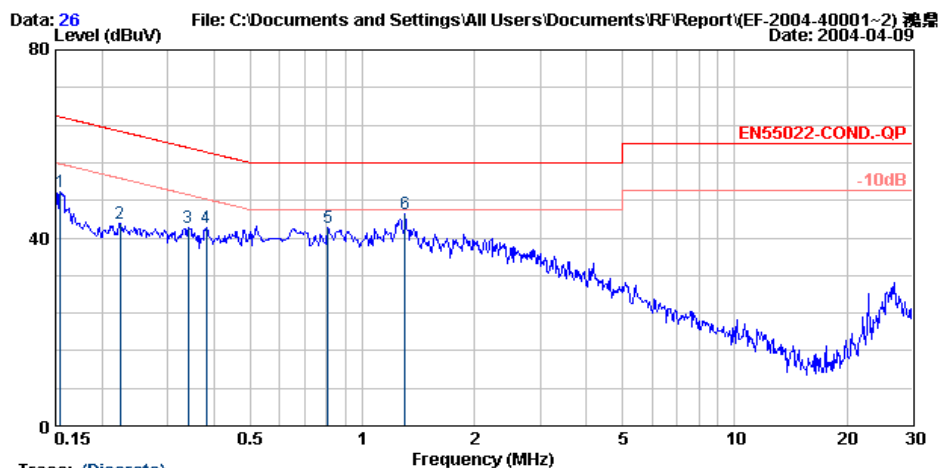

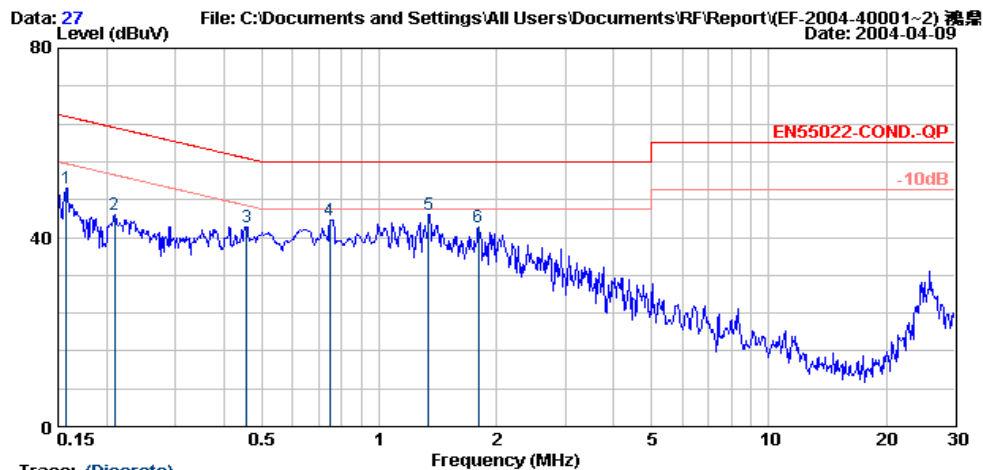

## 6. PEAK OUTPUT POWER MEASUREMENT

### 6.1 Standard Applicable

For frequency hopping systems operating in the band employing at least 75 hopping channels, and all frequency hopping systems in the 5725-5850MHz band: 1Watt. For all other frequency hopping systems in the 2400 – 2483.5MHz band: 0.125 Watts.

### 6.2 Measurement Procedure

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the power meter or spectrum. (Channel power function, RBW, VBW = 1MHz)
3. Record the max. reading.
4. Repeat above procedures until all frequency measured were complete.

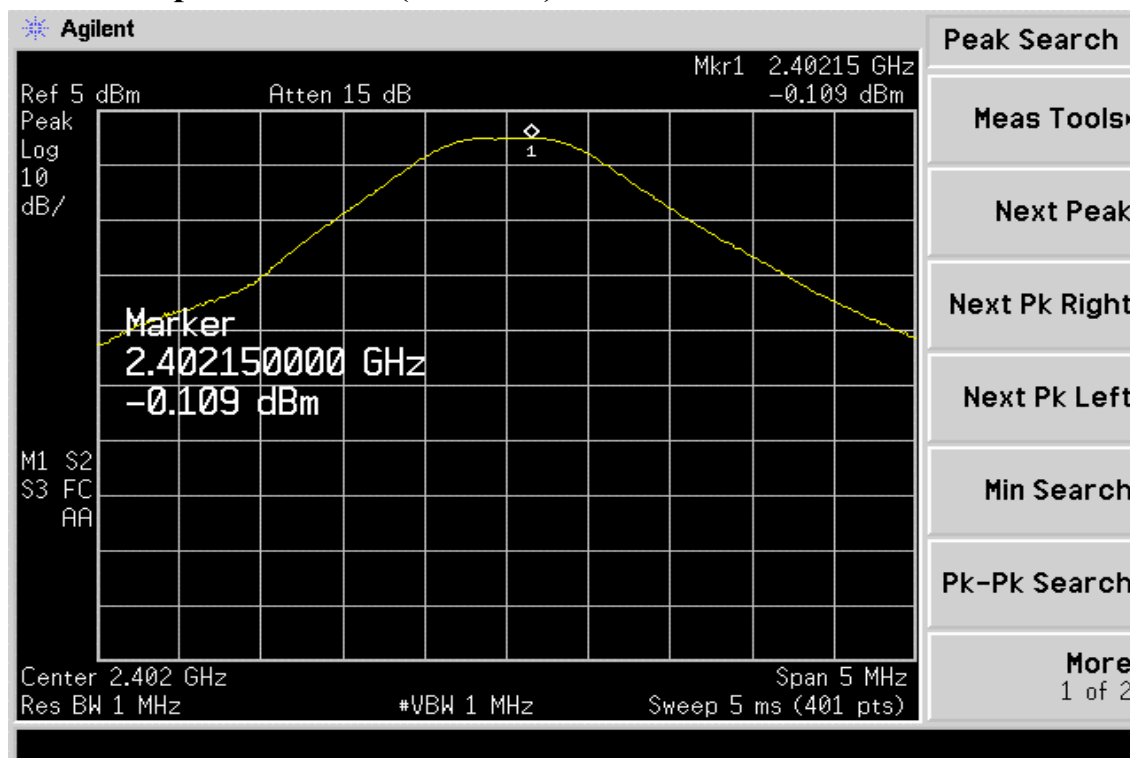

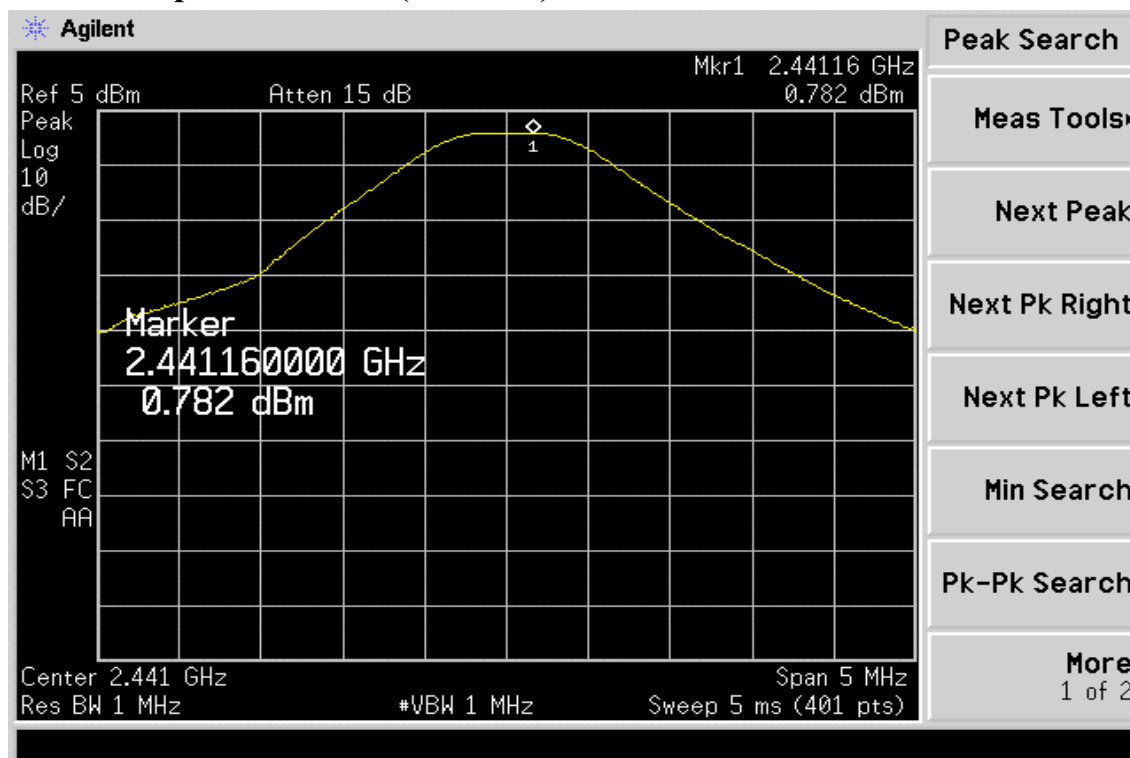

## Peak Power Output Data Plot (CH Low)

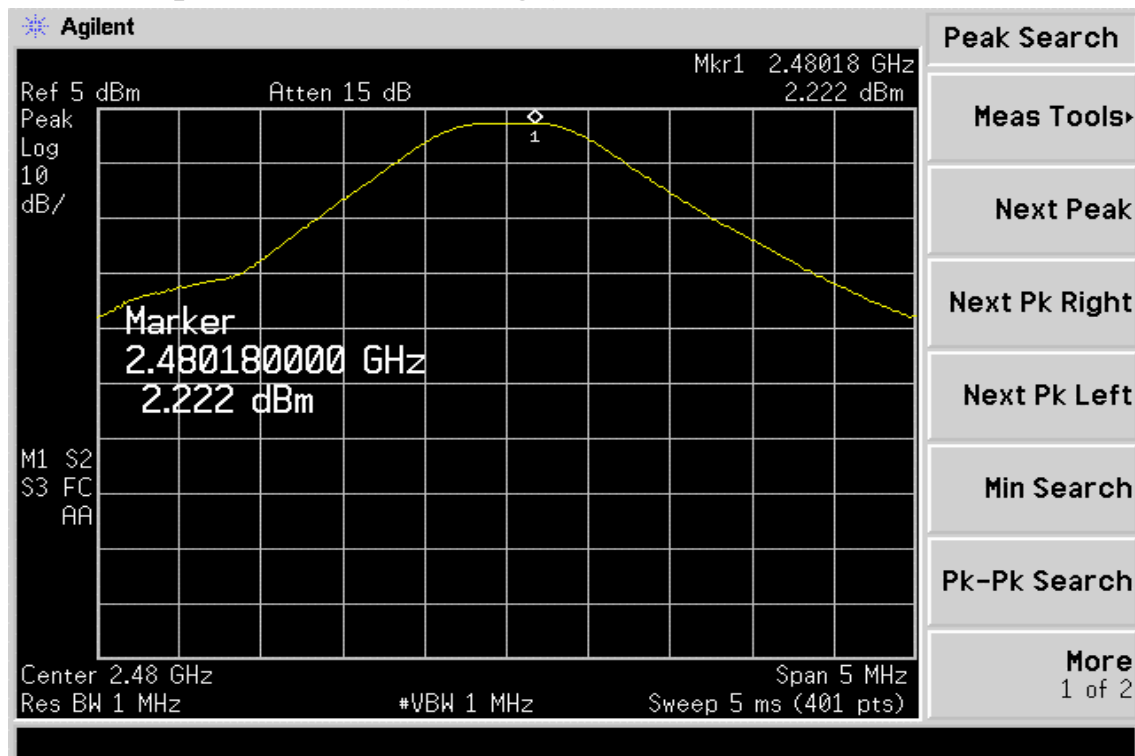


## Peak Power Output Data Plot (CH Mid)

## 7. 20dB BAND WIDTH

### 7.1 Standard Applicable

According to §15.247(a)(1)(ii), Frequency hopping systems operating in the 2400MHz-2483.5 MHz and 5725MHz – 5850MHz bands. The Maximum 20dB bandwidth of the hopping channel is 1MHz.

### 7.2 Measurement Procedure

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set the spectrum analyzer as RBW=10KHz (1 % of Bandwidth.), Span= 2MHz, Sweep=auto
4. Mark the peak frequency and –20dB (upper and lower) frequency.
5. Repeat above procedures until all frequency measured were complete.

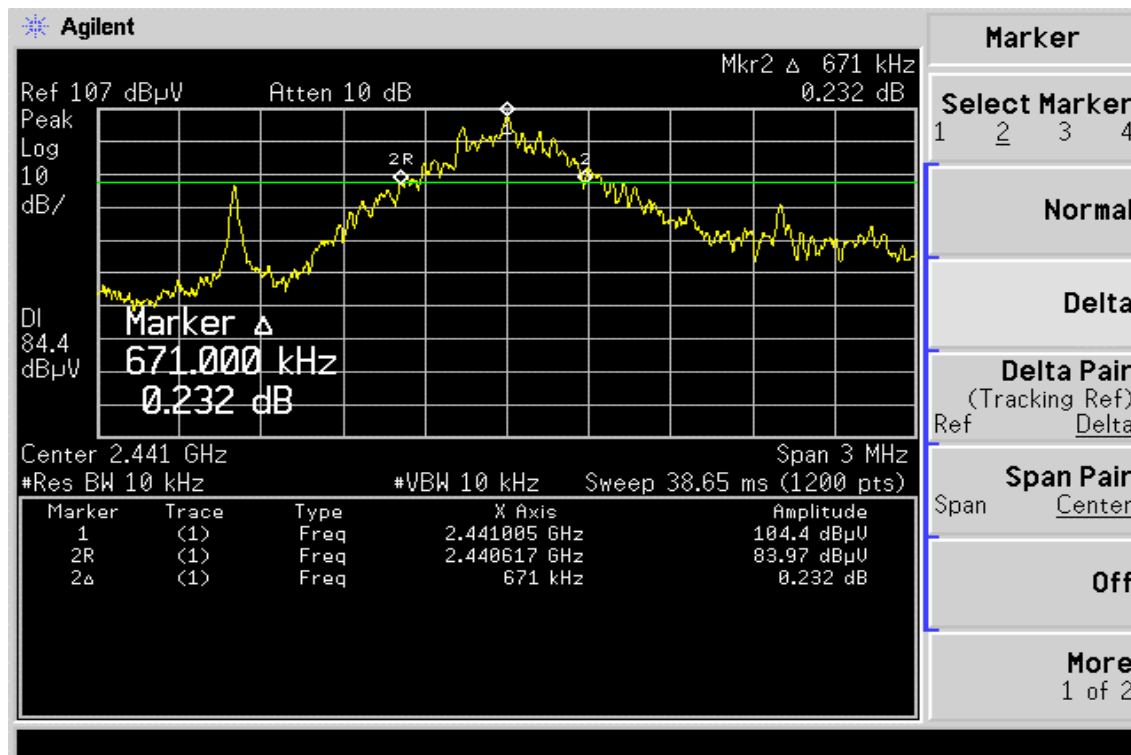

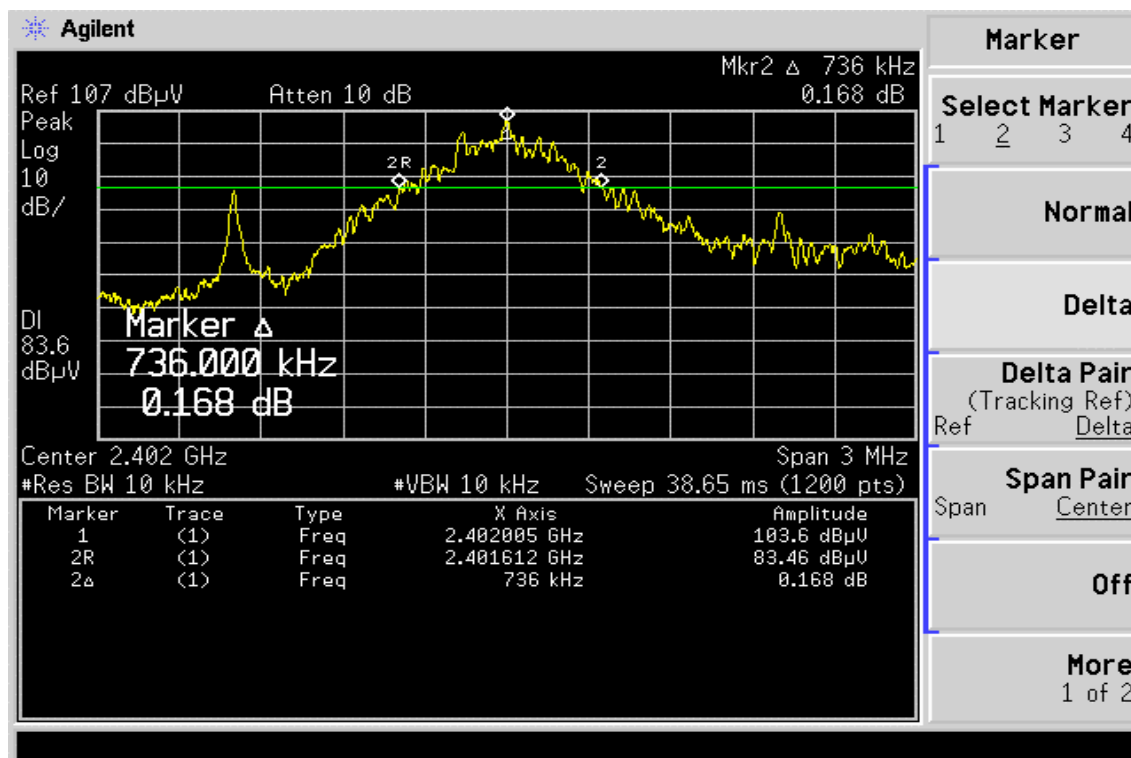

## 20dB Band Width Test Data CH-Low

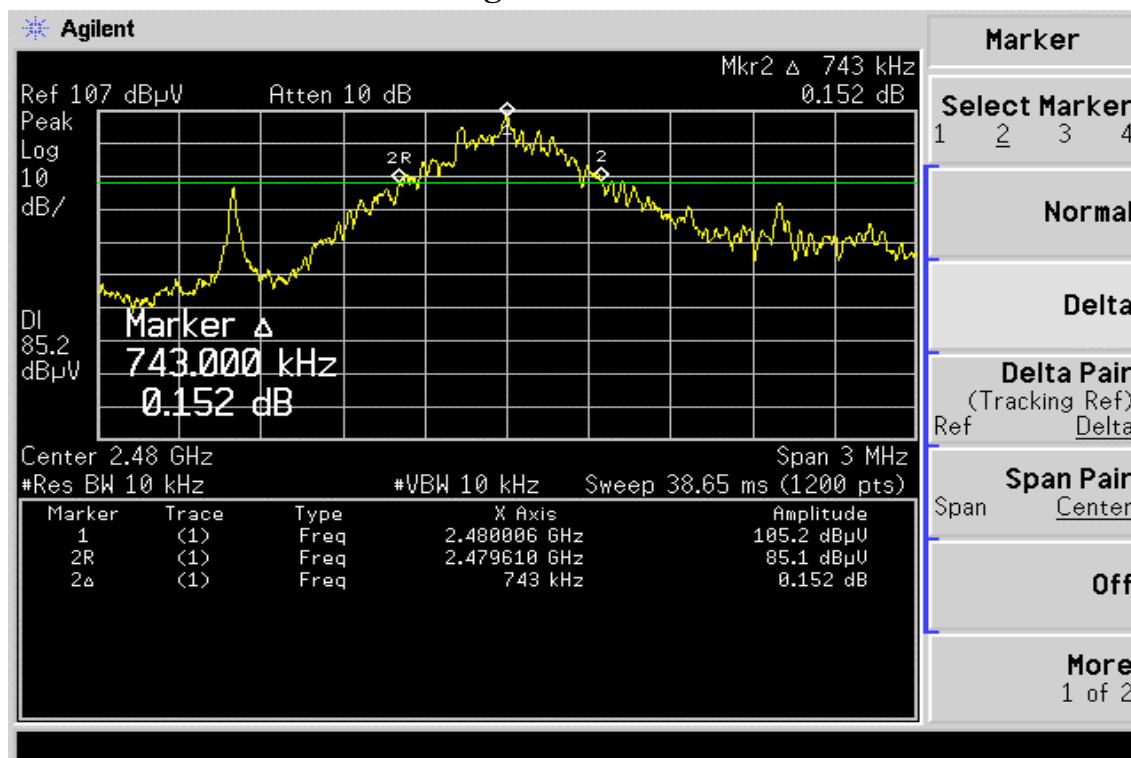


## 20dB Band Width Test Data CH-Mid

## 8. 100KHz BANDWIDTH OF BAND EDGES MEASUREMENT

### 8.1 Standard Applicable

According to §15.247(c), in any 100 KHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100KHz bandwidth within the band that contains the highest level of the desired power. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a).

### 8.2 Measurement Procedure

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set center frequency of spectrum analyzer = operating frequency.
4. Set the spectrum analyzer as RBW, VBW=100KHz, Span=25MHz, Sweep = auto
5. Mark Peak, 2.390GHz and 2.488GHz and record the max. level.
6. Repeat above procedures until all frequency measured were complete.
7. Radiated Emission refer to section 9.

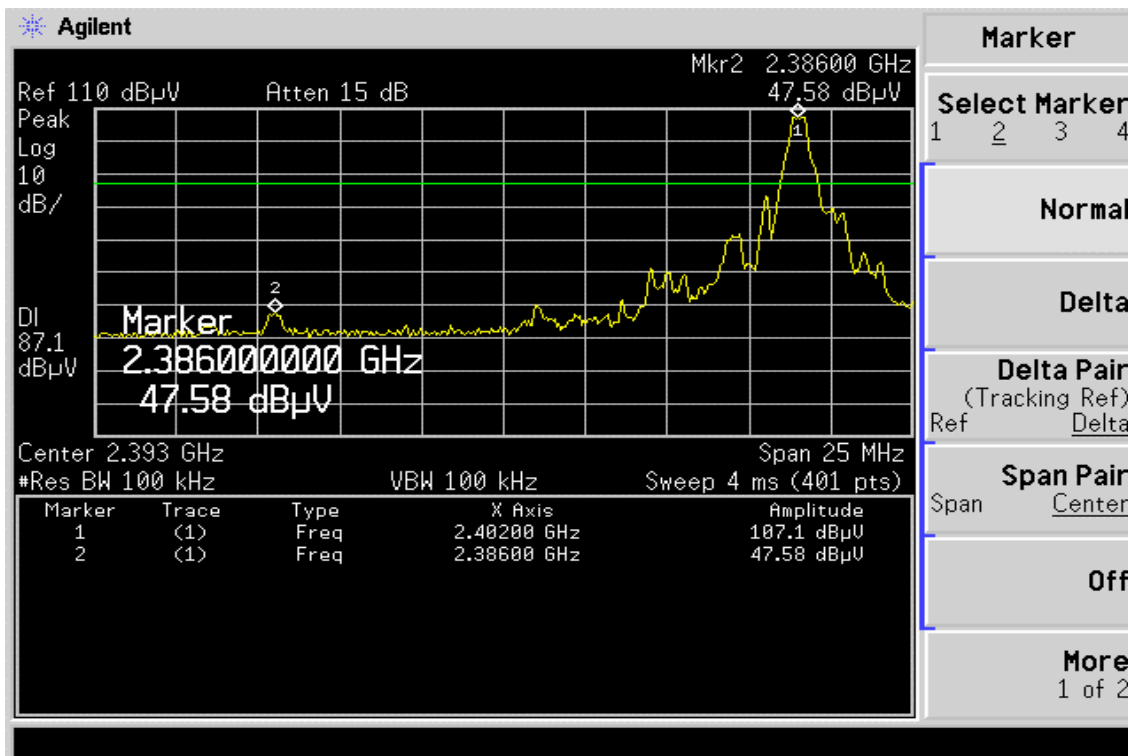

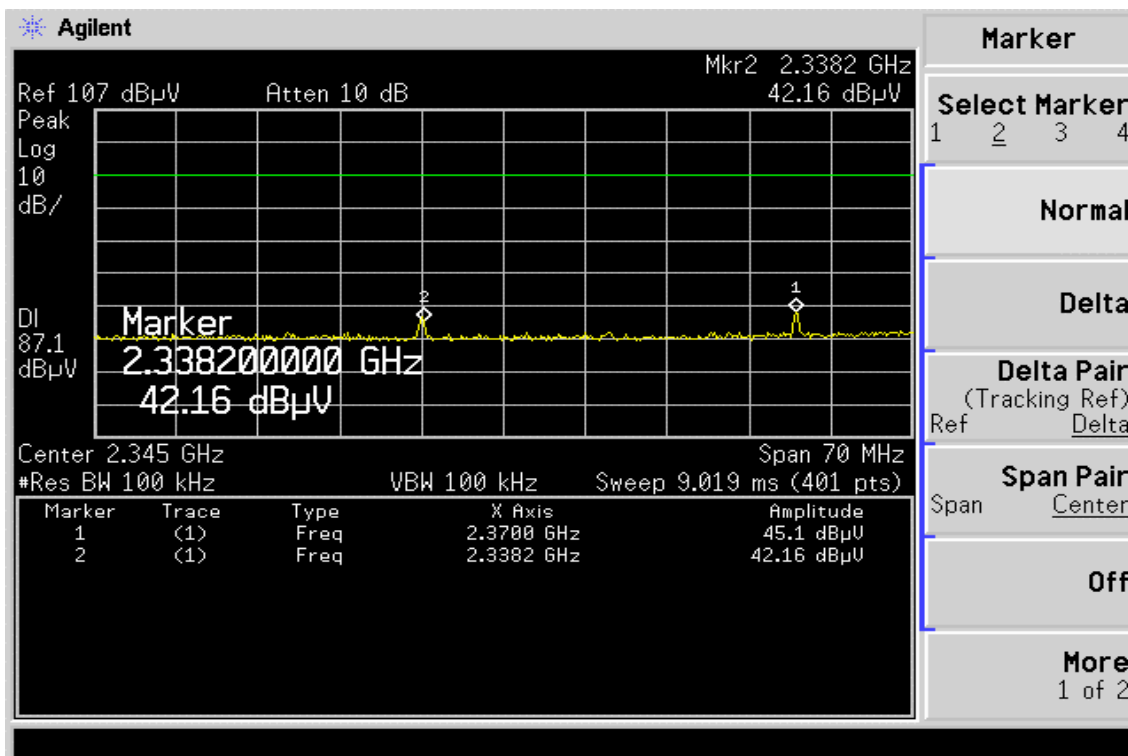

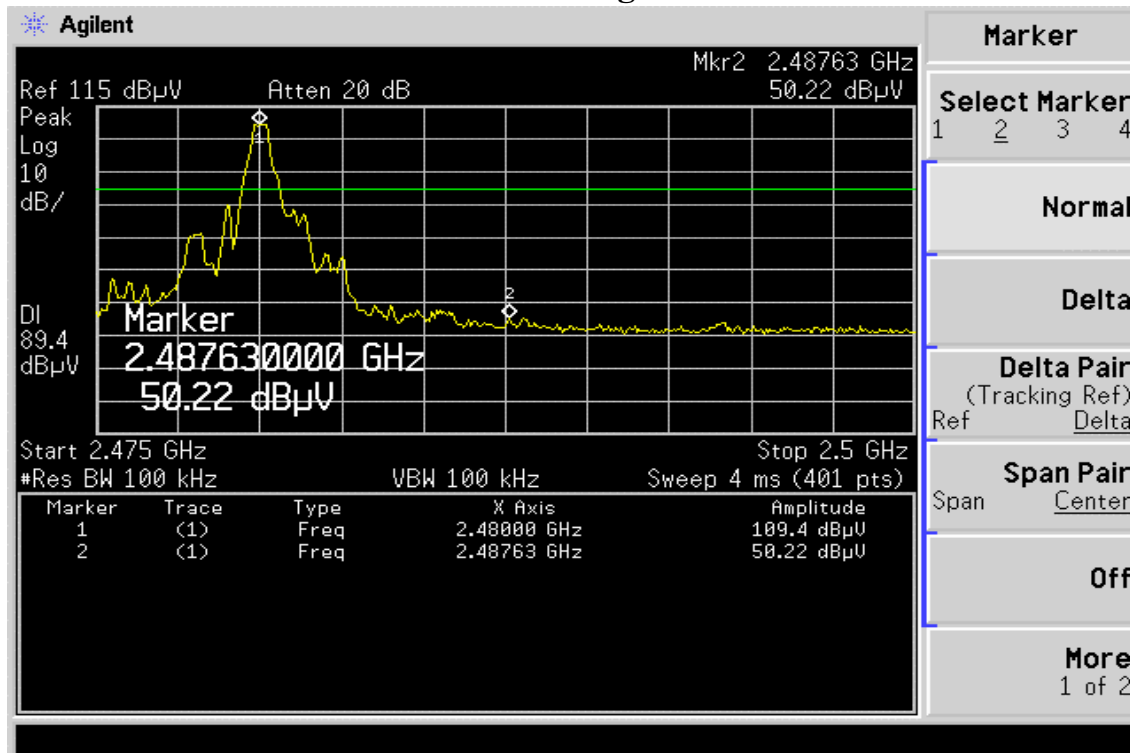
## Conducted Emission: Test Data CH-Low

## 9. SPURIOUS RADIATED EMISSION TEST

And according to §15.33(a)(1), for an intentional radiator operates below 10GHz, the frequency range of measurements: to the tenth harmonic of the highest fundamental frequency or to 40GHz, whichever is lower.

1. The radiated emission tests were performed in the 3 meter open-test site, using the setup in accordance with the ANSI C63.4-1992.

3. The PC system was connected with 110Vac/60Hz power source.

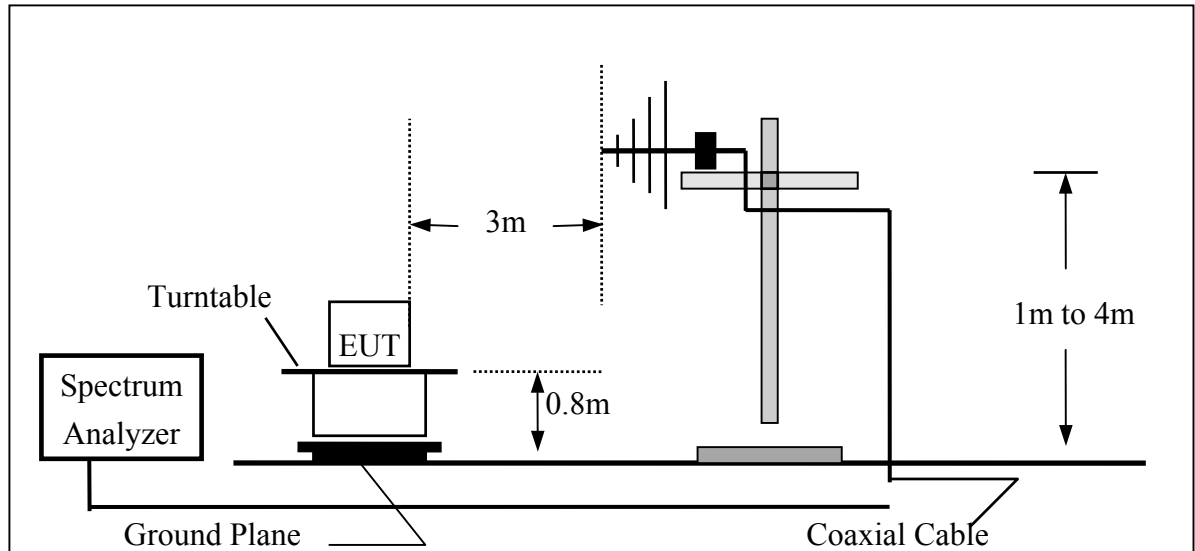

3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Repeat above procedures until all frequency measured were complete.

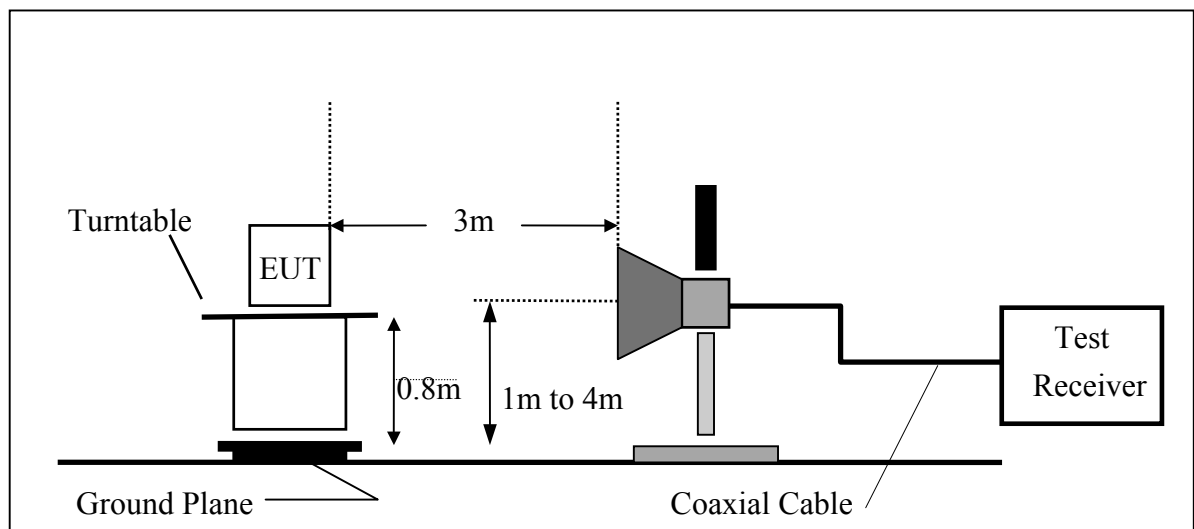


## 9.4 Test SET-UP (Block Diagram of Configuration)

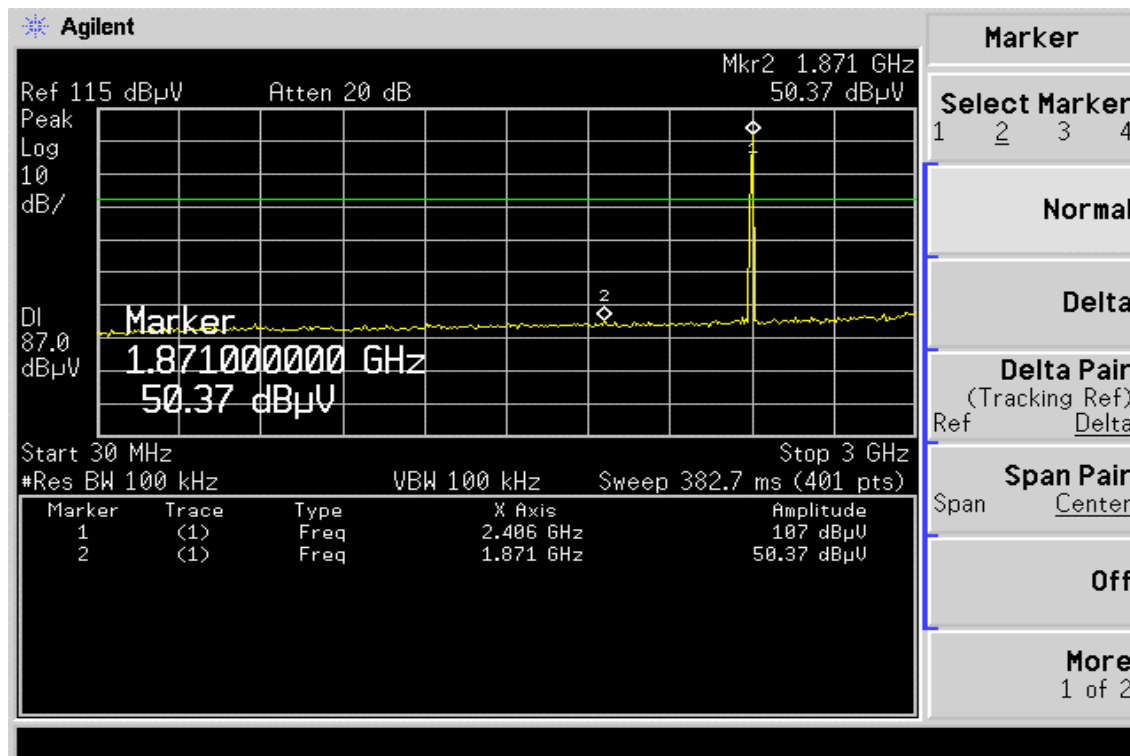

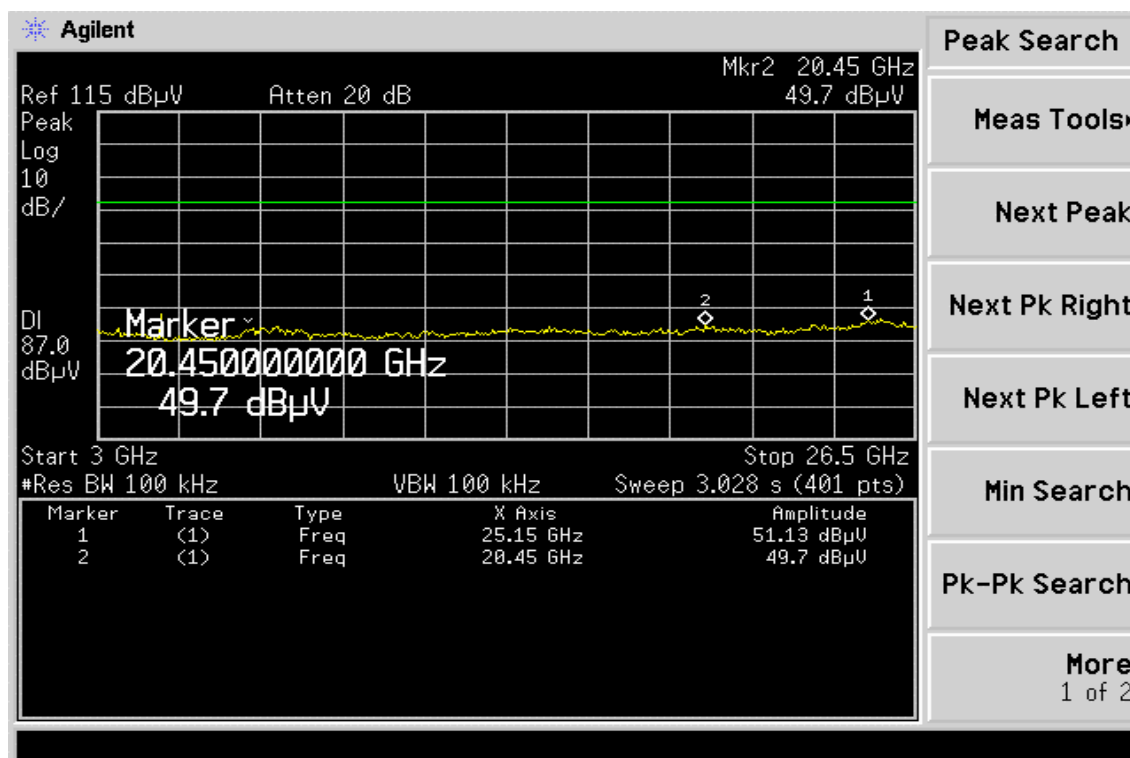

## Conducted Spurious Emission Measurement Result Ch Low 30MHz – 3GHz

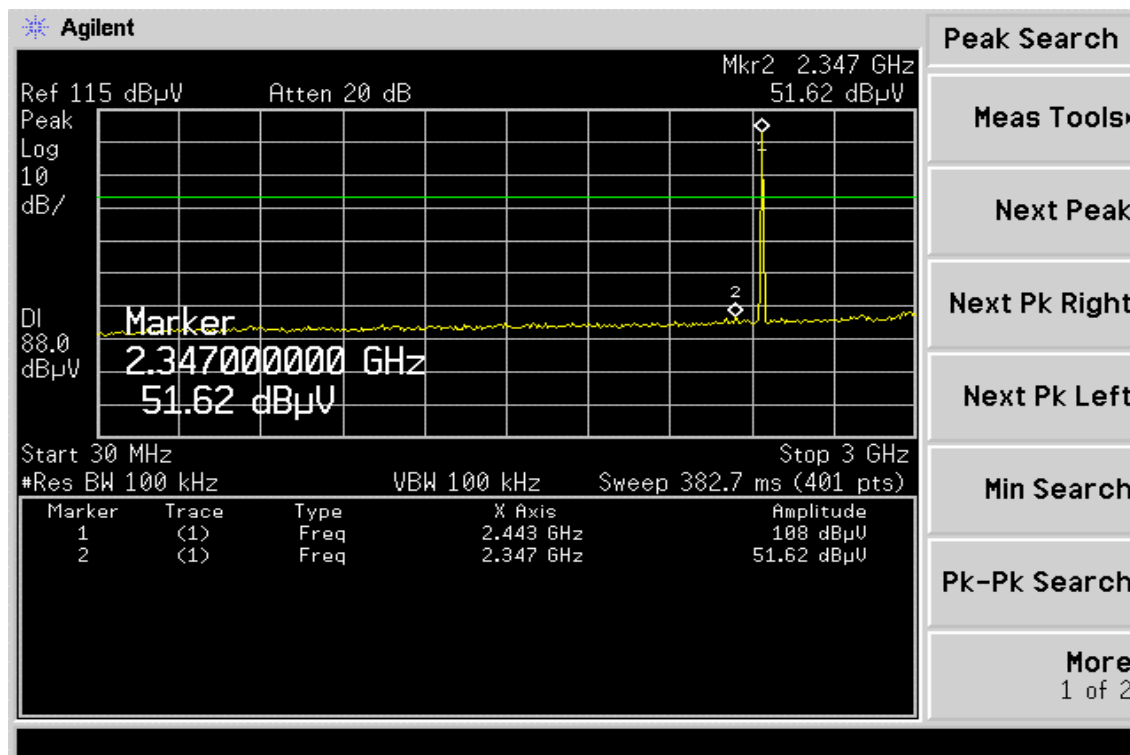


## Ch Low 3G Hz – 26.5GHz

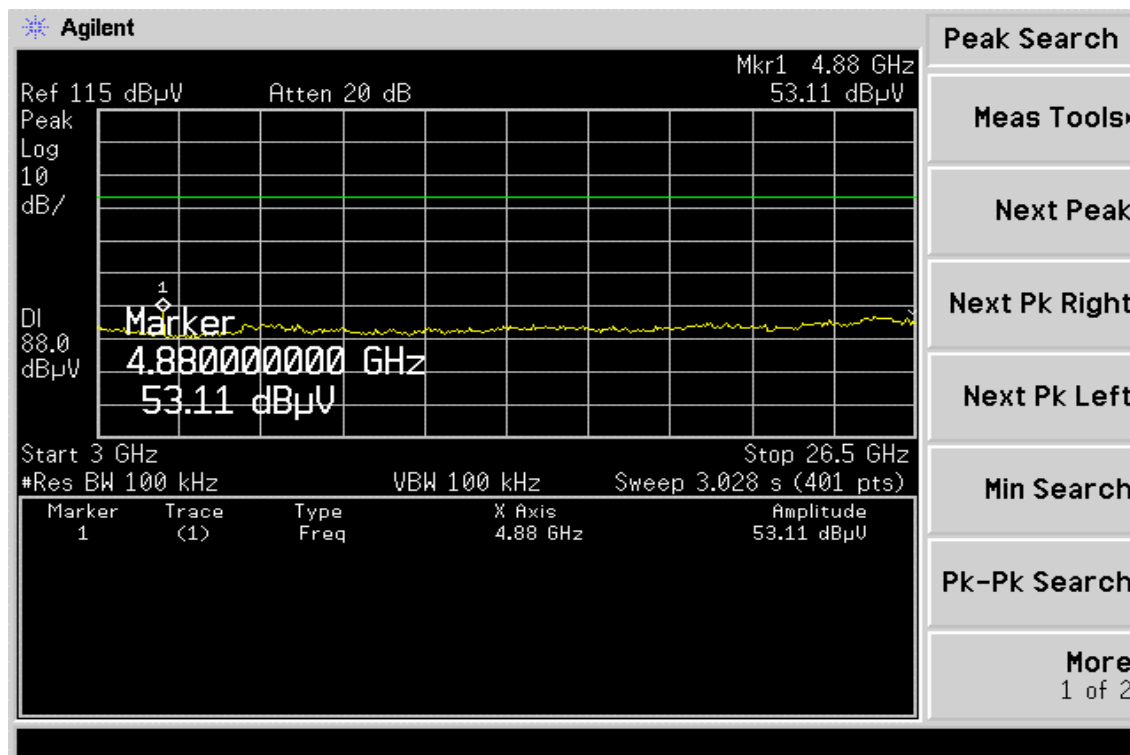

## Ch Mid 30MHz – 3GHz

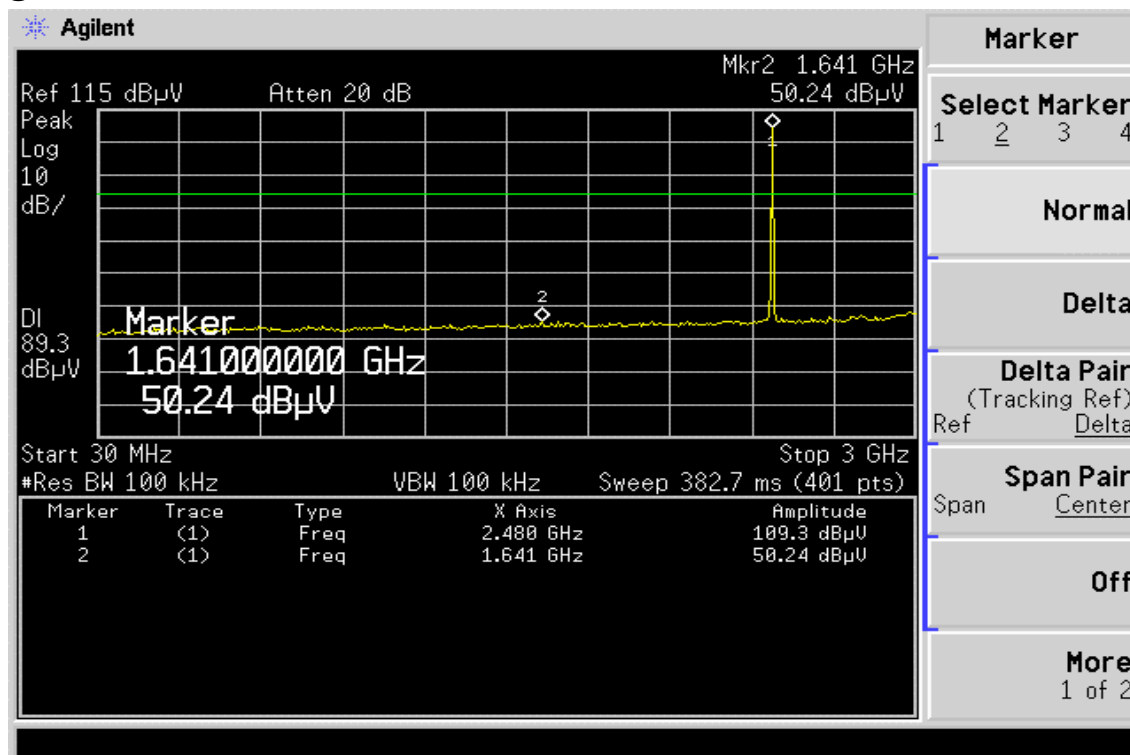


## Ch Mid 3G Hz – 26.5GHz

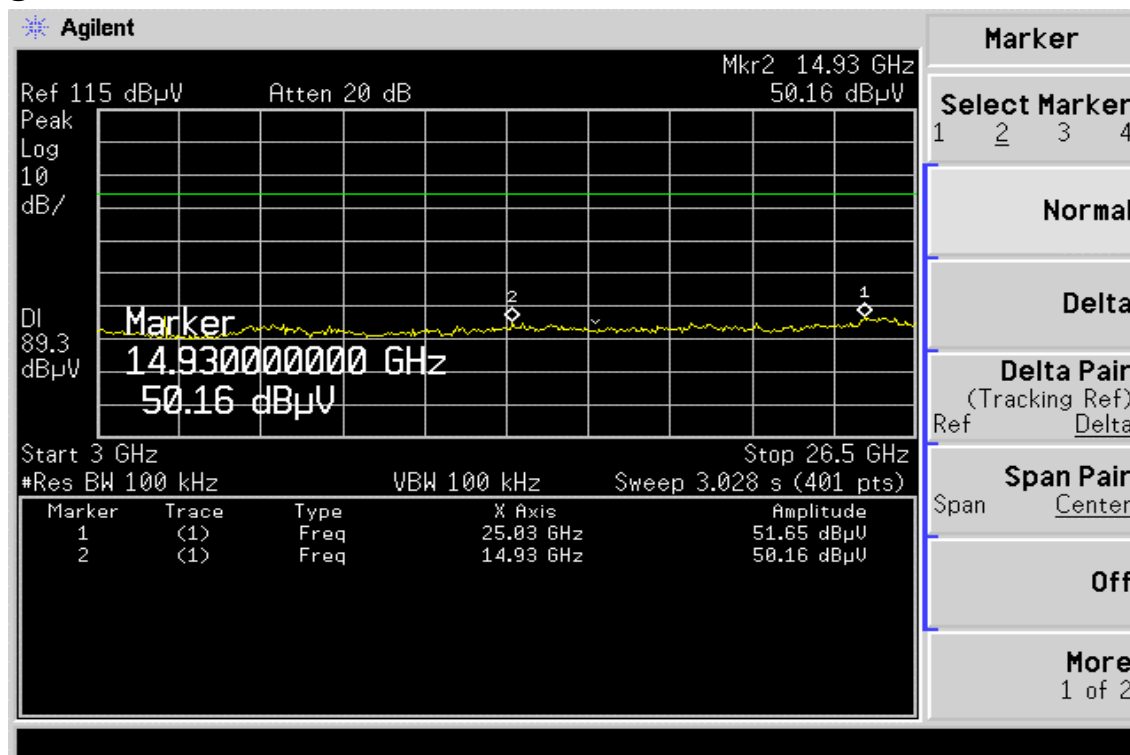

## 12. TIME OF OCCUPANCY (DWELL TIME)

### 12.1 Standard Applicable

According to §15.247(a)(1)(ii), Frequency hopping systems operating in the 2400MHz-2483.5 MHz and 5725MHz – 5850MHz bands. The average time of occupancy on any frequency shall not greater than 0.4 s within a 30s period.

### 12.2 Measurement Procedure

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set center frequency of spectrum analyzer = operating frequency.
4. Set the spectrum analyzer as RBW,VBW=100KHz, Span = 0Hz , Adjust Sweep = 30s.
5. Repeat above procedures until all frequency measured were complete.

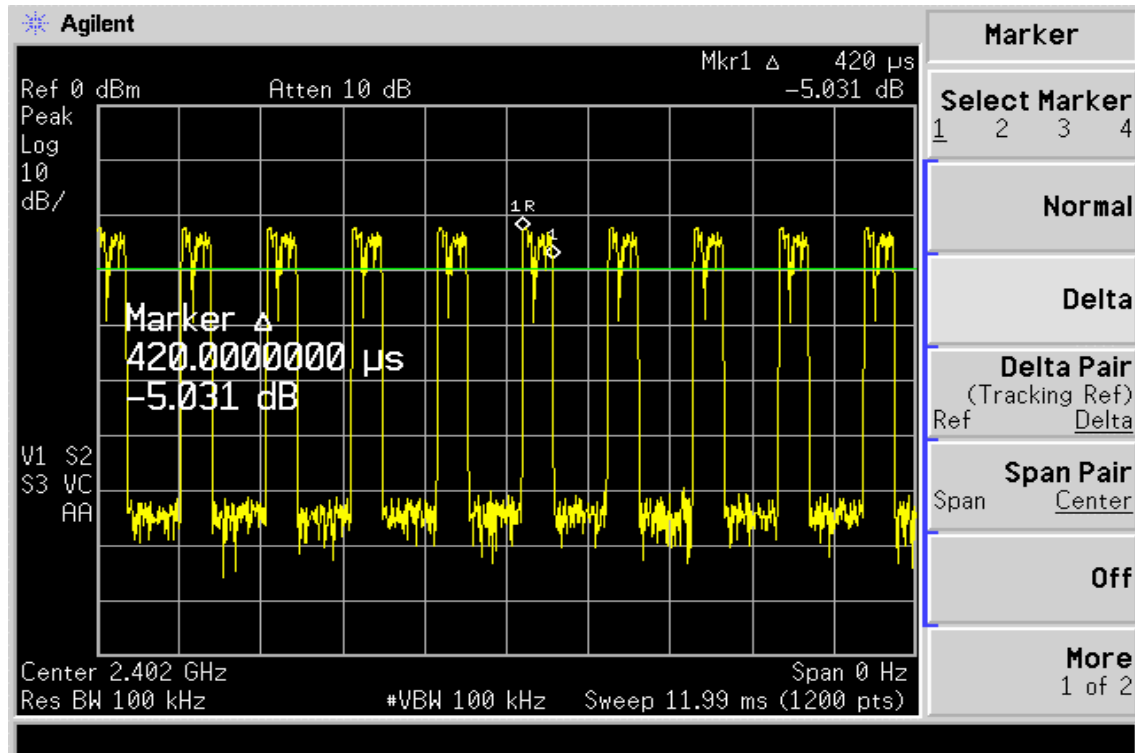

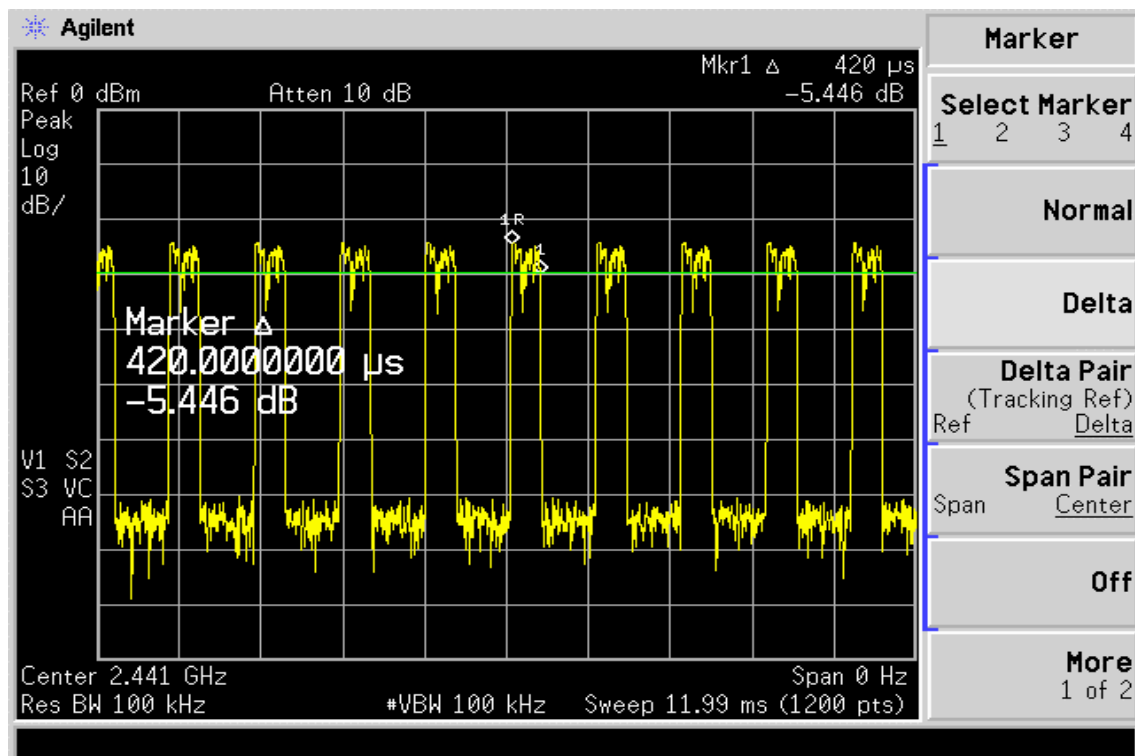

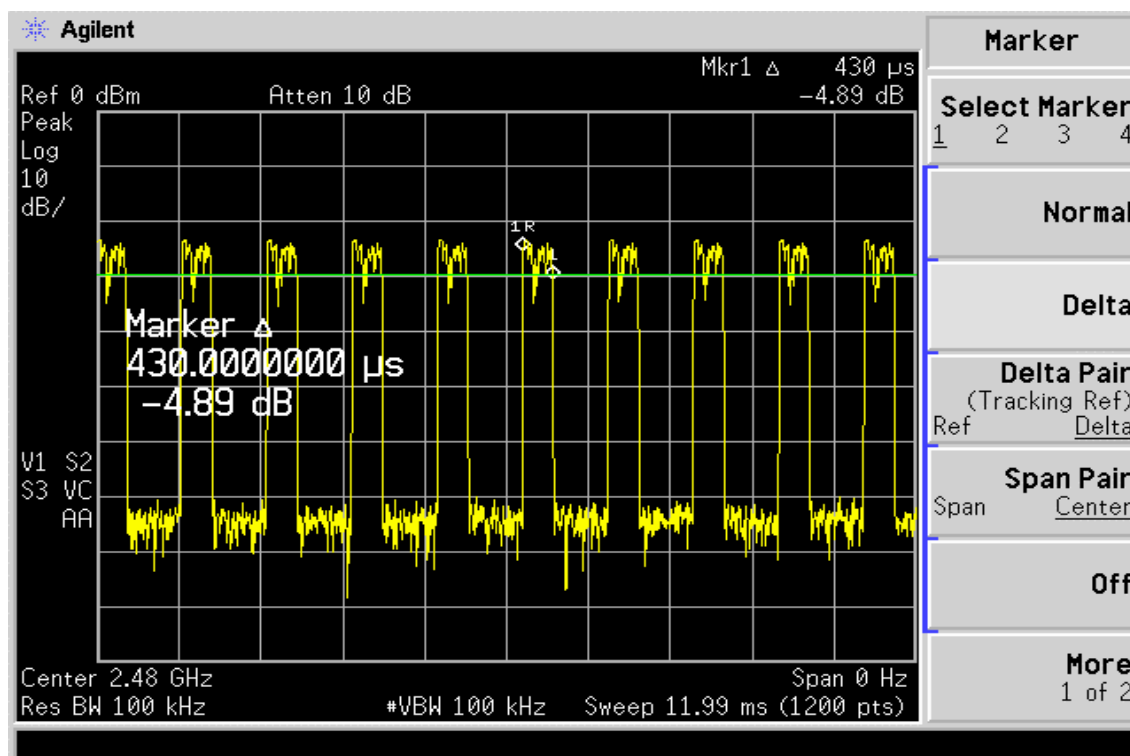

### 13. Peak Power Spectral Density

#### 13.2 Measurement Procedure

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set the spectrum analyzer as RBW = 3KHz, VBW = 8KHz, Span = 300KHz, Sweep=100s
4. Record the max. reading.
5. Repeat above procedures until all frequency measured were complete.

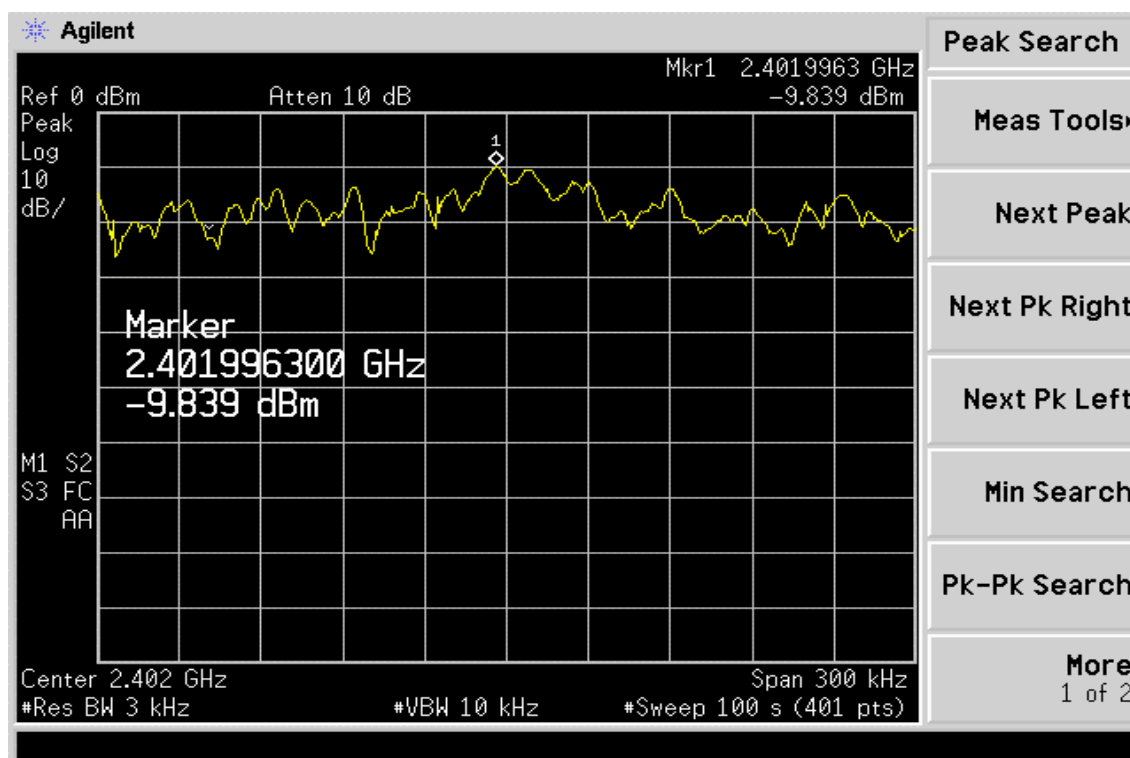

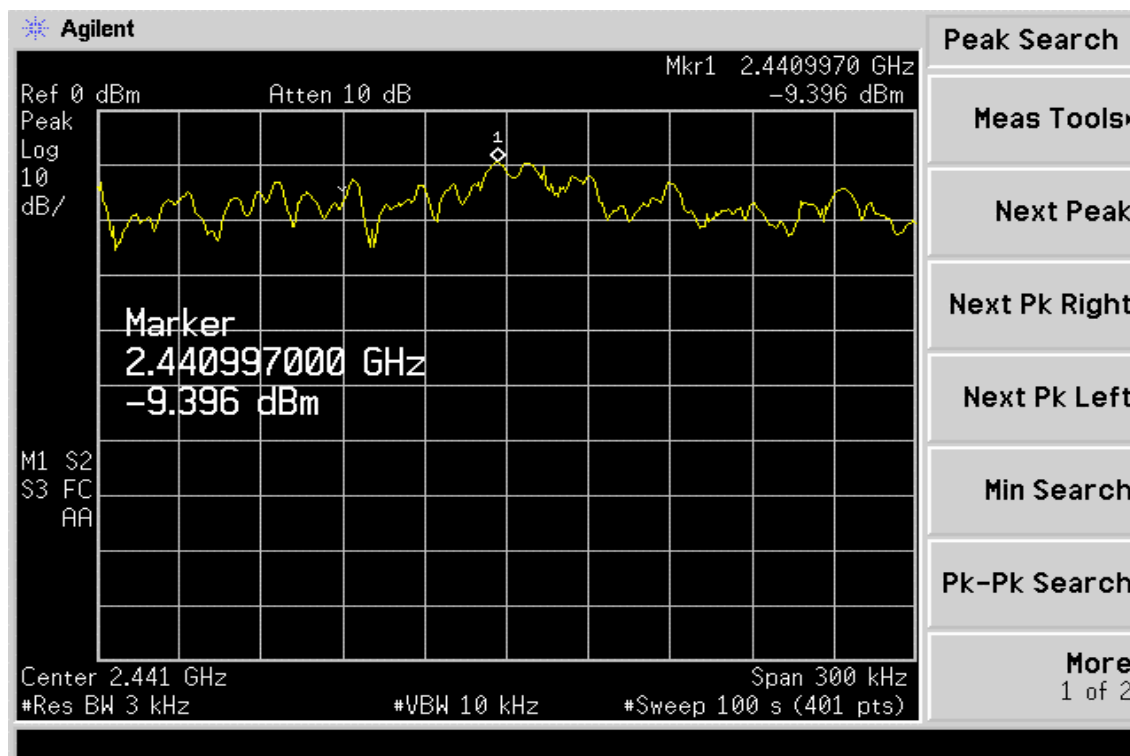

## Power Spectral Density Test Plot (CH-Low)



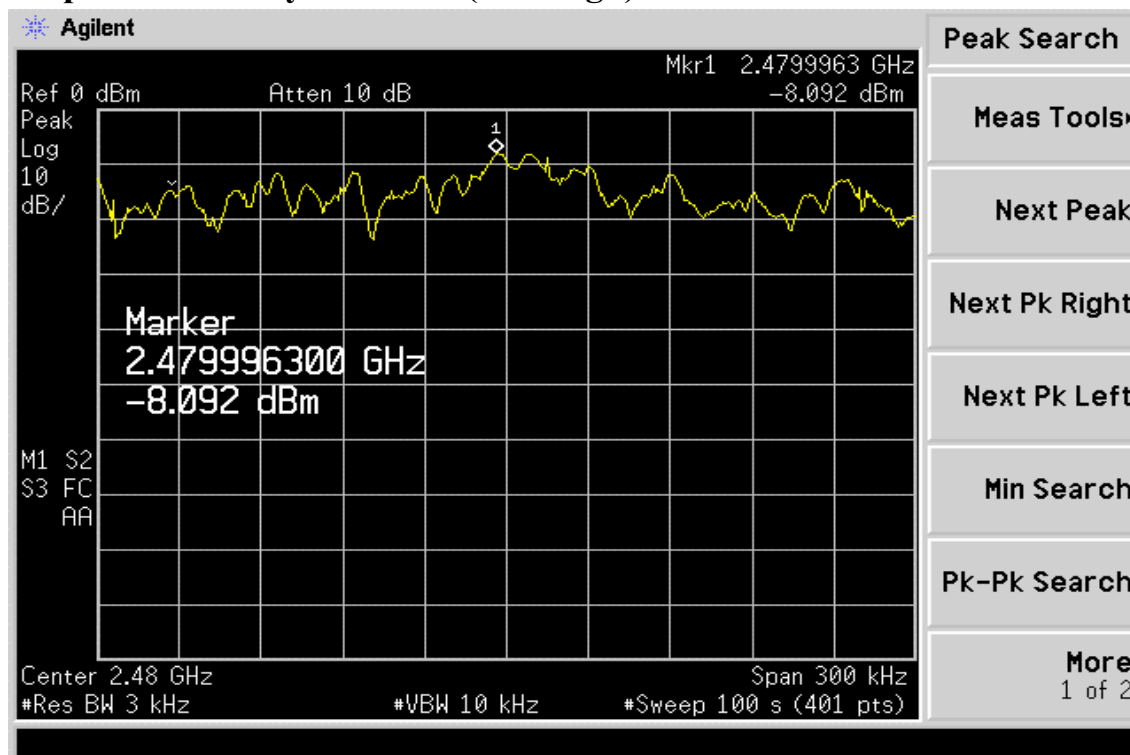
## Power Spectral Density Test Plot (CH-Mid)
