


USB 2.0 Mobile Storage Device

4. Device Driver installation

- Win 98/SE users should setup Device Driver. Run install.exe in the CD, then click Device Driver Setup icon.
- Win 2K/XP don't require a device driver.
- Mac OS, Linux users should read a manual in the CD.

5. Application Program Setup

(Programs for MS Window OS)

- Run install.exe in the CD. Then click Application Program Setup icon.
- Read User Guide for program operation. (Start -> Program -> USB Flash Disk -> Application)
- Application program:
Disk partition, Format, E-mail.

6. Warning

When you want to remove the USB Mobile Storage Device, please make sure the LED stop flashing. If the LED still flashes, the read/write operation is still going on between OS and USB Mobile Storage Device. Please do not remove the USB Mobile Storage Device at this time. Otherwise, it will cause some damages of the data or files even USB Mobile Storage Device.
