Qustion #1: Filing does not appear to be in accordance with TCB guidance (Oct 2005 TCBC workshop notes) for modules in specific-host final-products:

BELOW HAS EXAMPLE AS LAPTOP, BUT APPLIES FOR ANY MODULE IN SPECIFIC HOST

General filing guidance for mini-PCI and similar modules, for example in notebook computer:

- Filings for specific laptop(s) need external and internal-as-installed antenna photos or drawings
- Final-product laptop approvals need laptop user manual describing wireless function, installation/operation, final-product operation, etc.
- C2pc filings to add final-product (host) should include final device FCC ID labeling info, including labels for other modules if applicable

Please provide external photos of the host printer HC5500, internal photos to show antenna location when the module is installed inside the printer, user manual of the host printer, host printer FCC ID labeling info.

<answer>Attached pls find host photo, antenna/module location photos, host manual and host label.

Endusers or Service person can not access this RF Module, therefore, host manual does not describe wireless function.

Question #2: The limits listed on the test report page 29 of 38 are incorrect. For fundamental 13.56MHz, the limit at 30m should be 15,848 uV/m (84 dBuV/m), and for harmonic 27.12MHz, the limit at 30m should be 30uV/m (29.5 dBuV/m). Please update the report.
