


1. 제품 소개 Introduction

3. Warranty

BKM warrants this products as free of defects in material, design and workmanship for a period of twelve (12) months from the original date of purchase.

CAUTION

This Limited Warranty will be honored only within the geographical location that IPOP purchased. BKM will repair or replace I-POP if they fail to function properly during the warranty period, subject to any conditions and/or limitations stated herein. Such repair service will include all labor as well as any necessary adjustments and/or replacement parts. Such repair or replacement is the sole remedy under this warranty.

Warranty Conditions :

- Request for Warranty Service will not be accepted without proof of date of purchase, such as a copy of the original dated IPOP sales receipt.
- This Warranty does not apply to the battery used in I-POP. This Warranty does not cover circumstances beyond BKM's control, nor problems caused by failure to follow the operating instructions in the I-POP User's Guides.
- This Warranty does not apply when failure is due to shipping damage, accident, alteration, modification, unauthorized service, misuse, abuse, use with incompatible accessories or attachments, failure to follow BKM's operation, maintenance or repacking instructions, failure to use items supplied by BKM (Such as adapters and cables), or claims made after the duration of this Warranty.
- This Warranty does not apply when repairs performed by non-authorized service centers such as opening of the product by a non-authorized person.

4. FCC Statement

This device complies with parts 15 of the FCC Rules. Operation is subject to the following two conditions; (1)This device may not cause harmful interference, and (2)this device must accept any interference received, including interference that may cause undesired operation.
