6 Test Results

6.1 E.U.T. test conditions

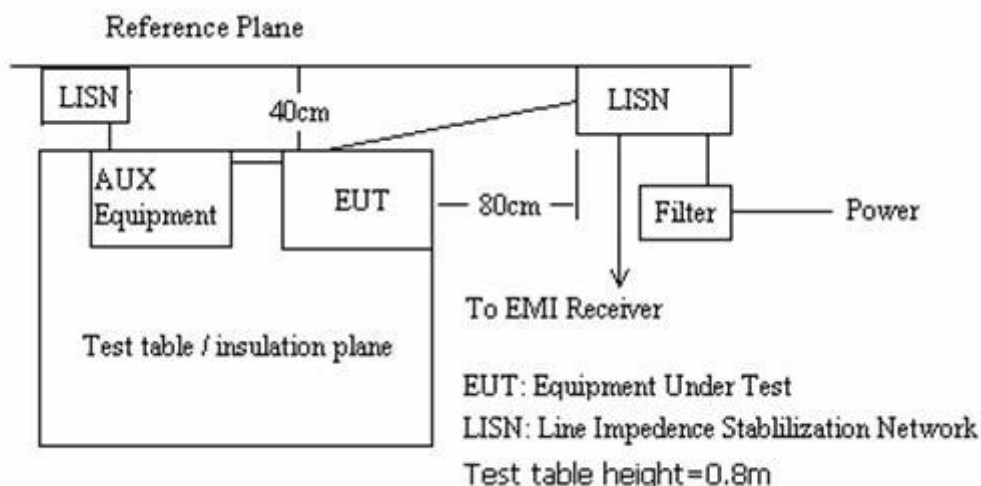

Plan View of Test Setup

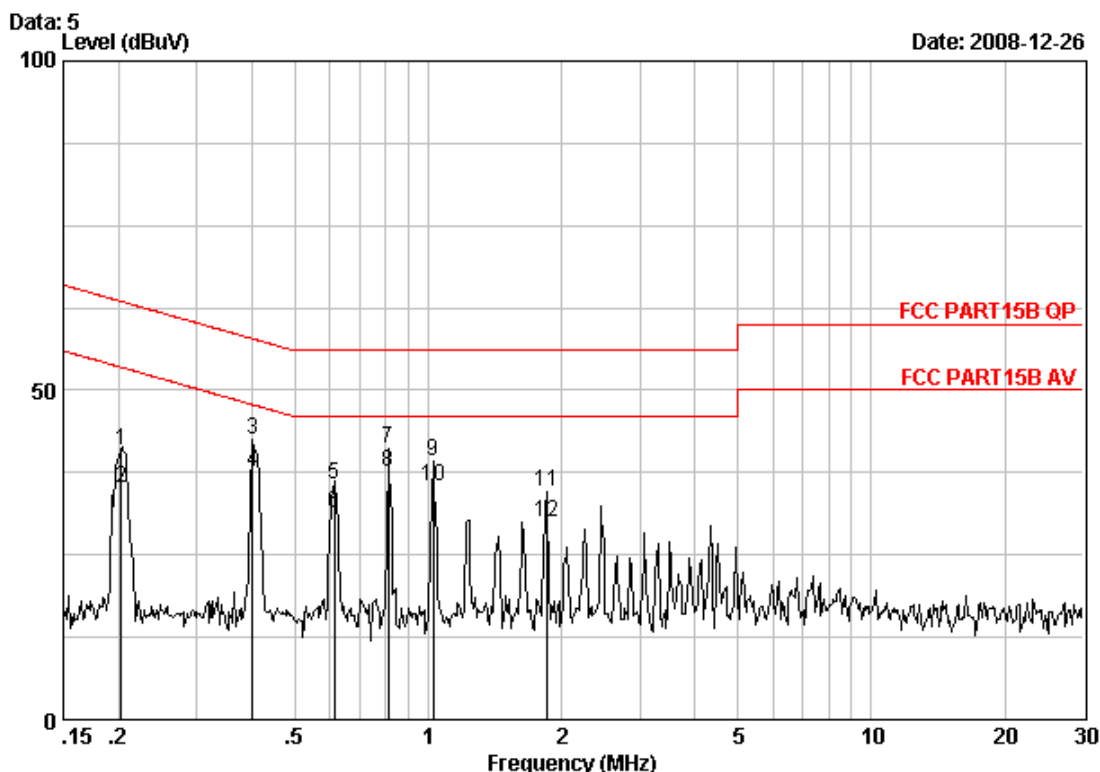

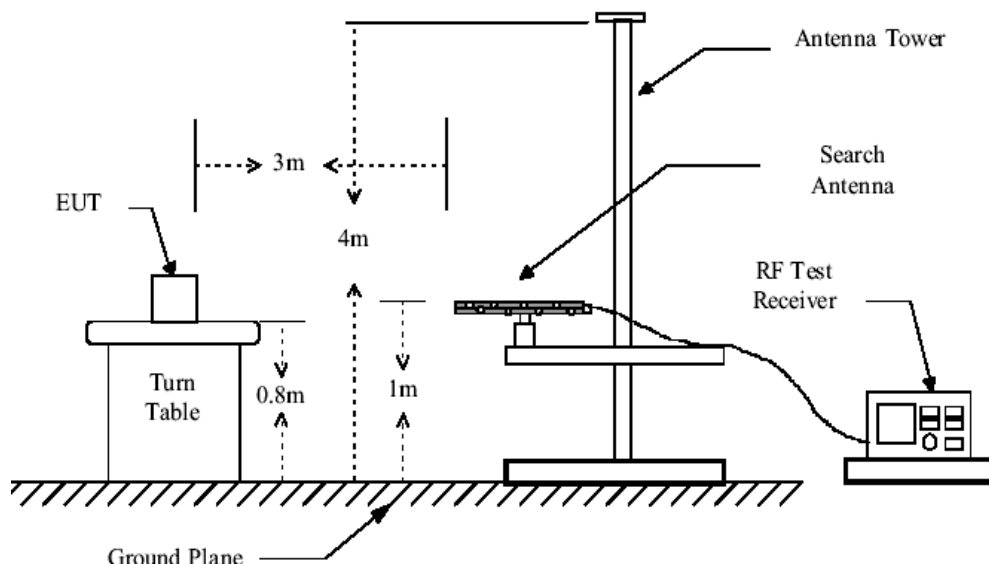


Figure 1. 30MHz to 1GHz radiated emissions test configuration

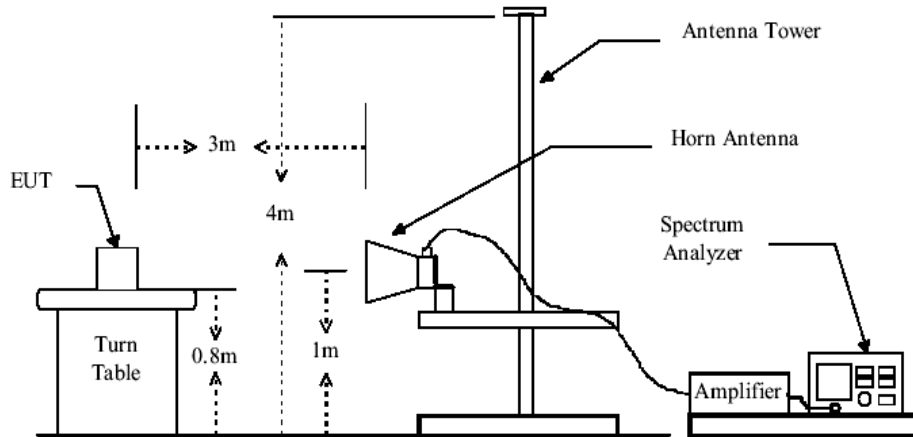


Figure 2. Above 1GHz radiated emissions test configuration
