Hello Mark:

Will address each issue as follows:

- 1/ Apparently we could have 2 grantee codes for Bobco Technology as Kidder Industrial is part of Bobco Technology. Otherwise, if still OK at this point then just go ahead and use RSO and change all model FCC ID etc. accordingly, i.e. RSO-8939 instead of LP5-8939. Industry Canada number would reference (and accept approval) for device issued to FCC Grant RSO instead of LP5, right?
- 2/ Letter of Confidentiality. Both the authorization and confidentiality letters were signed and in the .zip file bobcoltr.zip that we e-mailed last week to Jason. Anyway, Raymond will refax again to you shortly
- 3/ We have not encountered this request before. Can you e-mail us a generic Declaration of Continued Compliance letter that we can customize for our purpose and then we will sign it and fax right back to you?
- 4/ Attached please find a new document showing this label number and location on the outside of the device as well as inside battery compartment.

Thank you for the update, please make sure that Industry Canada application will not be adversely affected or delayed by any of the above grantee changes. If so we need to talk to you immediately or go with changing LP5 grantee to Bobco Technology as well, if we can have 2 grantee codes for the same company. Grantee RSO seems the easiest and fastest as you indicated its already correct address, etc.

> to the FCC TCB submittal for your product. I have included a list of issues
> that need to be addressed, as soon as possible. They are as follows:

> 1. The change of grantee information is confusing. The company name,
> Bobco
> Technology, is associated with grantee code RSO, while Kidder Industrial,
> Ltd. is associated with grantee code LP5. Please clarify.
>
> 2. While the Letter of Confidentiality is sufficient for maintaining
> confidentiality, the letter is not signed. Please provide a signed copy of the
> confidentiality request.
>
> 3. For change in FCC ID filings, a letter declaring continued
> compliance is
> required. Please submit a letter stating how the manufacturer intends to
> maintain continued compliance.
>
> 4. The photos of the exterior of the product do not clearly indicate
> the
> FCC ID label or location. If the FCC ID is embossed into the enclosure, it
> does
> not show up on the photos. Please clarify.
>
