1. External Photos: The photo of the back of the remote unit appears to show a small trap door to access the crystal. Part 95.645 b) requires that the crystal must not be accessible to the user. Please explain.

***- Yes, the EUT has a plug-in RF Modules. However, this plug-in action is only for manufacturer production, not for the end user. The end product shall have glue stick them. Moreover, the applicant provided the Confirmation Letter. In a word, it is impossible for end users to change the RF modules.***
