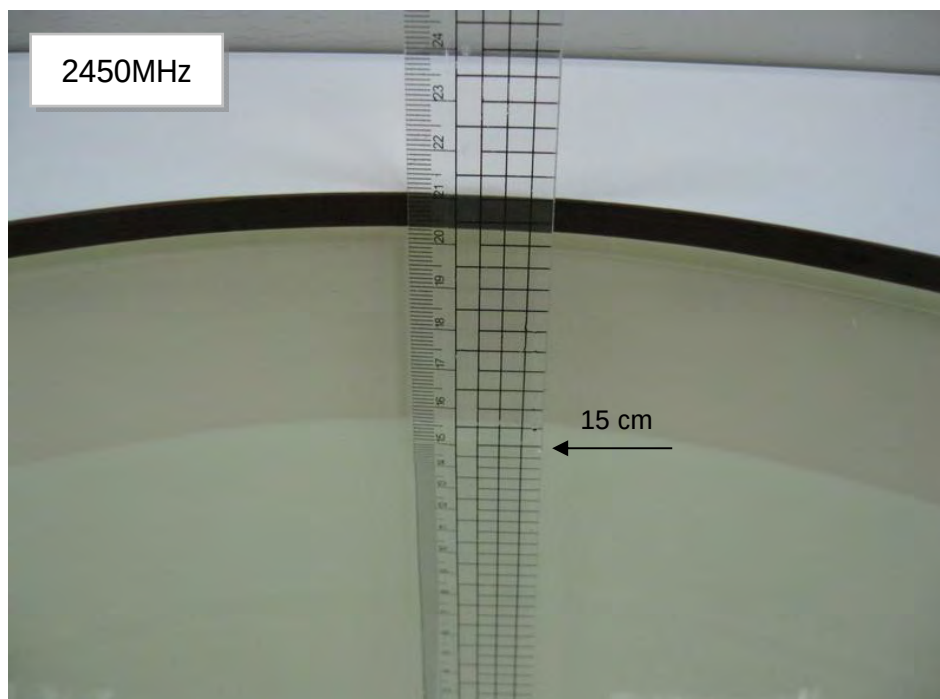

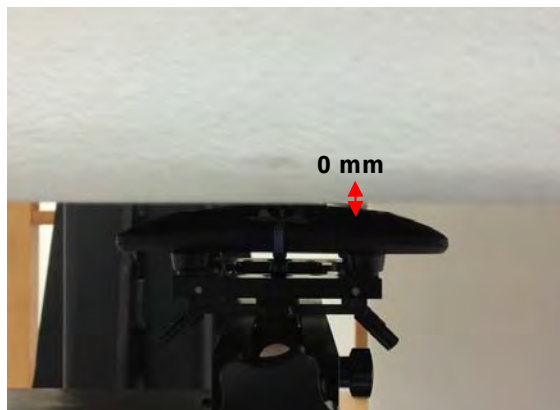


Fig.3 EUT Back side to flat phantom

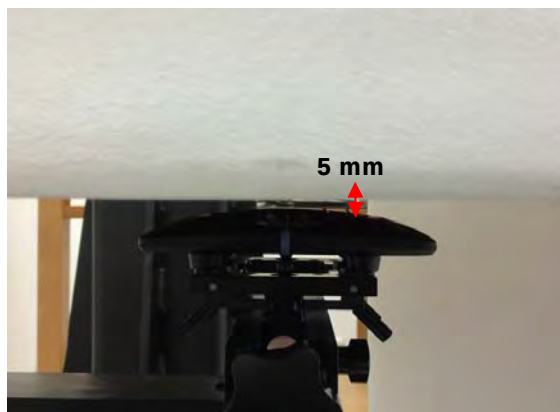


Fig.5 EUT Back side to flat phantom

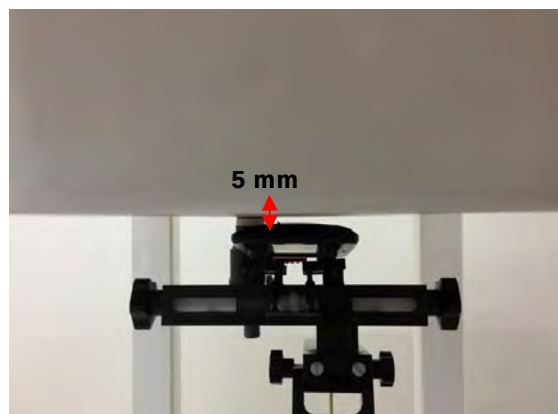


Fig.6 EUT Curve side to flat phantom

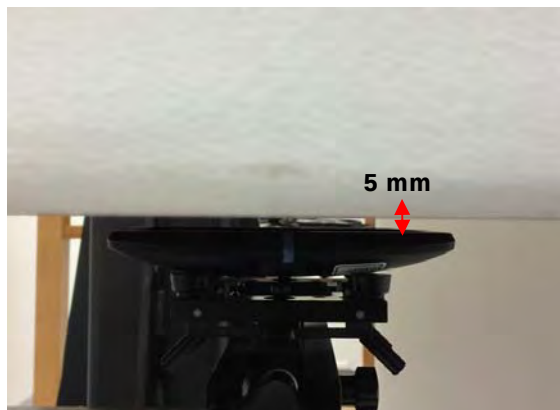
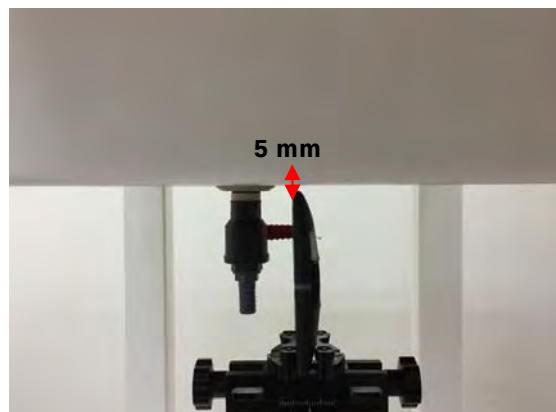


Fig.7 EUT Front side to flat phantom

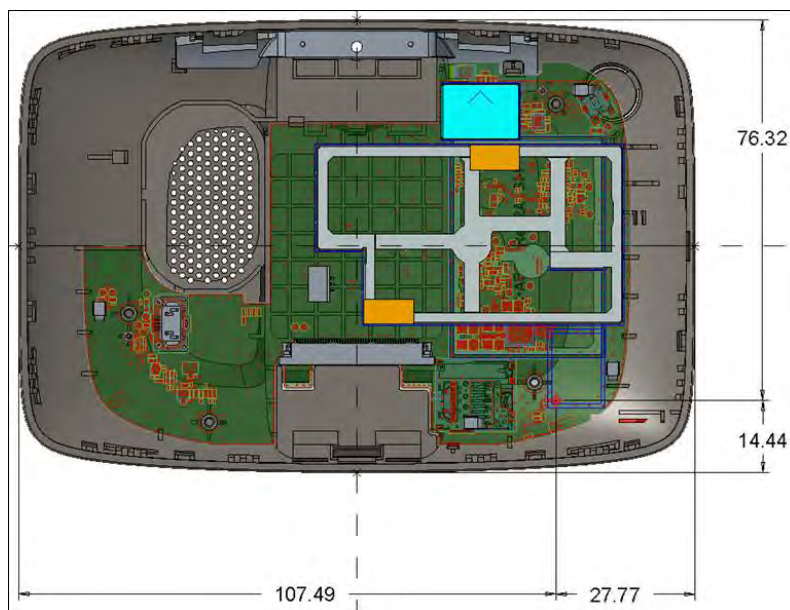


Fig.11 antenna location

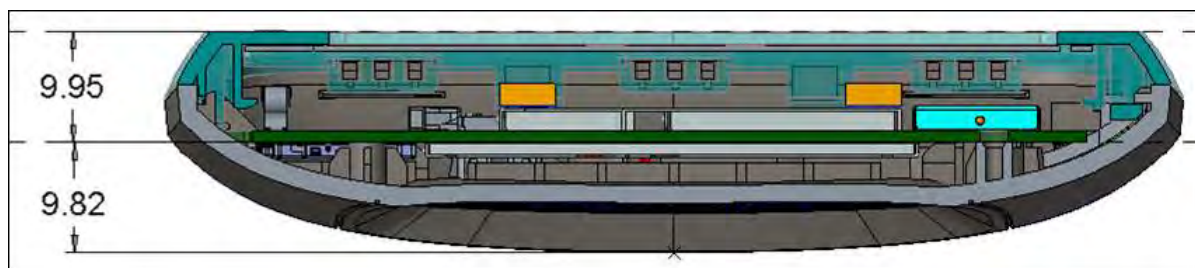


Fig.12 antenna location (edge view)
