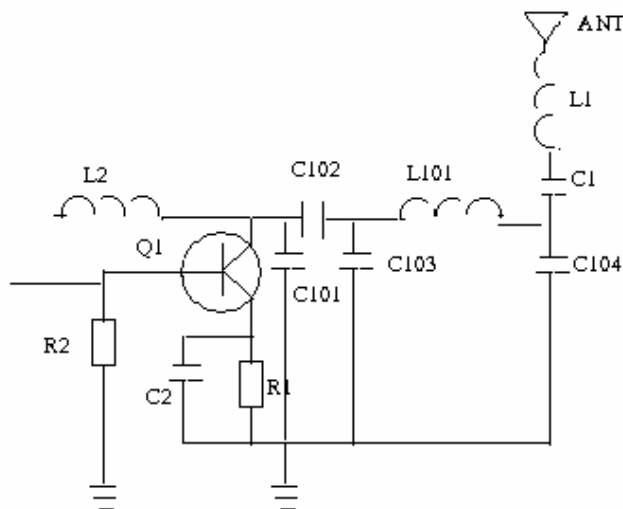

C1, C102: 200PF; C103, C104: 2PF

### 5.2 E.U.T. Operation

### 5.3 Test Procedure & Measurement Data

#### 5.3.1 Radiated Emissions

**Test Requirement:** FCC Part15 C

**Test Method:** FCC Part15 C Section 15.227

**Test Date:** 25 February 2005 (Initial Test);  
4 March 2005 (Test after modification)

**Measurement Distance:** 3m (Semi-Anechoic Chamber)

**Requirements:** Carrier frequency will not exceed 80dBuV/m AT 3m.  
Out of band emissions shall not exceed:  
40.0 dBμV/m between 30MHz & 88MHz  
43.5 dBμV/m between 88MHz & 216MHz  
46.0 dBμV/m between 216MHz & 960MHz  
54.0 dBμV/m above 960MHz

**Detector:** Peak Scan (120kHz resolution bandwidth)



Test Procedure: The procedure used was ANSI Standard C63.4-2003. The receiver was scanned from 30MHz to 1000MHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. The worst case emissions were reported.

An initial pre-scan was performed in the 3m chamber using the spectrum analyser in peak detection mode. The EUT was measured by Bilog antenna with 2 orthogonal polarities and peak emissions from the EUT were detected within 6dB of the class B limit line.

The following measurements were performed on the EUT on 30 April 2004:

Remark:

According to 15.35 (b) When average radiated emission measurements are specified in the regulations, including emission measurements below 1000 MHz, there is also a limit on the radio frequency emissions, as measured using instrumentation with a peak detector function, corresponding to 20 dB above the maximum permitted average limit for the frequency being investigated unless a different peak emission limit is otherwise specified in the rules, e.g., see Section 15.255.

**Test Results: The unit does meet the FCC Part 15 C Section 15.227 requirements.**

### 5.3.2 Occupied Bandwidth

Test Requirement: FCC Part 15 C

Test Method: ANSI C63.4

Operation within the band 26.960 – 27.280 MHz

Test Date: 4 March 2005

Requirements: The field strength of any emissions which appear outside of this band shall not exceed the general radiated emission limits in Section 15.209.

Method of measurement: The useful radiated emission from the EUT was detected by the spectrum analyser with peak detector. The vertical Scale is set to  $-10\text{dB}$  per division. The horizontal scale is set to  $5\text{KHz}$  per division.

The graph as below, represents the emissions take for this device.
