Select to the connected HDMI input channel.


2. DC-IN Power: Connect the power cord DC-IN Jack accessories with this device and the other end directly into the plug.

3. Press the power button to start the system.




## Wifi 2.4 G \5G use method


open (setting—>Network&Internet—>Wi-Fi —>Show available networks)
