Fig.1 Photograph of the SAR measurement System




Fig.2 Photograph of the Tissue Simulant liquid depth 15cm for Flat position




Fig.3 Bottom side of the Notebook is Vertical with panel and paralleled with flat phantom and Notebook is contact it.




Fig.4 Top side of Notebook is paralleled flat phantom, open the panel with 90 degrees, top side is contact with flat phantom.
