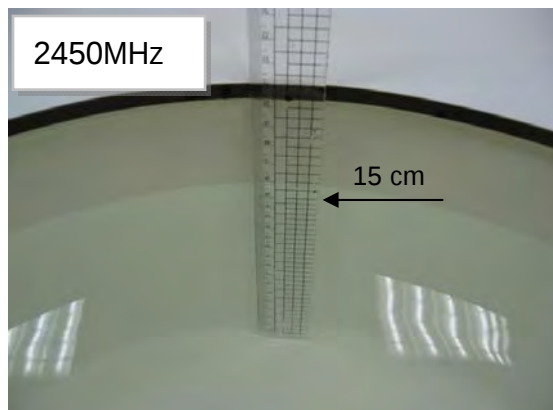

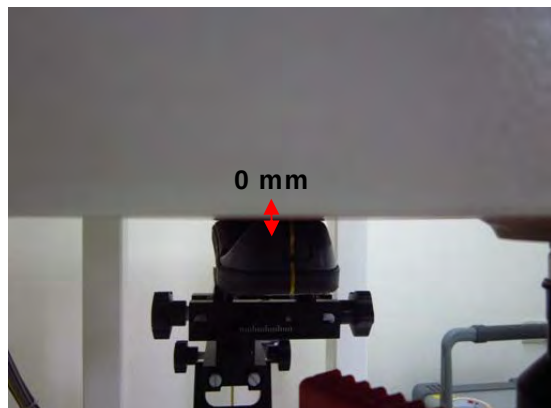
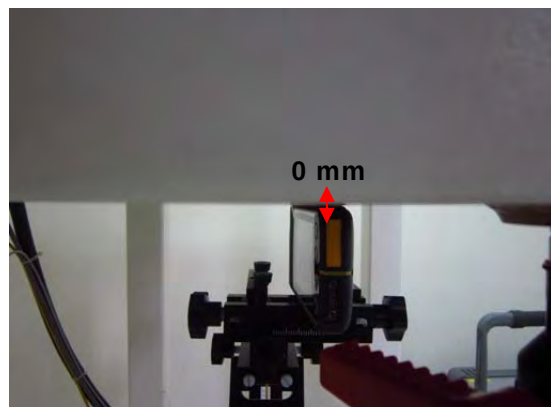


Fig.5 EUT right to flat phantom

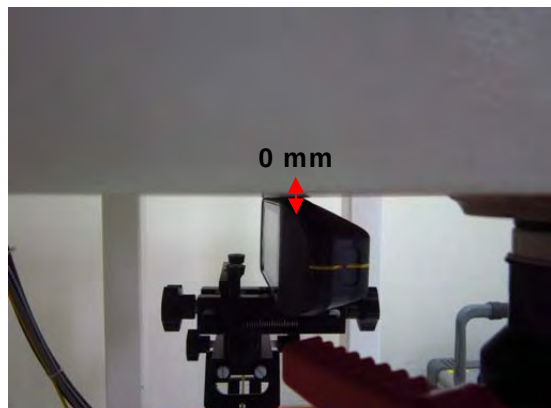


Fig.7 EUT top to flat phantom

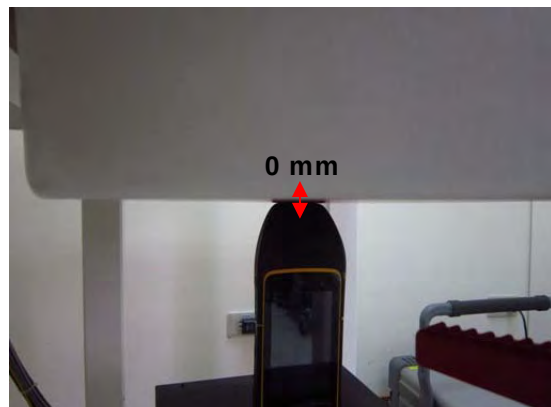


Fig.8 EUT bottom to flat phantom

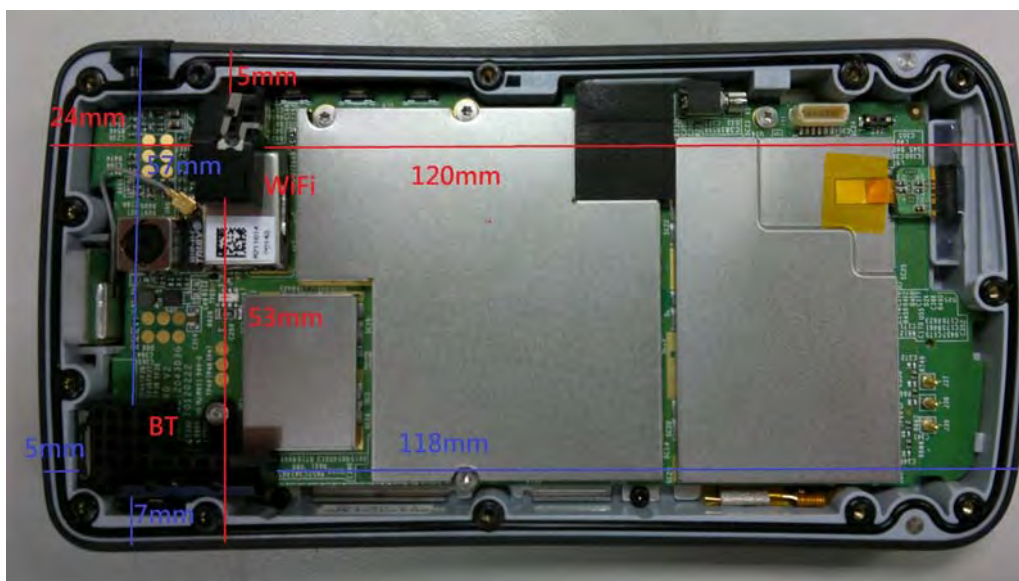


Fig.11 Antenna position of EUT
