

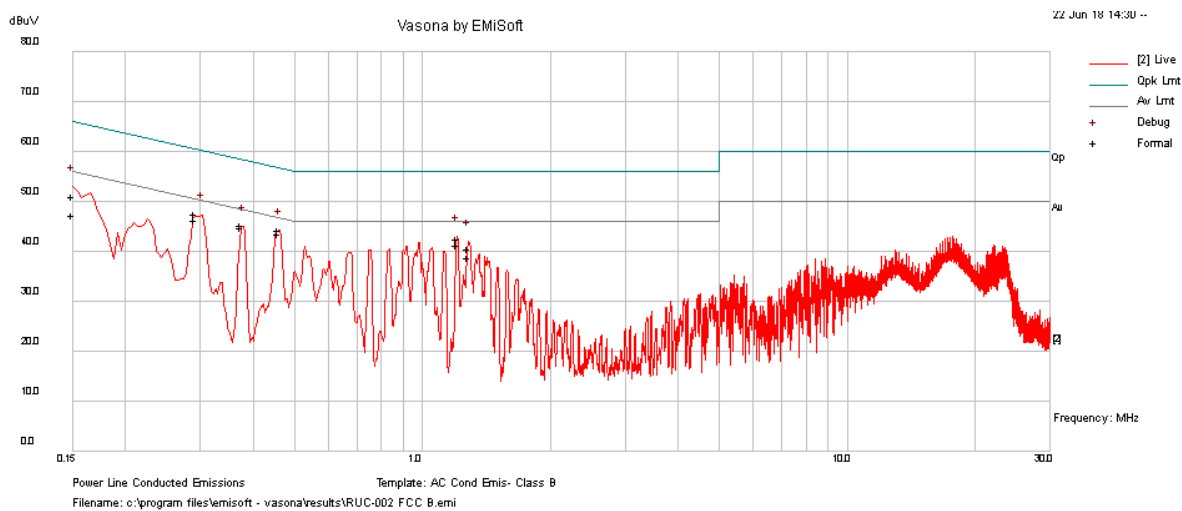

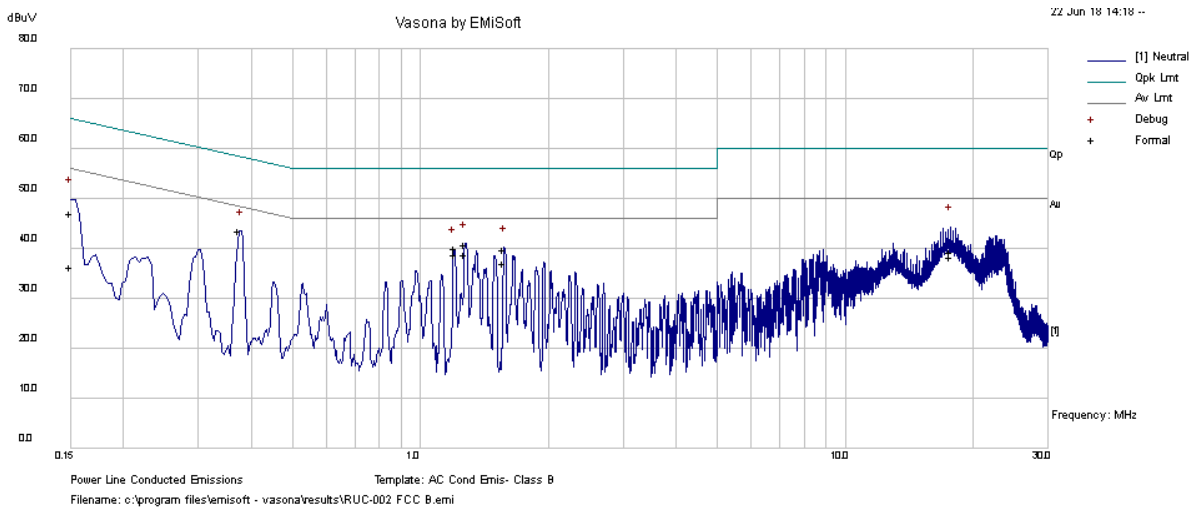


Live Plot at 120Vac, 60Hz



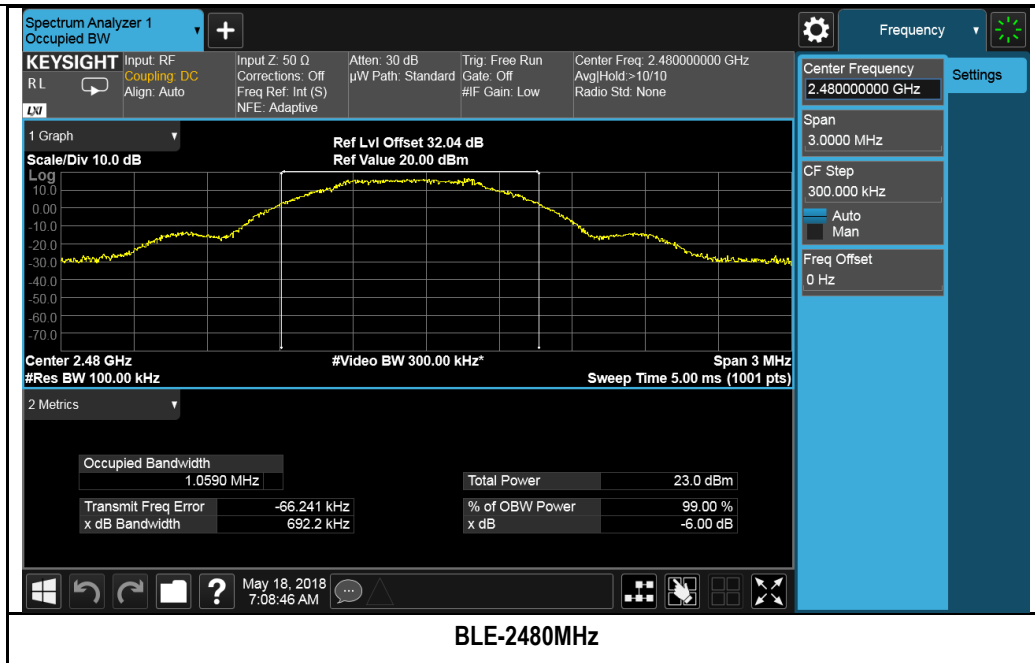


6dB & 99% Bandwidth Test Plots

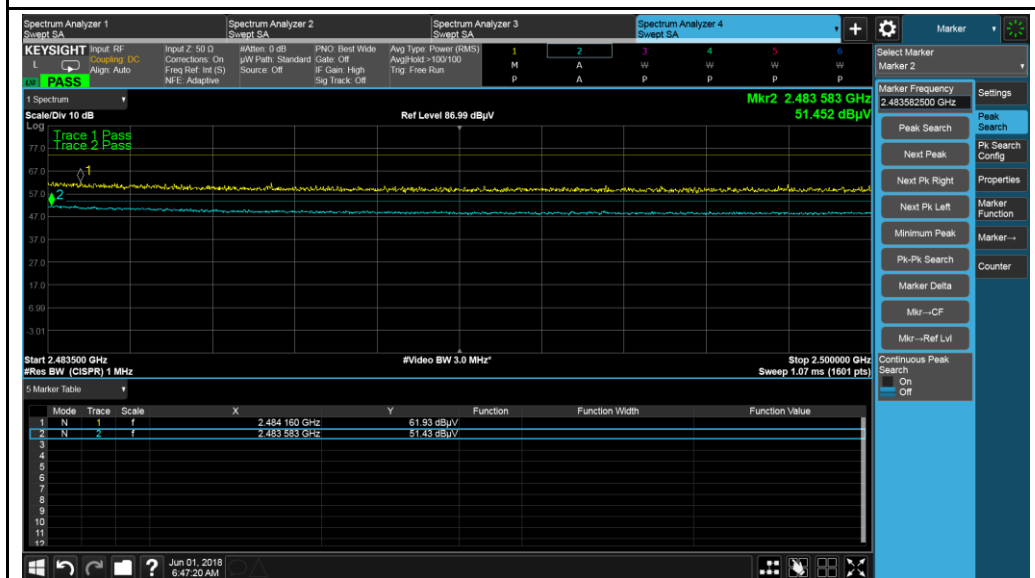
