

POWER & PAIR

POWERING ON/OFF

- 1 Briefly press and hold the Center button on the 3-Button Control.

- GREEN FLASH WITH AUDIBLE ALERT: Power on, Not Paired
- EXTENDED BLUE FLASH WITH AUDIBLE ALERT: Powered Off

PAIRING

- 2 FIRST TIME USE: LEAP Wireless For Women will automatically be set to pairing mode. Skip to step 4 to complete set-up.

CONSECUTIVE USES: Begin with LEAP Wireless For Women powered off and your Bluetooth device powered on and in search mode.

- 3 Press and hold the Center button on the 3-Button Control for an extended period of time, until the light is alternately flashing green and blue indicating it is pairing mode.

- 4 Select "yurbuds LEAP Wireless For Women" on your device.
