### 4.3 Test Procedure & Measurement Data

#### 4.3.1 Radiated Emissions

**Test Requirement:** FCC Part15 C  
**Test Method:** Based on FCC Part15 C Section 15.235  
**Test Date:** 20 July 2004 (Initial Test);  
 30 July 2004 (2<sup>nd</sup> retest).  
**Measurement Distance:** 3m (Semi-Anechoic Chamber)  
**Requirements:** Carrier frequency will not exceed 80dBuV/m AT 3m.  
 Out of band emissions shall not exceed:  
 40.0 dBμV/m between 30MHz & 88MHz  
 43.5 dBμV/m between 88MHz & 216MHz  
 46.0 dBμV/m between 216MHz & 960MHz  
 54.0 dBμV/m above 960MHz  
**Detector:** Peak Scan (120kHz resolution bandwidth)

Test Procedure: The procedure used was ANSI Standard C63.4-2000. The receive was scanned from 30MHz to 1000MHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. The worst case emissions were reported.

An initial pre-scan was performed in the 3m chamber using the spectrum analyser in peak detection mode. The EUT was measured by Bilog antenna with 2 orthogonal polarities and peak emissions from the EUT were detected within 6dB of the class B limit line.

The following measurements were performed on the EUT on 30 July 2004:

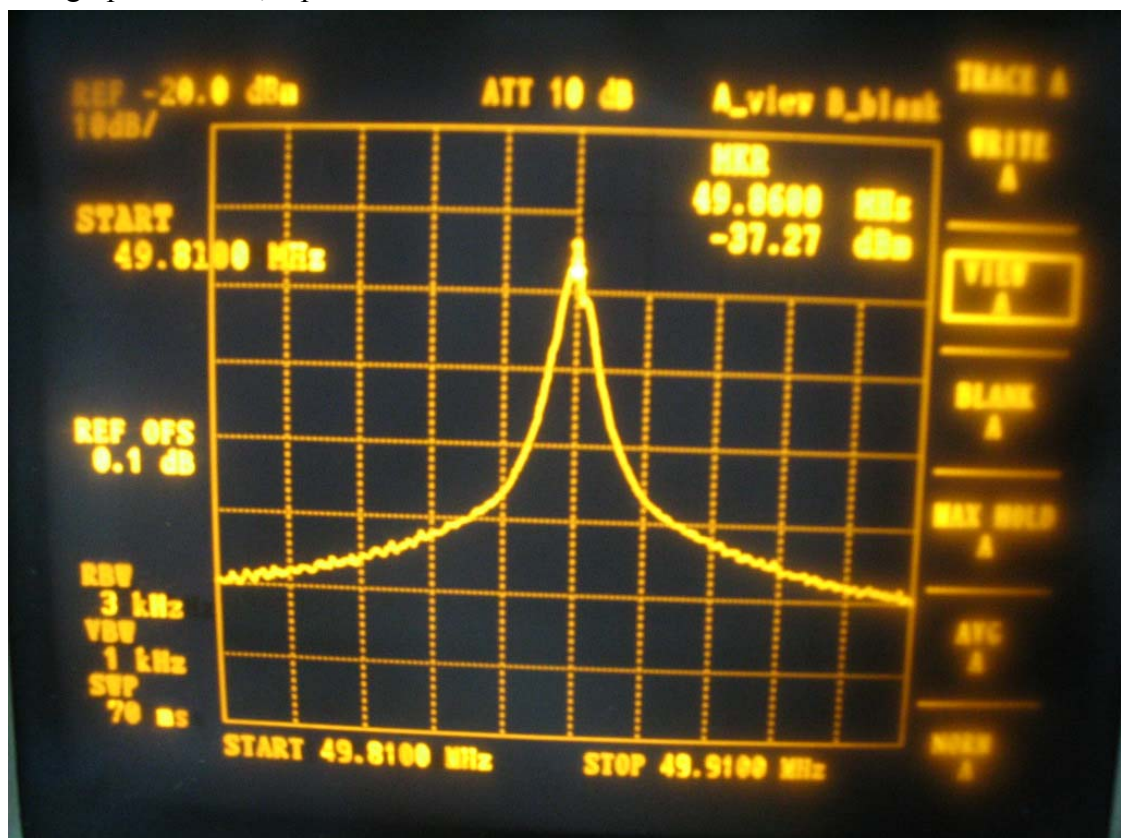

**Test Results: The unit does meet the FCC Part 15 C requirements. But the result is close to limit.**

## 4.3.2 Occupied Bandwidth

Test Requirement:	FCC Part 15 C
Test Method:	Based on FCC Part15 C Section 15.235: Operation within the band 49.82 – 49.90 MHz
Test Date:	30 August 2004
Requirements:	The field strength of any emissions appearing between the band edges and up to 10 kHz above and below the band edges shall be attenuated at least 26 dB below the level of the unmodulated carrier or to the general limits in Section 15.209, whichever permits the higher emission levels. The field strength of any emissions removed by more than 10 kHz from the band edges shall not exceed the general radiated emission limits in Section 15.209.
Method of measurement:	The useful radiated emission from the EUT was detected by the spectrum analyser with peak detector. The vertical Scale is set to –10dB per division. The horizontal scale is set to 5KHz per division.

The graph as below, represents the emissions take for this device.
