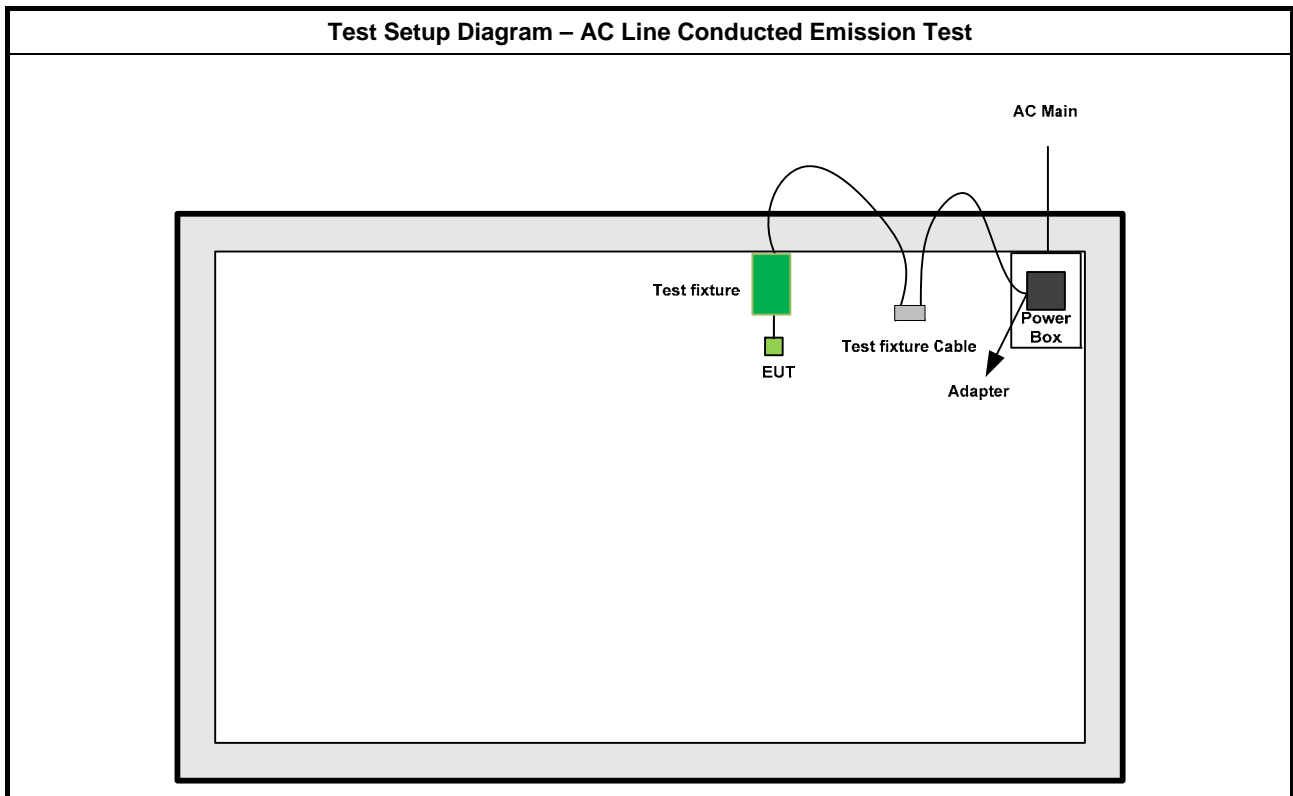

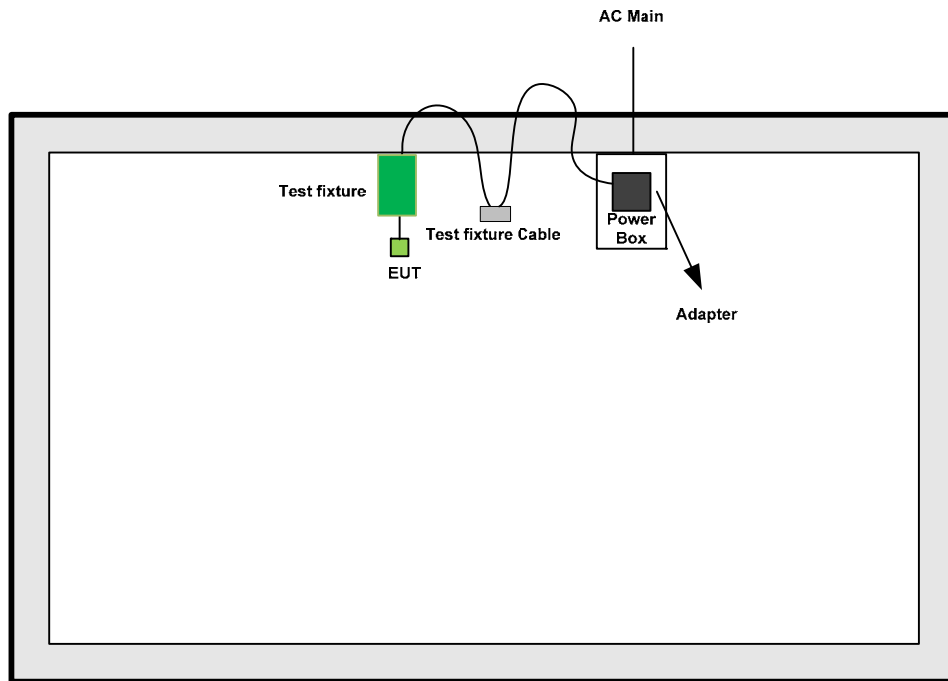

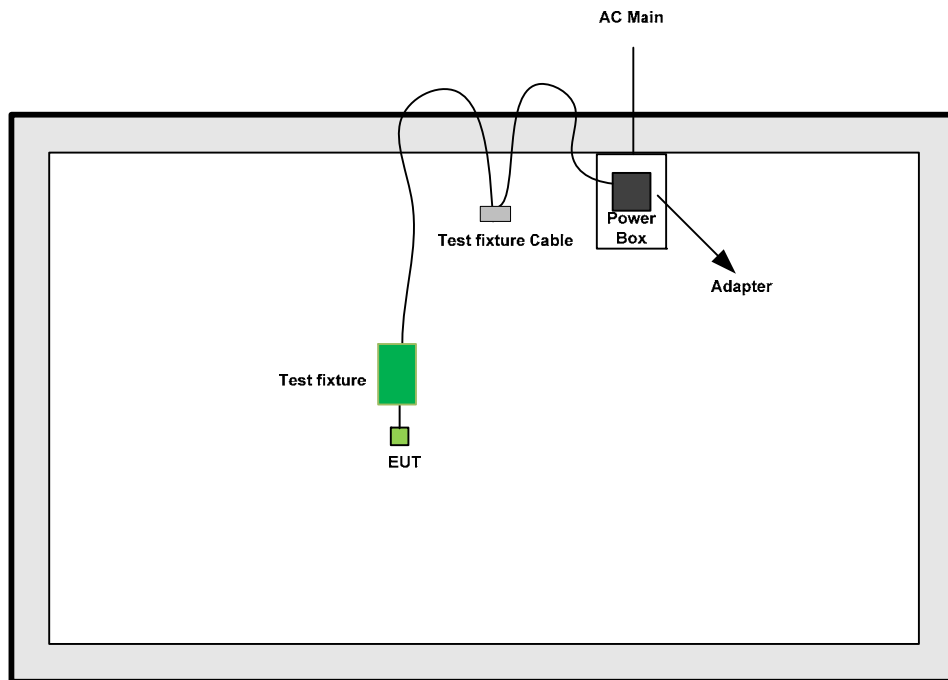

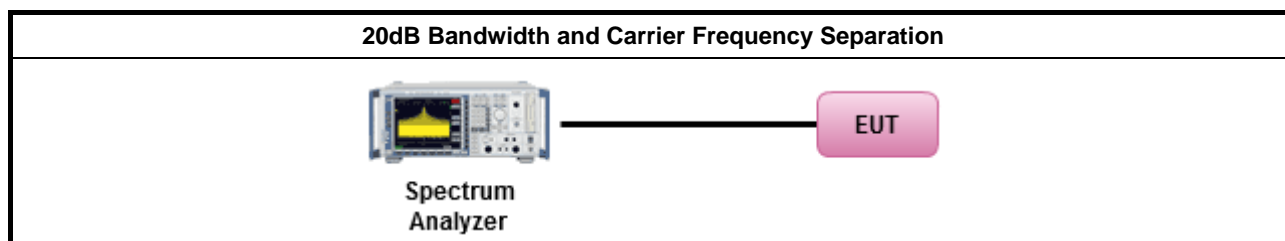

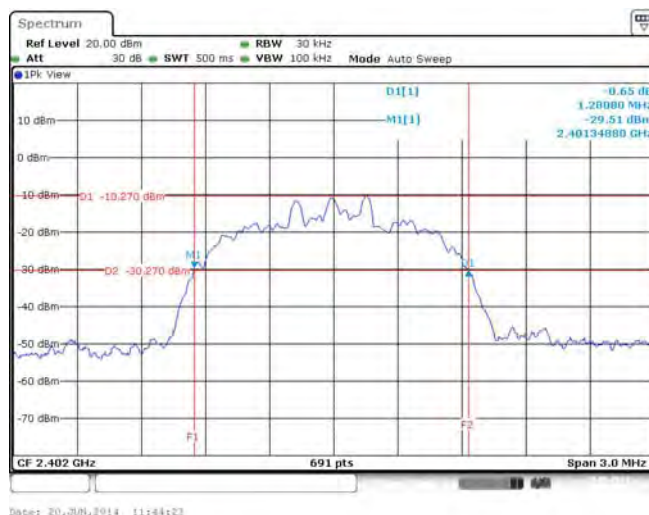

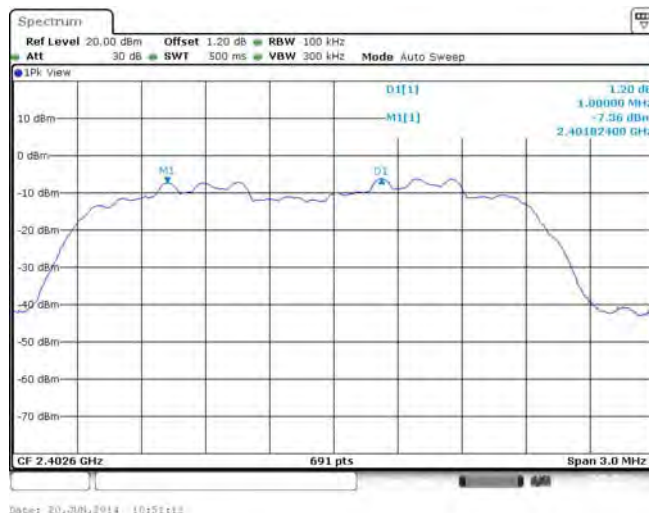
Worst 20dB Bandwidth Plots

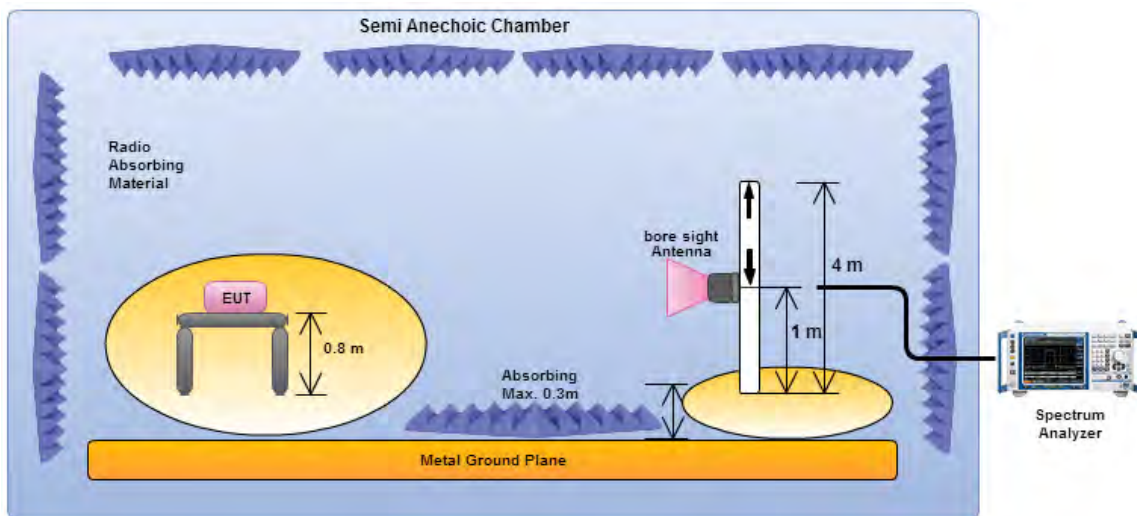

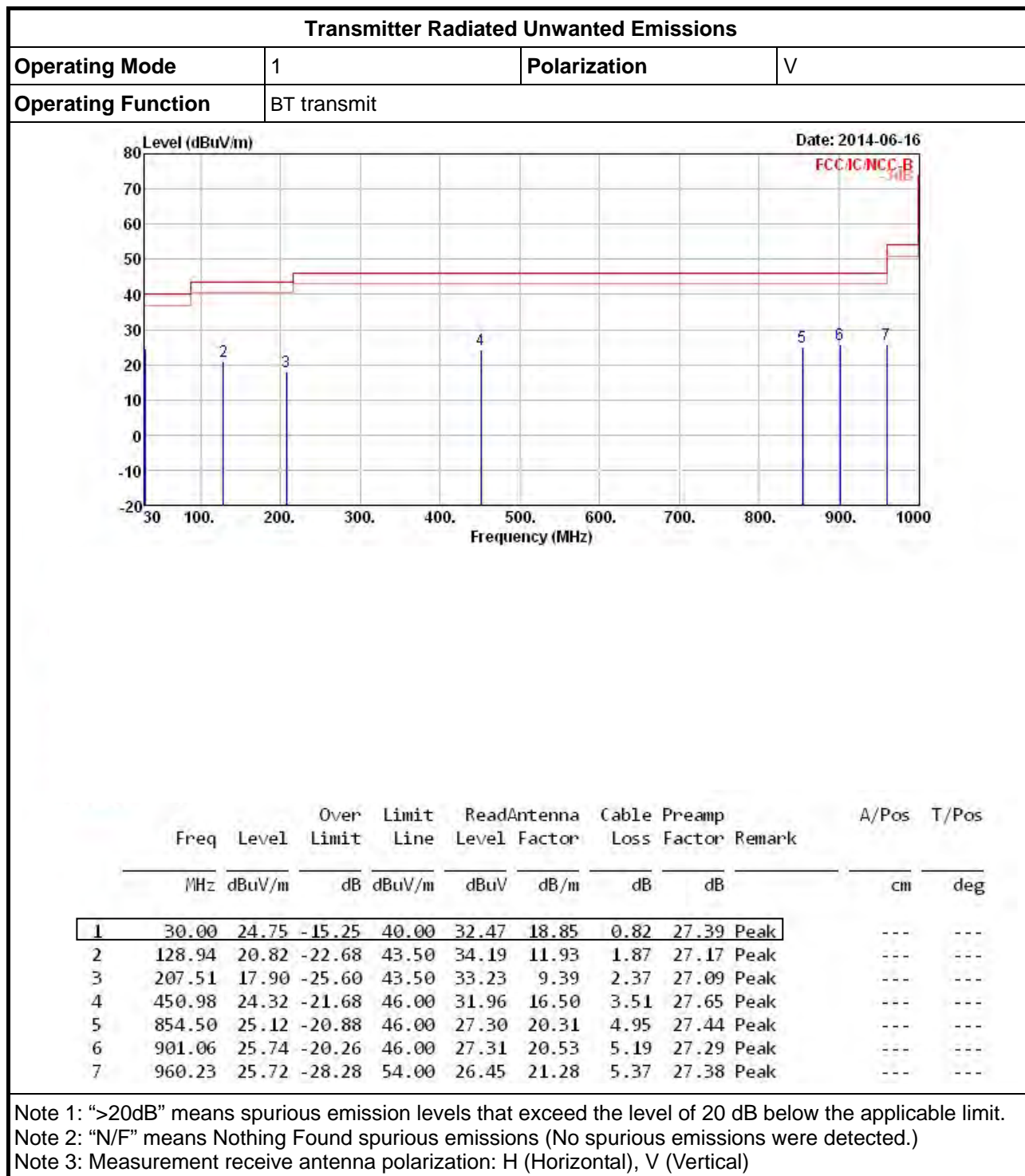
Transmitter Radiated Unwanted Emissions Above 1GHz
