Elisa, I have reviewed the documentation submitted for the TCB Certification of this Bluetooth Hands;XFree Car Kit and have the following issues that need to be addressed:

1) There is no FCC information in the manual, so they need 15.21 as well as no-collocation statement. An example of acceptable wording is as follows:

This equipment complies with FCC radiation exposure limits set forth for an uncontrolled environment. End users must follow the specific operating instructions for satisfying RF exposure compliance. This transmitter must not be co-located or operating in conjunction with any other antenna or transmitter.

Notice: Any changes or modification not expressly approved by the party responsible could void the user's authority to operate the device.

2) The schematic diagram is not legible. Please re-submit a higher resolution exhibit so the text can be read.
