


Fig.1 Photograph of the SAR measurement system












Fig.6 EUT right side (slant) to flat phantom




Fig.7 EUT Left side to flat phantom




Fig.8 EUT Left side (slant) to flat phantom




Fig.9 EUT Top side to flat phantom




Fig.10 EUT Top side (slant) to flat phantom




Fig.16 Antenna position plot
