Connecting E-Blocks® to your computer:



1st

- Attach one end of the USB cable to E-Blocks® panel. Do not put too much pressure on the plug or it might get damaged.



2nd

- Attach the other end of the USB cable to the computer while *your operation system (Windows or Mac OS)* is running. If you are using Mac OS, Windows 2000 or Windows XP, administrator rights are required to install E-Blocks® properly.
- NOTE: Do not attach E-Blocks® to a USB HUB, as this can cause panel malfunction.



3rd

- Windows *your operation system (Windows or Mac OS)* should automatically detect the new USB device. In this case, go to step 7. In some cases, Windows 98 will require a driver for Human Interaction Device (HID). If this happens, Windows "Add New Hardware" Wizard will start. Click on "Next".



4th

- Follow the instructions on the screen and select **SEARCH FOR THE BEST DRIVER FOR YOUR DEVICE (RECOMMENDED)**. Then, click "Next".



5th

- If necessary, check **Specify Location**. Click on "Browse" and locate C:\Windows\system. Click "OK" and then click "Next".



6th

- Now Windows will locate the driver. Click "Next". Windows will then perform the driver installation and notify you when the installation is complete. Click "Finish".



7th

- Install E-Blocks® Software by following the instructions on your E-Blocks® CD.

This product has a 12-month warranty starting from the original date stated on your purchase receipt. Therefore, the end user must keep a copy of the purchase receipt in a safe place. Hot Keys

Note that the E-Blocks® Software has Hot Keys which are designed to help the teacher navigate through some restricted areas (off-limits to students).

- Shift + F1 to choose the help language.
- Shift + F2 to open the virtual keyboard (which can be used instead of the blocks).
- Shift + F3 to place the song and the game icons on the navigation bar.
- Shift + F4 to open the student record form
