## Quick Start

To use your iBrella wireless portable speaker system with bluetooth, you need to:

1. Remove from box
2. Remove battery cover and place 2AAA batteries, then replace cover.
3. Turn on the portable speaker (slide to on position)
4. Secure your 1 ¼ inch beach umbrella into sand.
5. Place iBrella into top of bottom pole securely.
6. Place top of your 1 ¼ inch beach umbrella into iBrella
7. Turn on bluetooth power on your cell phone/device (refer to cellphone/device's user manual for instructions)
8. Name: iBrella  
Code: 000
9. Sit back and enjoy.

## Troubleshooting

### 1. HEARING DISTORTION

- a. Lower the volume on your Bluetooth Speaker and/or phone/device. (See section 5, Get connected)
- b. Make sure it's charged up. Check for low battery, then charge Bluetooth Speaker

### 2. NOT LOUD ENOUGH?

- a. Turn up the volume on your phone/device or your Bluetooth Speaker
- b. Make sure it's charged up.
- c. Plug Bluetooth Speaker in to your phone/device via 3.5mm stereo cable.

### 3. UNABLE TO PAIR WITH BLUETOOTH® DEVICE?

- a. Confirm that your phone/device is Bluetooth compatible.
- b. Follow GET CONNECTED instructions in this guide

### 4. EXPERIENCING SIGNAL LOSS OR DROPOUTS VIA BLUETOOTH?

- a. Move Bluetooth Speaker closer to your phone/device.
- b. Make sure it's charged up.
- c. Turn off your BENCH and phone/device, then power up and reconnect.
