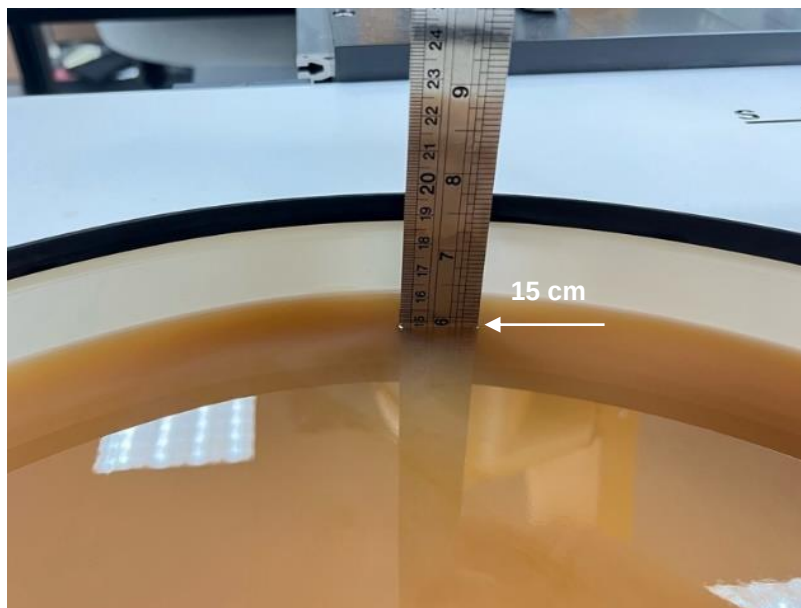

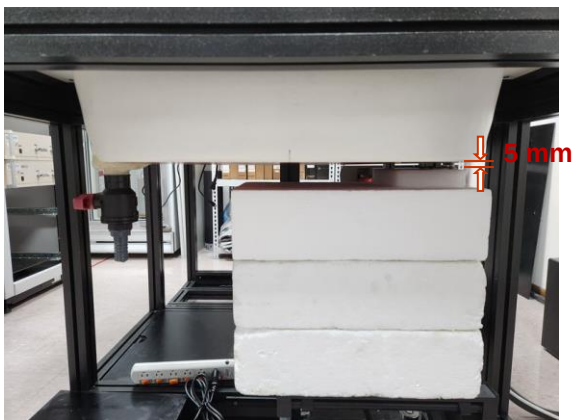

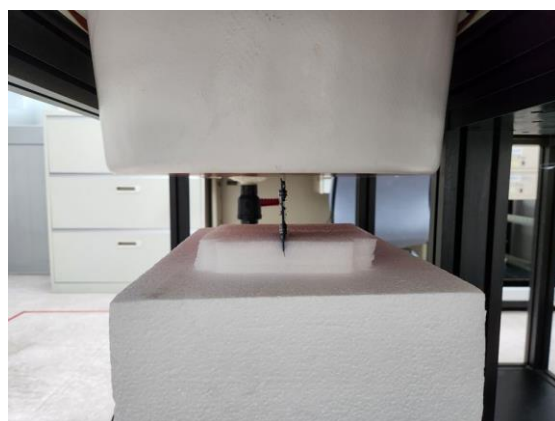

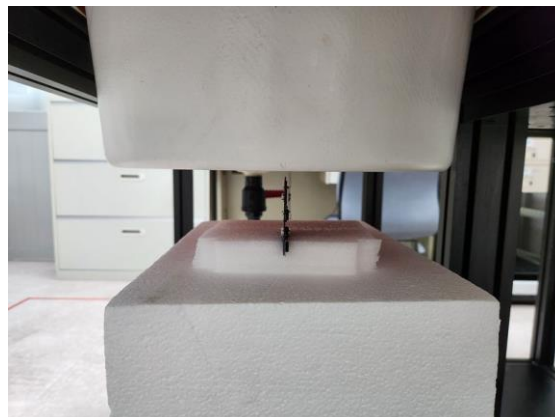

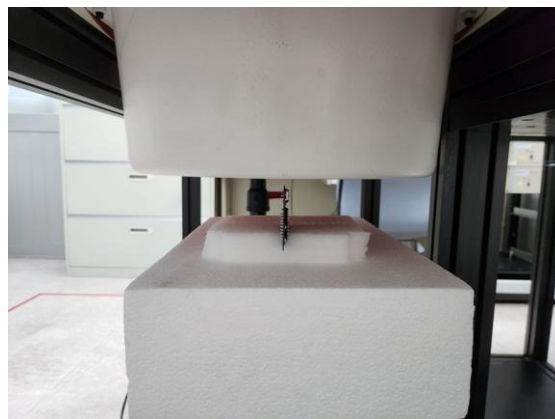

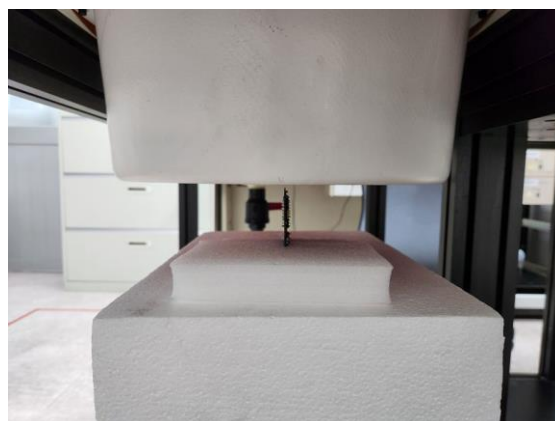
Photograph 9. Body, Right Edge, 5mm
