



Charging Your Tablet

 To charge your tablet, plug the included charging cable into the tablet's charging port and connect to a power outlet. Note that the connector should insert easily. Forcing the connector into the port may cause damage to your tablet.



- If your tablet is powered off, a charging icon will appear on your screen.

- If your tablet is powered on, the battery icon in the top right corner of your screen will change to indicate that your tablet is charging.

- Charging your tablet for two hours prior to initial use will assure the best experience.
- For your safety, we recommend that you disconnect your tablet from the power source once it is fully charged and that you refrain from charging it overnight. Setup

Please note the following steps are designed to supplement on-screen instructions from the Setup Wizard.

- 1. To power on your tablet, long press the power on/off button for 2-3 seconds. Note that your tablet may take several minutes to boot. To power off or restart your tablet, long press the power on/off button for 2-3 seconds, then select Power off or Restart.
- 2. When your tablet is finished booting, the Setup Wizard will begin. Tap "English (United States)" to select your preferred language. When you are finished selecting, select "Start" to continue. Language can be changed later in the settings menu.
- 3. To "Connect to Wi-Fi" (necessary step to access the internet), select your preferred Wi-Fi network.
- I. If you do not know the name of your network, check your wireless router or contact your internet service provider.
- II. Some networks may require a password to connect. If you do not know your home network password, contact your internet service provider.
- III. If you receive an "Authentication problem" notice, you may have entered your password incorrectly. Most passwords are case-sensitive. Check the "Show password" box to see your password as you type.
- 4. To continue without connecting to your Wi-Fi network, select the "Setup up offline" option, then select "Continue".
- 5. If you chose the "Setup up offline" option, next you will see the "Date & time" screen, change the time zone, date, or time if adjustment is needed, then select "Next". Skip to Step 8.
- 6. If you chose to connect to your Wi-Fi network, the next screen will display "Getting your tablet ready...This may take a few minutes". On the next screen you will have the option to "Copy apps & data" from an existing Android™ device or from the cloud. Select "Next" and follow the on-screen instructions or select the "Don't copy" option.
- 7. If you chose to connect to your Wi-Fi network, you will be prompted "Who's going to use this device?" If for a child, see Google Kids Space™ Setup on next page. If for yourself, select "An adult or a teen", you will then be prompted to login to your Google™ account or select "Create account". On the next screen, select "I agree" to accept Google™ Terms of Service. Logging in will allow for seamless use of Google™ apps and easy access to the Google Play™ store. If you do not remember your Google™ username or password, visit: www.goo-gle.com/recovery
- 8. Next you have the option to participate in Google™ services. By default, some options are turned on. You can disable certain options by selecting each individual slider, the slider will be grayed out if disabled. Select Google's "Privacy Policy" link to learn more about how Google™ services use your data before selecting "Accept".
- 9. Next you have the option to a "Set a pin" or you may skip this option by selecting "Skip". For security purposes, it is recommended you set a screen lock option. The default screen lock option is a PIN, which must be at least 4 digits. Other options are available by selecting the "Screen lock options". IMPORTANT NOTE: Regardless of the option you select, it is essential that you remember your Pattern, Pin, or Password, as it will be necessary for accessing your tablet.
- 10. The next few screens allow for additional customization options; you can either select "Skip", "No thanks", "Continue", or "I agree" based on your preferences.

11. When the Setup Wizard is complete, the home screen will load.

Google Kids Space™ Setup

Follow the steps below to setup Google Kids Space™

- 1. When prompted who will use the tablet, select "A child". (If you had previously setup the tablet as an adult or teen, swipe up on the home screen and select the Kids Space app, then follow the prompts).
- 2. Sign into your child's existing Google™ account or follow the prompts to create a new Google™ account for your child under 13.
- 3. When prompted to setup Google Kids Space, select "Set Up".
- 4. Parental Consent & Family Link™, follow the prompts to set screen time limits, approve or block apps, and add filters for web and search.
- 5. The next few screens allow for additional customization options; select "Skip", "Next" or "No thanks" based on your preferences.
- 6. When prompted, "Pick what you like", have your child select at least three, then select "Next", finally select "Push".

Note: If the tablet was initially set up for an adult, Google Kids Space™ can still be set up later by selecting the Kids Space app from the app drawer.

Troubleshooting and Resources

- Many issues can be resolved by performing a soft reset of your tablet. Insert a safety pin, paper clip, or earring into the reset hole. You should feel the reset button click. Your tablet will begin resetting. This will take a few minutes to complete. The tablet should power back up or you may need to press and hold the power on/off button for 2-3 seconds. IMPORTANT NOTE: The hole directly next to the charging port is the charging indicator light. Do not insert objects into this hole (10QH+ model only).
- Some issues may require a factory reset. This process will erase all of your stored apps, documents, photos, and information. Please make sure to backup any files you would like to save prior to initiating a reset. To perform a factory reset, select "Settings", scroll down and select "System", select "Advanced", select "Reset options", select "Erase all data (factory reset)", select "Erase all data", and lastly select "Erase all data" again. This process will take several minutes to complete.
