2.5 General Test Procedure

POWER LINE CONDUCTED INTERFERENCE: The procedure used was ANSI STANDARD C63.4-2003 5.2 using a 50µH LISN (if necessary). Both lines were observed. The bandwidth of the spectrum analyzer was 10 kHz with an appropriate sweep speed.

RADIATION INTERFERENCE: The test procedure used was ANSI STANDARD C63.4-2003 6.4 using a spectrum analyzer. The bandwidth of the spectrum analyzer was 100 kHz with an appropriate sweep speed. The analyzer was calibrated in dB above a microvolt at the output of the antenna. The resolution bandwidth was the 100 kHz and the video bandwidth was 300 kHz. The ambient, temperature of the UUT was 23°C with a humidity of 40 %.

FORMULA OF CONVERSION FACTORS: The Field Strength at 3m was established by adding the meter reading of the spectrum analyzer (which is set to read in units of $dB\mu V$) to the antenna correction factor supplied by the antenna manufacturer. The antenna correction factors are stated in terms of dB.

Example:

Freq (MHz) METER READING + ACF + CABLE LOSS(to the receiver) = FS

33 $20 dB\mu V + 10.36 dB/m + 6 dB = 36.36 dB\mu V/m @3m$

ANSI STANDARD C63.4-2003 6.2.1 MEASUREMENT PROCEDURES: The UUT was placed on a table 80 cm high and with dimensions of 1m by 1.5m (non metallic table). The UUT was placed in the center of the table. The table used for radiated measurements is capable of continuous rotation. The spectrum was scanned from 30 MHz to 10^{th} harmonic of the fundamental.

Peak readings were taken in three (3) orthogonal planes and the highest readings.

Measurements were made by ETS Dr. Genz Taiwan PS Co., Ltd. at the registered open field test site located at. The Registration Number: 930600

When an emission was found, the table was rotated to produce the maximum signal strength. At this point, the antenna was raised and lowered from 1m to 4m. The antenna was placed in both the horizontal and vertical planes.

3.3 Out of Band Radiated Emissions

3.5 Spurious Emission radiated, Transmitter

The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. For devices operating above 900 MHz, the emission shall be no wider than 0.5% of the center frequency. Bandwidth is determined at the points 20 dB down from the modulated carrier.

3.7 Antenna requirement

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

3.8 Duty Cycle

The correction factor, based on the channel dwell time in a 100ms period, may be mathematically applied to a measurement made with an average detector, to further reduce the measured value.

Average Reading = Peak Reading (dBuV/m) + Duty Cycle Correction

Duty Cycle Correction = $20 \log (Cycle)$

3.9 Conducted Measurement at (AC) Power Line

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the table bellows with this provision shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminals.

This measurement was transact first with instrumentation using an average and peak detector and a 10 kHz bandwidth. If the peak detector achieves a calculated level, the measurement is repeated by an instrumentation using a quasi-peak detector.


