8.3 Standard Applicable

FCC §22.917(a), §24.238(a), §27.53(h), Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dB.

FCC §27.53(c)

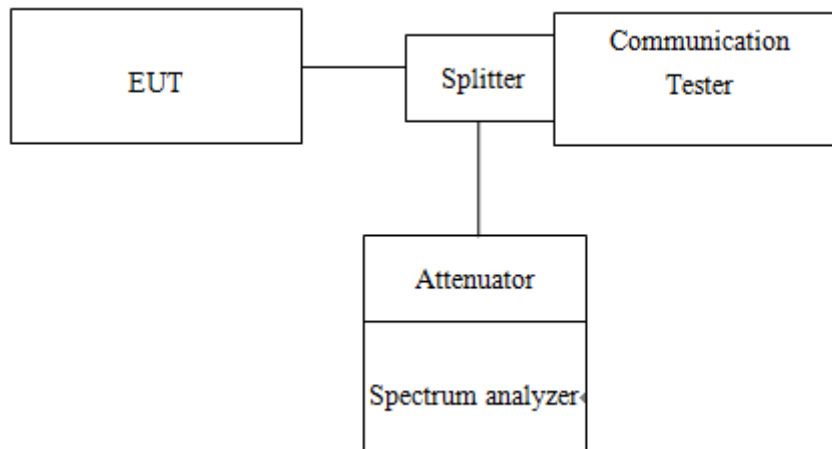

Conducted Emission

The RF output of the transceiver was connected to a spectrum analyzer through appropriate attenuation. The resolution bandwidth of the spectrum analyzer was set at 1MHz, sufficient scans were taken to show the out of band Emissions if any up to 10th harmonic.

1. To connect Antenna Port of EUT to Spectrum.
2. Set RBW = 1MHz & VBW = 1MHz on Spectrum.
3. Allow trace to fully stabilize
4. Repeat above procedures until all default test channel measured were complete.

Band Edge

1. To connect Antenna Port of EUT to Spectrum.
2. The band edge of low and high channels for the highest RF powers was measured. Setting $RBW \geq 1\% \text{ EBW}$.
3. Allow trace to fully stabilize
4. Repeat above procedures until all default test channel measured were complete.
