

TEST PROCEDURE

1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a WIFI module op system; a wooden table with a height of 0.1 meters is used and is placed on the ground plane as per ANSI C63.10:2020.
2. Support equipment, if needed, was placed as per ANSI C63.10:2020.
3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10:2020.
4. The adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
5. All support equipments received AC power from a second LISN, if any.
6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load;

the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.

7. Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
8. During the above scans, the emissions were maximized by cable manipulation.

TEST RESULTS

Battery-powered products do not require this test.

3.2. Radiated Emissions

Limit

The maximum emissions outside of the frequency bands of operation shall be attenuated in accordance with the following limits:

- (1) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (2) For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (3) For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (4) For transmitters operating in the 5.725-5.85 GHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.






(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

Test Procedure

1. Below 1GHz measurement the EUT is placed on a turntable which is 0.1m above ground plane, and above 1GHz measurement EUT was placed on a low permittivity and low loss tangent turn table which is 1.5m above ground plane.
2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0°C to 360°C to acquire the highest emissions from EUT
3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
4. Repeat above procedures until all frequency measurements have been completed.
5. Radiated emission test frequency band from 9KHz to 40GHz.
6. The distance between test antenna and EUT as following table states:




TEST RESULTS

Remark:

1. This test was performed with EUT in X, Y, Z position and the worse case was found when EUT in X position.
2. All 802.11a / 802.11n (HT20) modes have been tested for below 1GHz test, only the worst case 802.11n (HT20) low channel of U-NII 1 band was recorded.
3. All 802.11a / 802.11n (HT20) modes have been tested for above 1GHz test, only the worst case 802.11n (HT20) was recorded.
4. Radiated emission test from 9 KHz to 10th harmonic of fundamental was verified, and no emission found except system noise floor in 9 KHz to 30MHz and not recorded in this report.

3.3. Maximum Conducted Average Output Power

Limit

FCC requirement:

For the band 5.15-5.25 GHz.

- (i) For an outdoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6dBi.
- (ii) For an indoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6dBi.
- (iii) For fixed point-to-point access points operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W.
- (iv) For client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250mW provided the maximum antenna gain does not exceed 6dBi.


For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250mW or $11\text{dBm} + 10\log B$, where B is the 26 dB emission bandwidth in megahertz.

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W

Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum.

3.4. Power Spectral Density

Limit

FCC requirement:

For the band 5.15-5.25 GHz.

- (i) For an outdoor access point operating in the band 5.15 - 5.25 GHz, the maximum power spectral density shall not exceed 17dBm in any 1 MHz band.^{note1}
- (ii) For an indoor access point operating in the band 5.15 - 5.25 GHz, the maximum power spectral density shall not exceed 17dBm in any 1 MHz band.^{note1}
- (iii) For fixed point-to-point access points operating in the band 5.15 - 5.25 GHz, transmitters that employ a directional antenna gain greater than 23dBi, a 1 dB reduction in maximum power spectral density is required for each 1 dB of antenna gain in excess of 23dBi.
- (iv) For mobile and portable client devices in the 5.15 - 5.25 GHz band, the maximum power spectral density shall not exceed 11dBm in any 1 MHz band. ^{note1}

For the 5.25-5.35 GHz and 5.47-5.725 GHz bands

The maximum power spectral density shall not exceed 11dBm in any 1 megahertz band.

The e.i.r.p. spectral density shall not exceed 10dBm in any 1.0 MHz band.

Frequency band 5250-5350 MHz

The power spectral density shall not exceed 11dBm in any 1.0 MHz band.

For the band 5.725 - 5.85 GHz

The maximum power spectral density shall not exceed 30dBm in any 500 kHz band. ^{note1, note2}


Note1: If transmitting antennas of directional gain greater than 6dBi are used, the peak power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

Note2: Fixed point - to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information.

Test Procedure

1. Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.
2. Set the RBW = 1MHz for U-NII 1, U-NII 2A, U-NII C band and 510KHz for U-NII 3 band.
3. Set the VBW $\geq 3 \times$ RBW.
4. Set the span to encompass the entire EBW.
5. Detector = peak.
6. Sweep time = auto couple.
7. Trace mode = max hold.
8. Allow trace to fully stabilize.
9. Use the peak marker function to determine the maximum power level.

3.5. Emission Bandwidth (26dBm Bandwidth)



Test Procedure

1. Set resolution bandwidth (RBW) = approximately 1 % of the EBW.
2. Set the video bandwidth (VBW) > RBW.
3. Detector = Peak.
4. Trace mode = Max hold.
5. Measure the maximum width of the emission that is 26 dB down from the peak of the emission. Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW / EBW ratio is approximately 1 %.

3.6. Minimum Emission Bandwidth (6dBm Bandwidth)



Section 15.407(e) specifies the minimum 6 dB emission bandwidth of at least 500 kHz for the band 5.725-5.85 GHz

Test Procedure

1. Set resolution bandwidth (RBW) = 100 kHz
2. Set the video bandwidth 3 x RBW.
3. Detector = Peak.
4. Trace mode = Max hold.
5. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.



3.7. Frequency Stability

Manufacturers of U-NII devices are responsible for ensuring frequency stability such that an emission is maintained within the band of operation under all conditions of normal operation as specified in the users manual.

TEST PROCEDURE

Frequency Stability under Temperature Variations:

The equipment under test was connected to an external AC or DC power supply and input rated voltage. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators. The EUT was placed inside the temperature chamber. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 20°C operating frequency as reference frequency. Turn EUT off and set the chamber temperature to -30°C. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with 10°C increased per stage until the highest temperature of +50°C reached.

Frequency Stability under Voltage Variations:

Set chamber temperature to 20°C. Use a variable AC power supply / DC power source to power the EUT and set the voltage to rated voltage. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and recorded the frequency.

Reduce the input voltage to specify extreme voltage variation ($\pm 15\%$) and endpoint, record the maximum frequency change.
