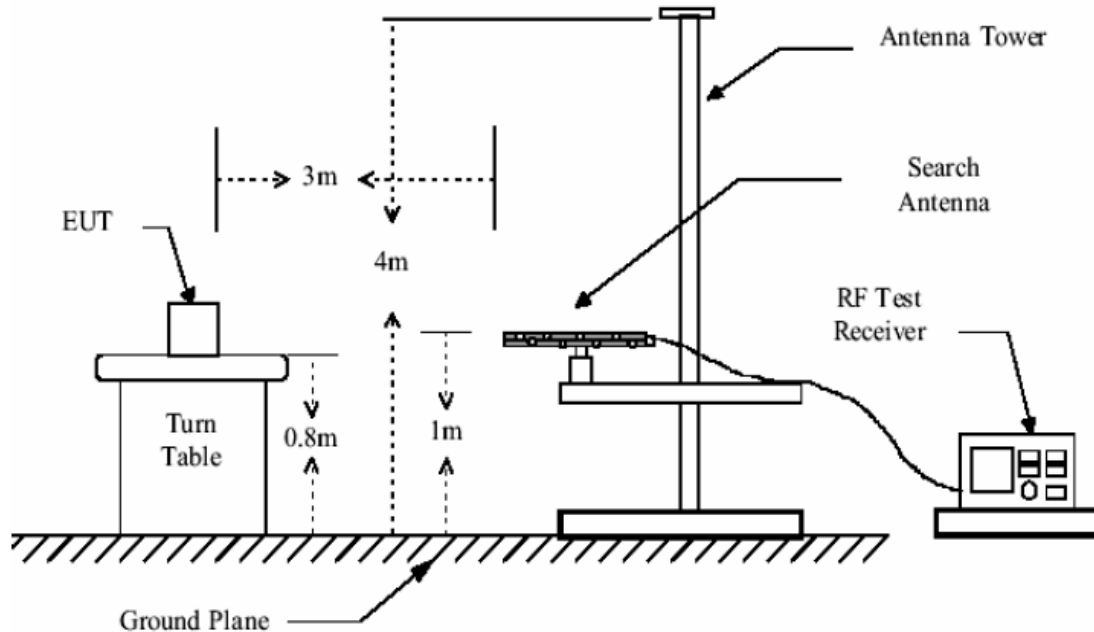


Figure1: 30MHz to 1GHz radiated emissions test setup

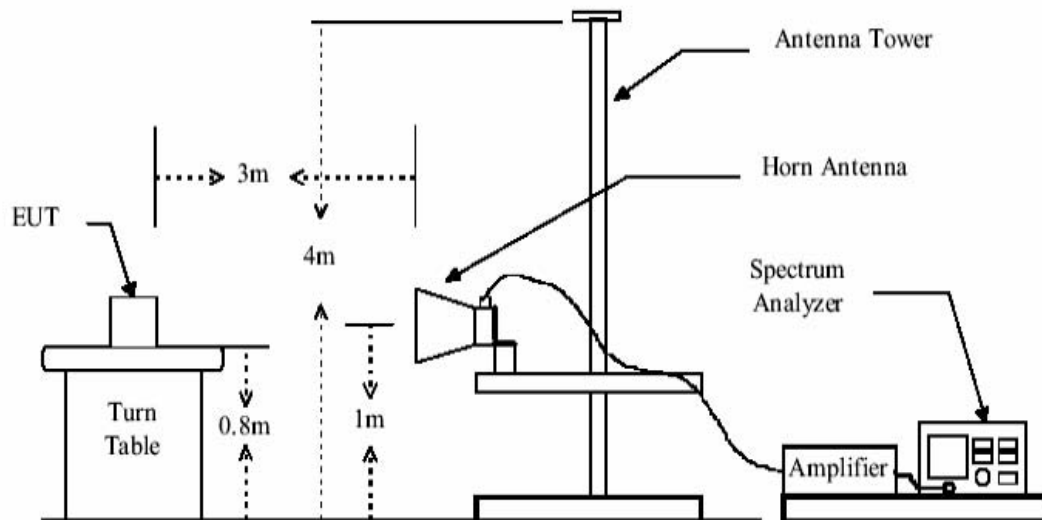


Figure 2: Above 1GHz radiated emissions test setup

5.2.2 Test Procedure

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Repeat above procedures until all frequency measured were complete.

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain from the measured reading. The basic equation with a sample calculation is as follows:

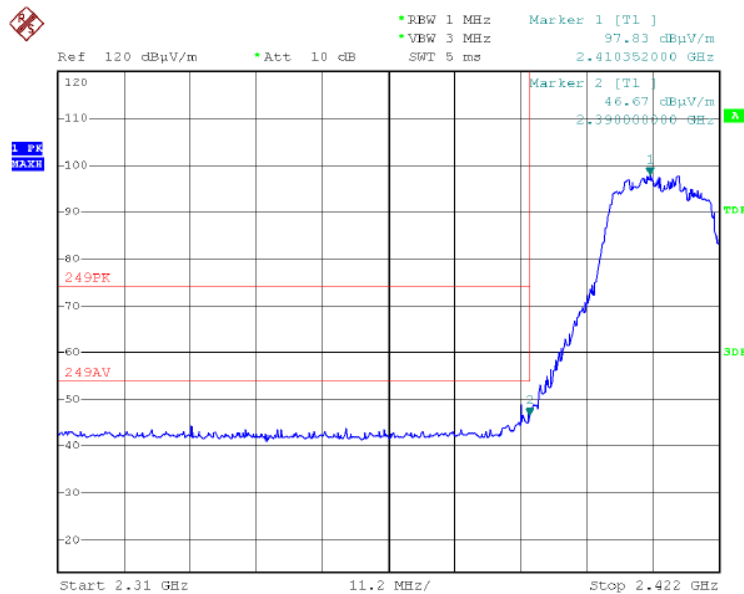


Band Edge and Restrictred band (Radiated measurement)

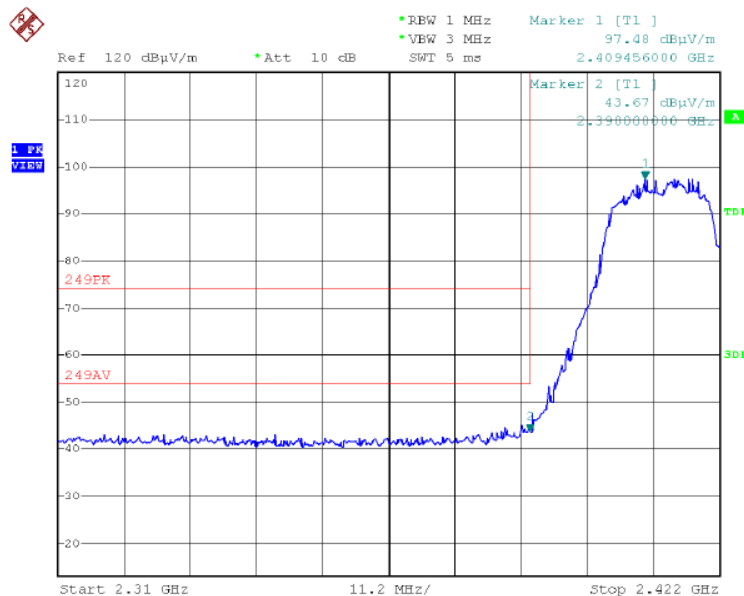

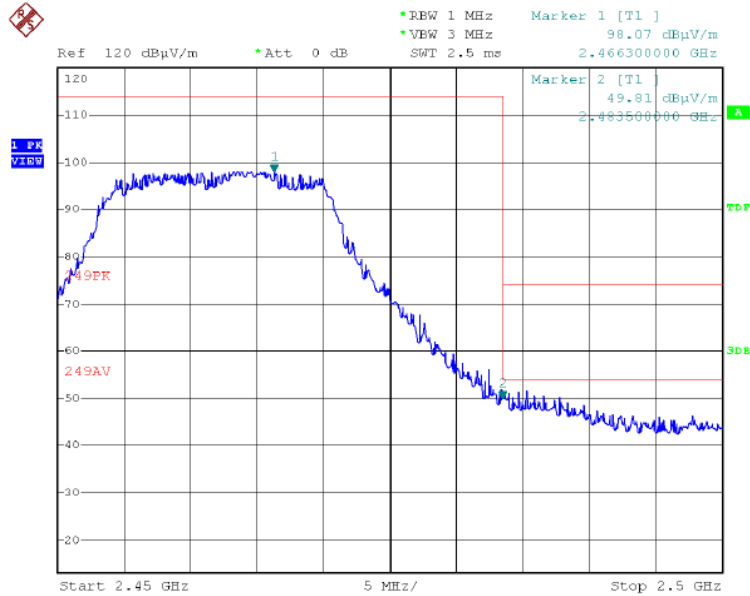

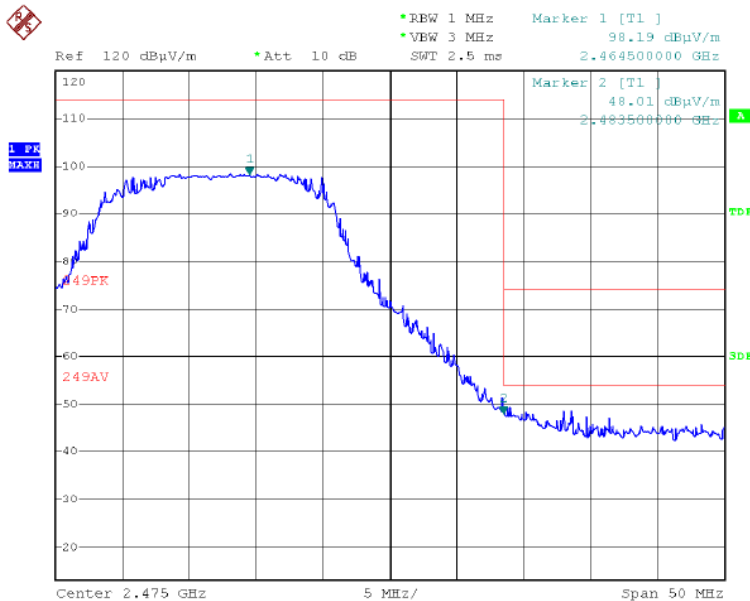


Transmitting with 801.11n mode (Highest channel=2462MHz)

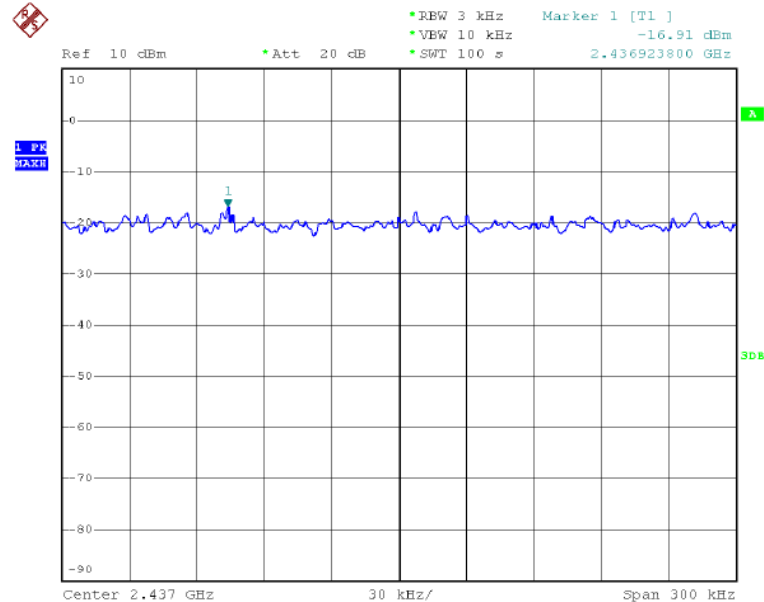


The EUT communicating with 802.11b Mode

Middle channel=2437MHz



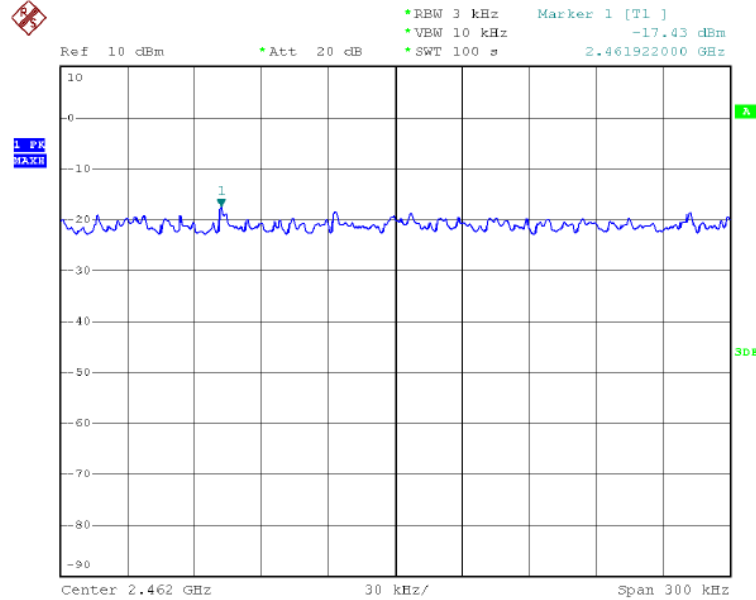

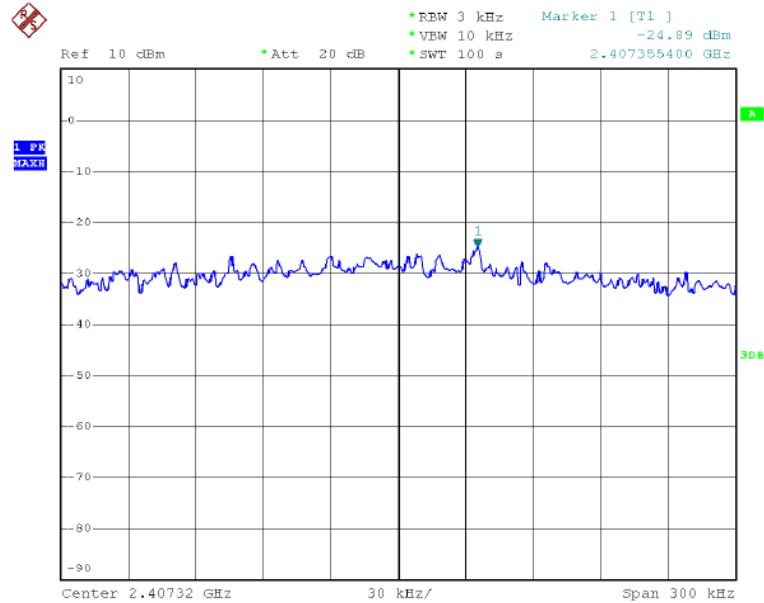

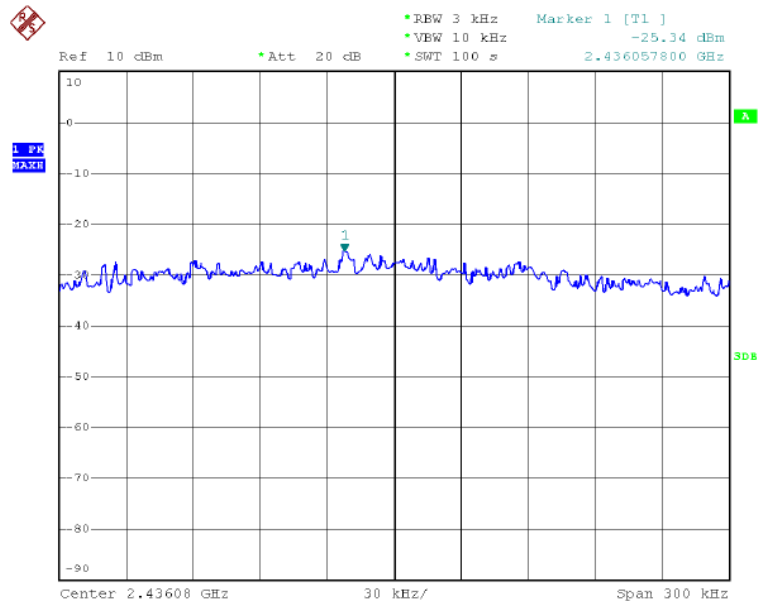


The EUT communicating with 802.11g Mode

Middle channel=2437MHz



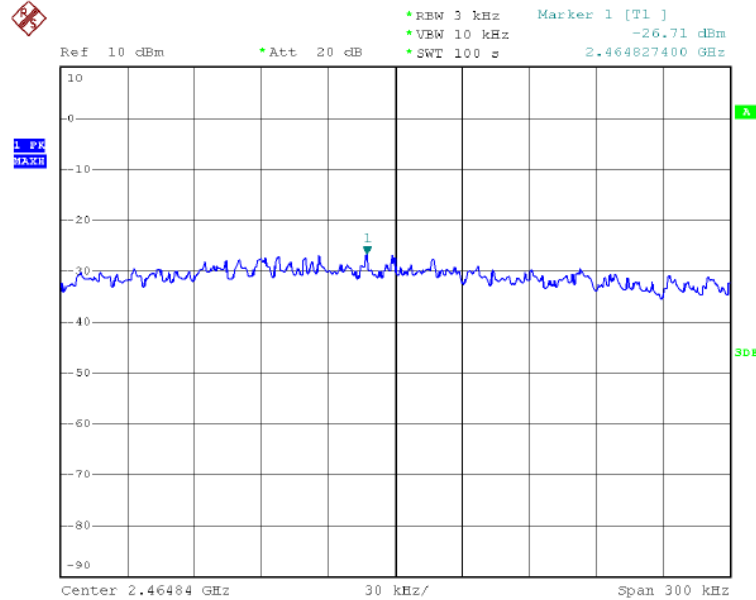

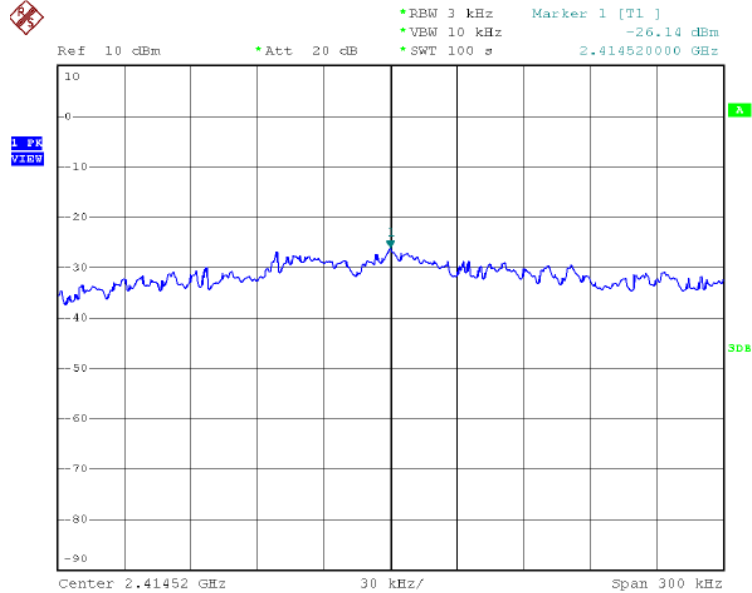

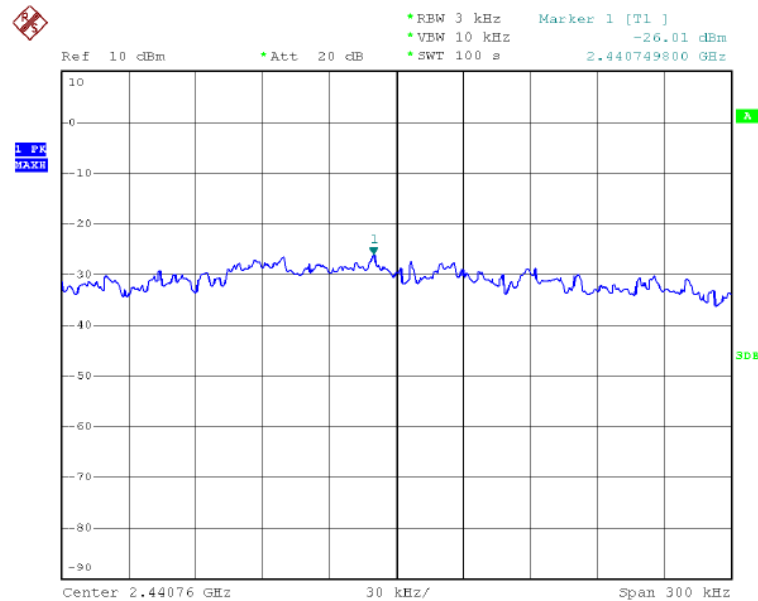


The EUT communicating with 802.11n Mode

Middle channel=2437MHz



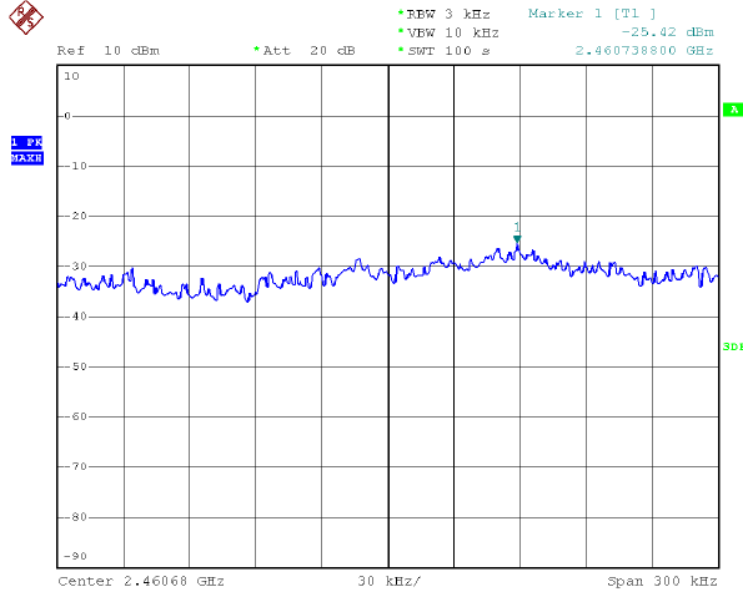
