
## BATTERY PACK CARE/CAUTIONS:


- If you do not plan to use the car for several days, remove the batteries from the transmitter and charger.

- Keep the package and owner's manual since it contains important information.




## How Mini car operation


Open the mini window cover and place the mini car on the charging stand as the secure position.

The charging LED will light up when the mini car is properly secured. Walt for around at 45 seconds. After charging done, the LED will off automatically. When fully charging, the mini car can operate in around 5 - 10 minutes (Depends on whether old on new battery to be installed in remote controller)







When found the mini car can't run in linear operation, user can make correction by turning the magnifier turner at the mini car bottom side.




## CARE:
