Predication of MPE limit at a given distance

 $S = PG/4\pi R^2 = power density (in appropriate units, e.g. mW/cm^2);$ 

P = power input to the antenna (in appropriate units, e.g., mW);

G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor, is normally numeric gain;

R = distance to the center of radiation of the antenna (appropriate units, e.g., cm);

The maximum authorized indoor antenna gain is 3.0dBi, outdoor antenna gain is -2.0dBi.

**Result:** The device meet FCC MPE at 120 cm distance for outdoor antenna and 80cm for indoor antenna.
