GENERAL INFORMATION

Product Description for Equipment Under Test (EUT)

The *Hunter's Specialties, Inc.* 's product, model: *ICO-5502*, Revision: *Rev. 1* or the "EUT" as referred to in this report is a Attractor Remote Digital Caller which measures approximately 10.0cm L x 4.7cm W x 2.2cm H, rated input voltage: DC 12 V battery.

** The test data gathered are from production sample, serial number: 0602029, provided by the manufacturer, we receive the EUT on 2006-2-23.*

Objective

This document is a test report based on the Electromagnetic Interference (EMI) tests performed on the EUT. The EMI measurements were performed according to the measurement procedure described in ANSI C63.4 - 2003.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, and section 15.203,15.205,15.209 and 15.231 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4 - 2003, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz. All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratory, Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Test Facility

The Test site used by Bay Area Compliance Lab Corp. (ShenZhen) to collect radiated and conducted emission measurement data is located in the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone, ShenZhen, Guangdong 518038, P.R.China.

Test site at Bay Area Compliance Lab Corp. (ShenZhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on November 04, 2004. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2003.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 382179. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.

Additionally, Bay Area Compliance Lab Corp. (ShenZhen) is a National Institute of Standards and Technology (NIST) accredited laboratory, under the National Voluntary Laboratory Accredited Program (Lab Code 200707-0). 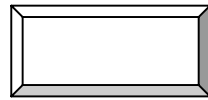

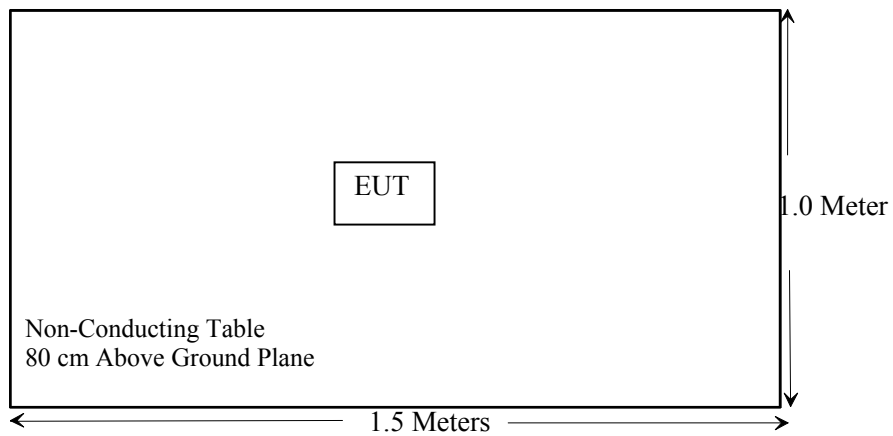

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

This product has a build on board antenna, fulfill the requirement of this section.

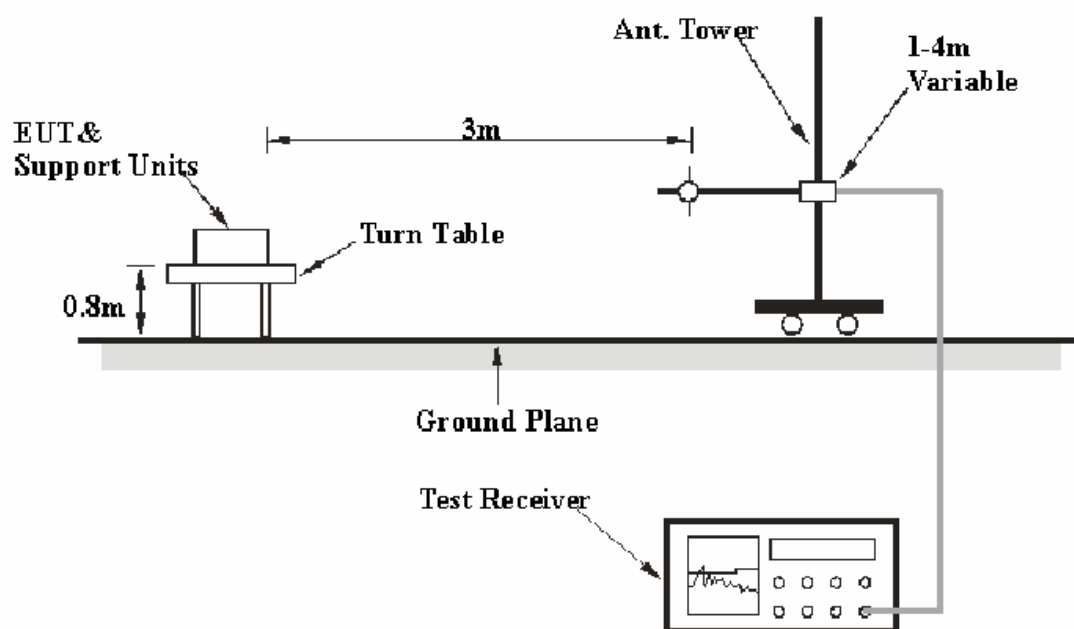

Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Lab Corp. (ShenZhen) is ± 4.0 dB.

EUT Setup



The radiated emission tests were performed in the 3 meters chamber B test site, using the setup accordance with the ANSI C63.4 - 2003. The specification used was the FCC § 15.209 and 15.231.

EMI Test Receiver Setup

The system was investigated from 30 MHz to 5 GHz.

During the radiated emission test, the EMI test receiver was set with the following configurations:

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Peak and Average detection mode.

The above field strength limits are specified at a distance of 3-meters the tighter limits apply at the band edges.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

$$\text{Corr. Ampl.} = \text{Meter Reading} + \text{Antenna Loss} + \text{Cable Loss} - \text{Amplifier Gain}$$

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of -5.8dB means the emission is 5.8dB below the limit for Class C. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Corr. Ampl.} - \text{Limit}$$

Test Results Summary

According to the data in the following table, the EUT complied with the FCC Part 15.209 and 15.231, with the worst margin reading of:

Low Frequency : -0.40 dB at 630.00 MHz in the Horizontal polarization.
High Frequency: -24.0 dB at 2205.00 MHz in the Vertical polarization.

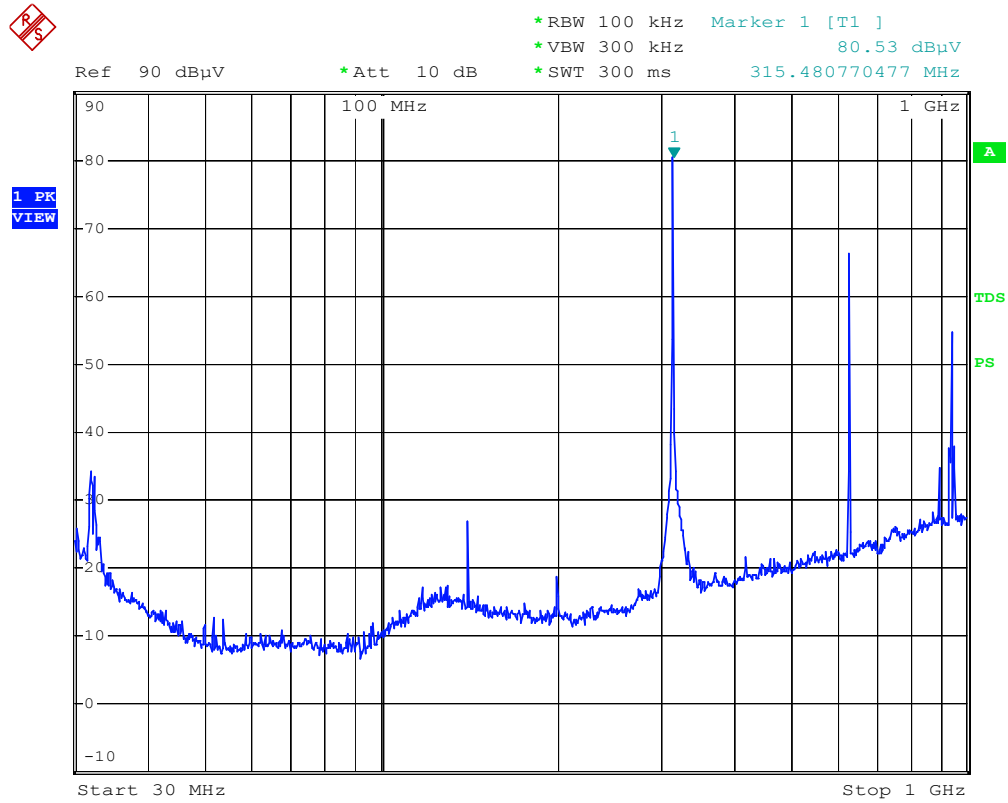

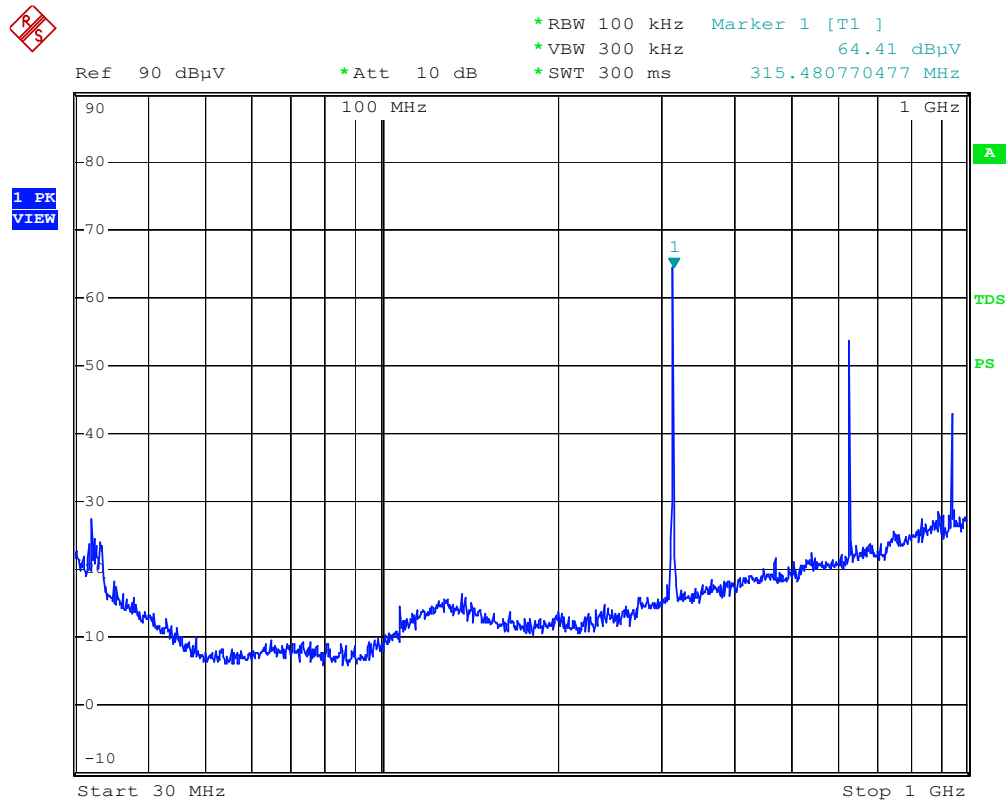

§15.231(c) 20dB BANDWIDTH TESTING

Requirement

Per 15.231(c) ,The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. Bandwidth is determined at the points 20 dB down from the modulated carrier.

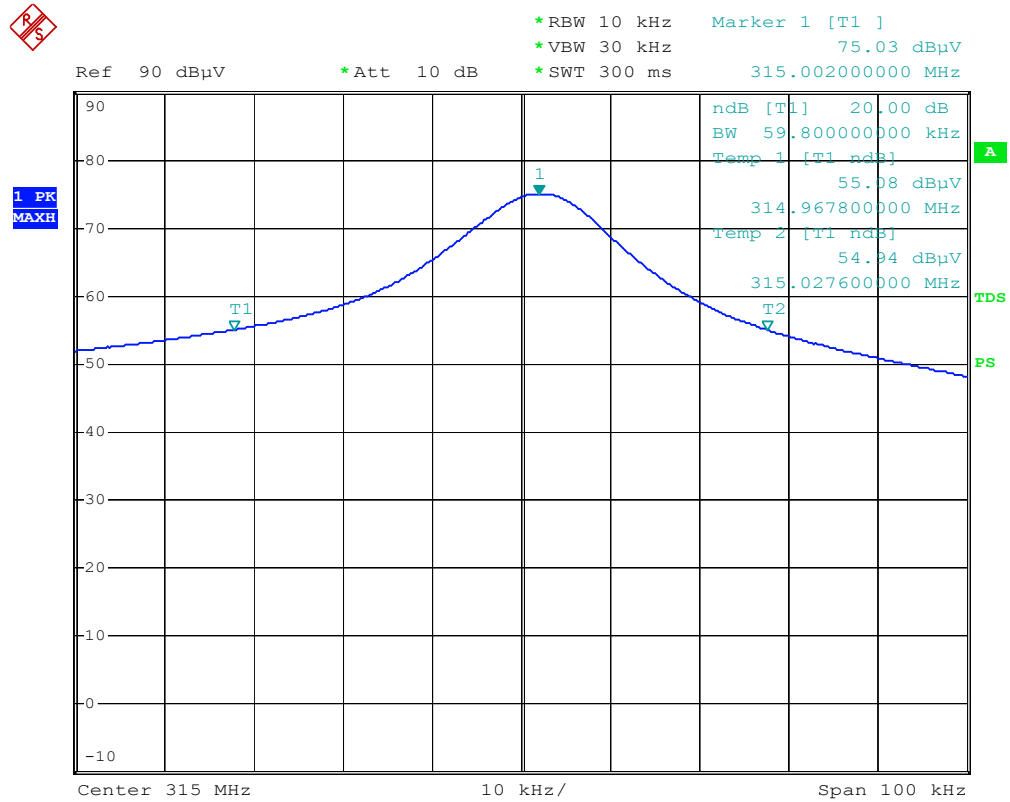

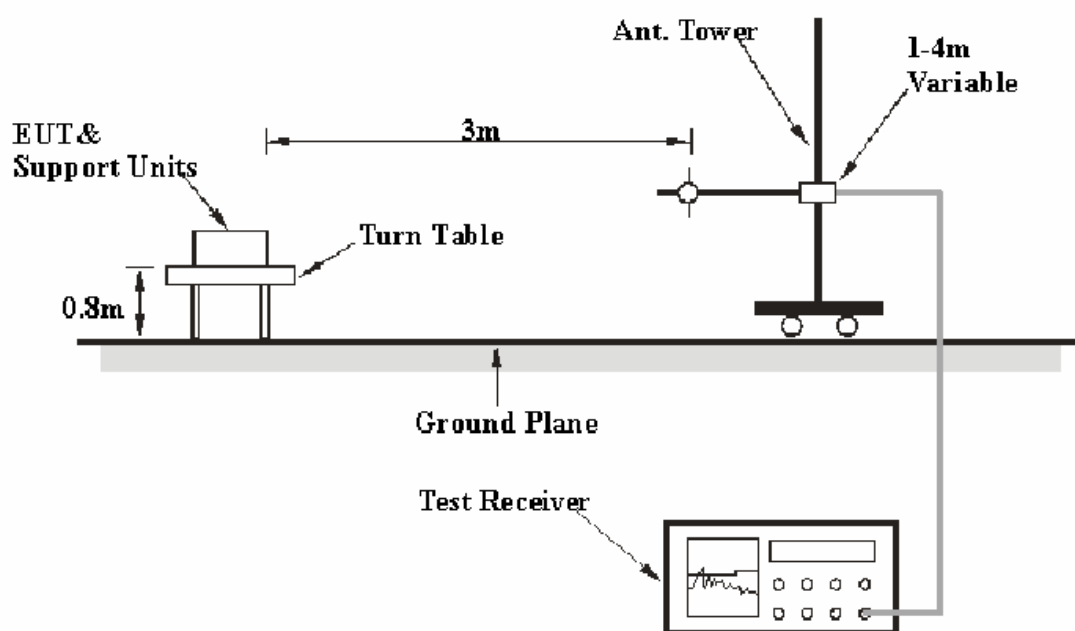

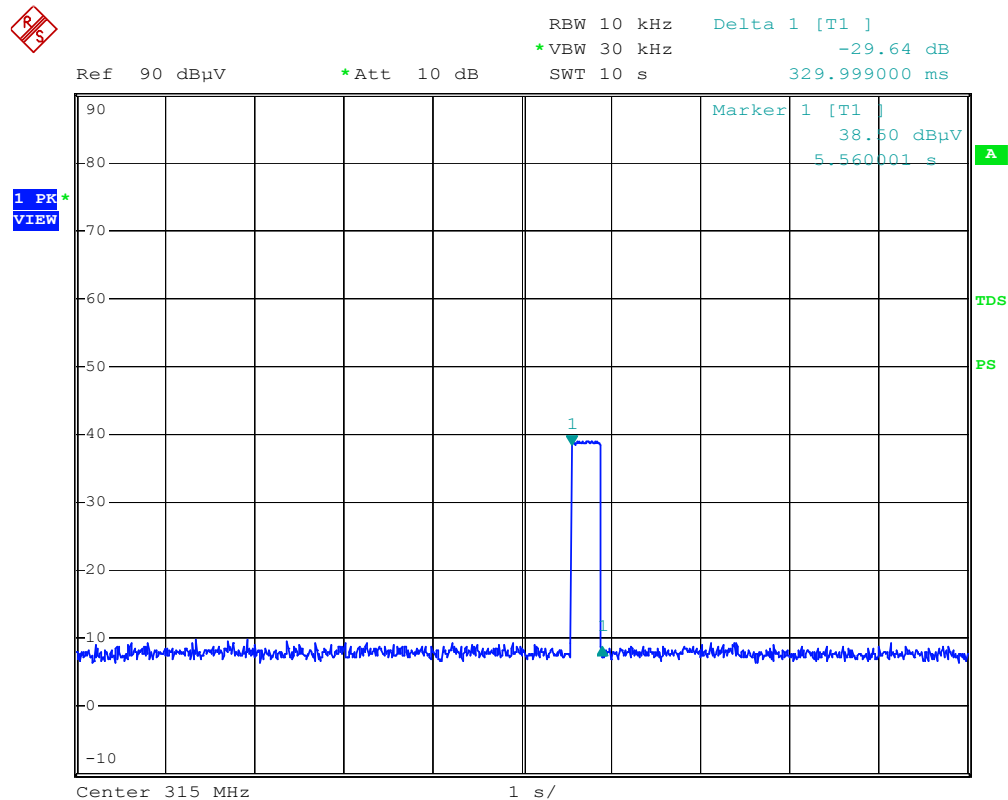
