USAGE OF THE DAE 3

The DAE unit is a delicate, high precision instrument and requires careful treatment by the user. There are no serviceable parts inside the DAE. Special attention shall be given to the following points:

Battery Exchange: The battery cover of the DAE3 unit is connected to a fragile 3-pin battery connector. Customer is responsible to apply outmost caution not to bend or damage the connector when changing batteries.

Shipping of the DAE: Before shipping the DAE to SPEAG for calibration the customer shall remove the batteries and pack the DAE in an antistatic bag. This antistatic bag shall then be packed into a larger box or container which protects the DAE from impacts transportation. The package shall be marked to indicate that a fragile instrument is inside.

E-Stop Failures: Touch detection may be malfunctioning due to broken magnets in the E-stop. Rough handling of the E-stop may lead to damage of these magnets. Touch and collision errors are often caused by dust and dirt accumulated in the E-stop. 



Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)





Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)


Receiving Pattern (ϕ), $\vartheta = 0^{\circ}$









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f = 900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)











Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f = 900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)



Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)





Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)








Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f = 900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)


1xRTT setting for Radio Configuration 1 with Service Option 55


