

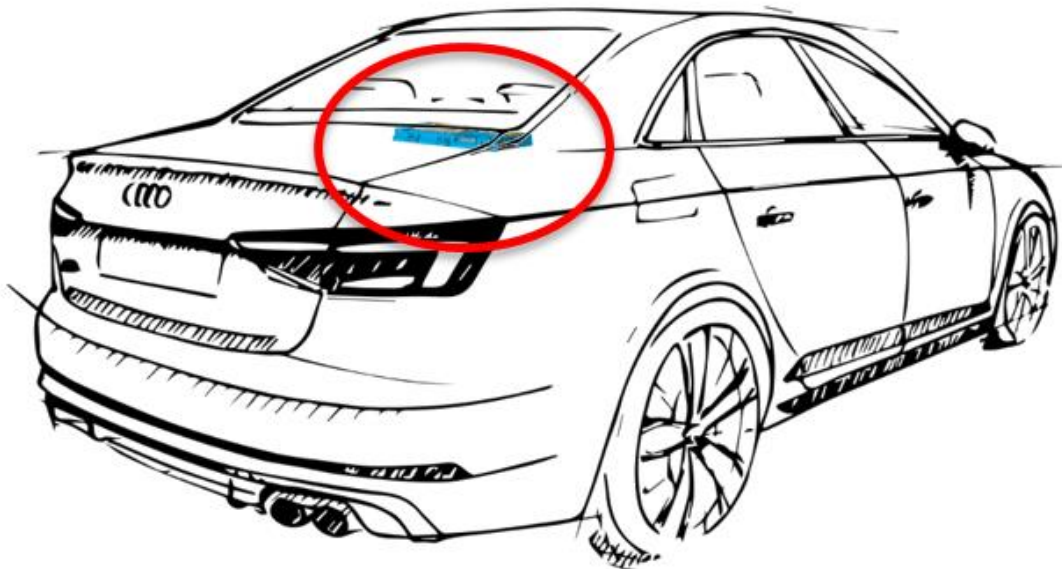
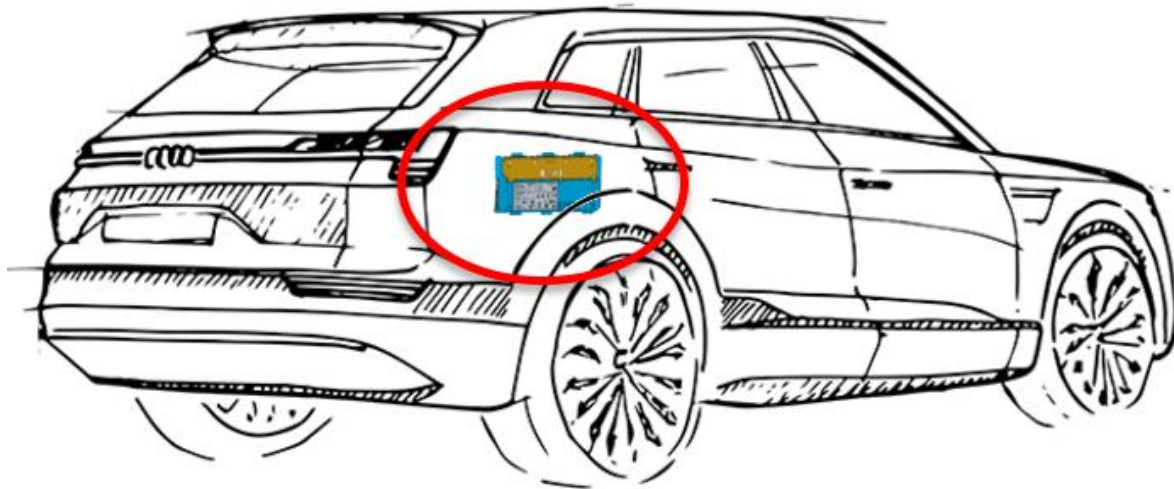

CONMOD is placed in the cars like in bellow pictures:

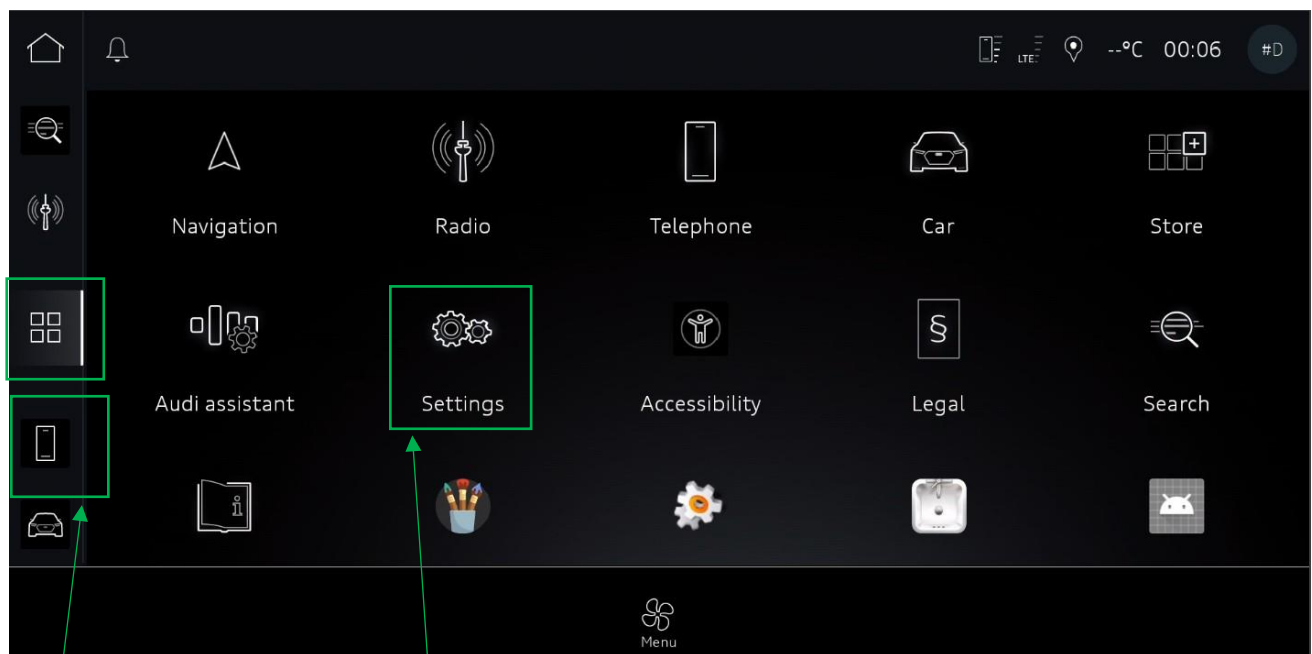


Description:

Included key technologies are 2G, 3G, LTE, 5G, WLAN, Bluetooth, GNSS receiver, depending on the model.

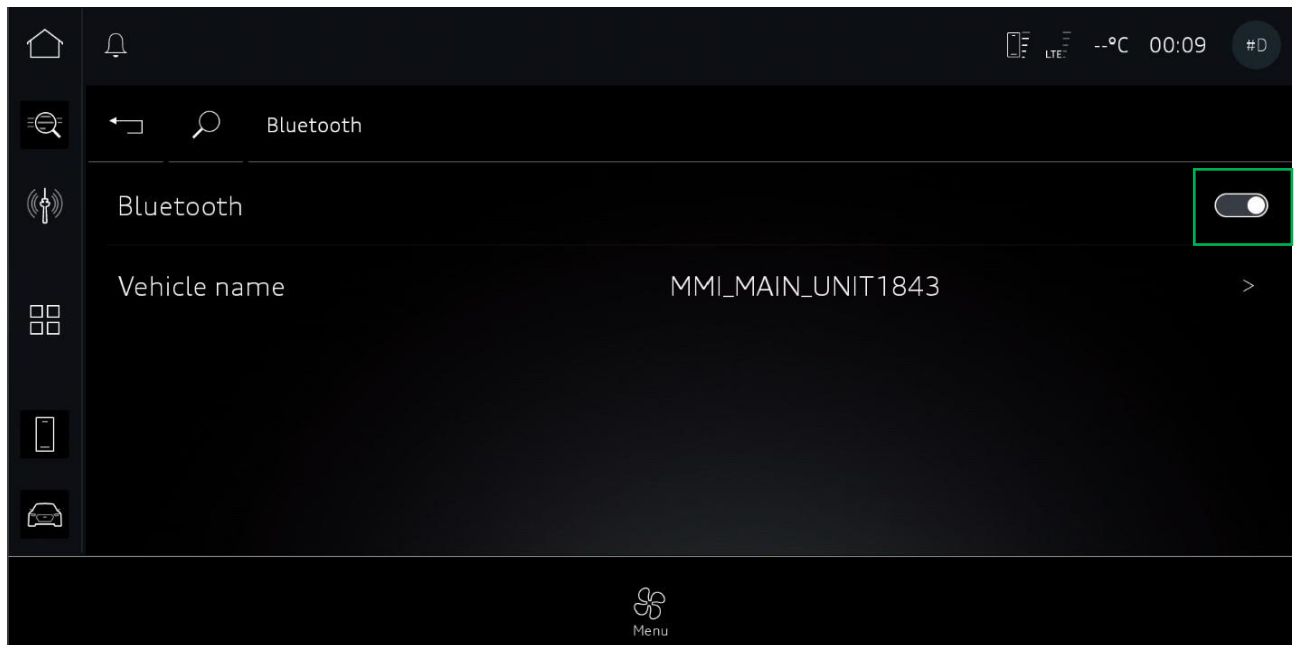
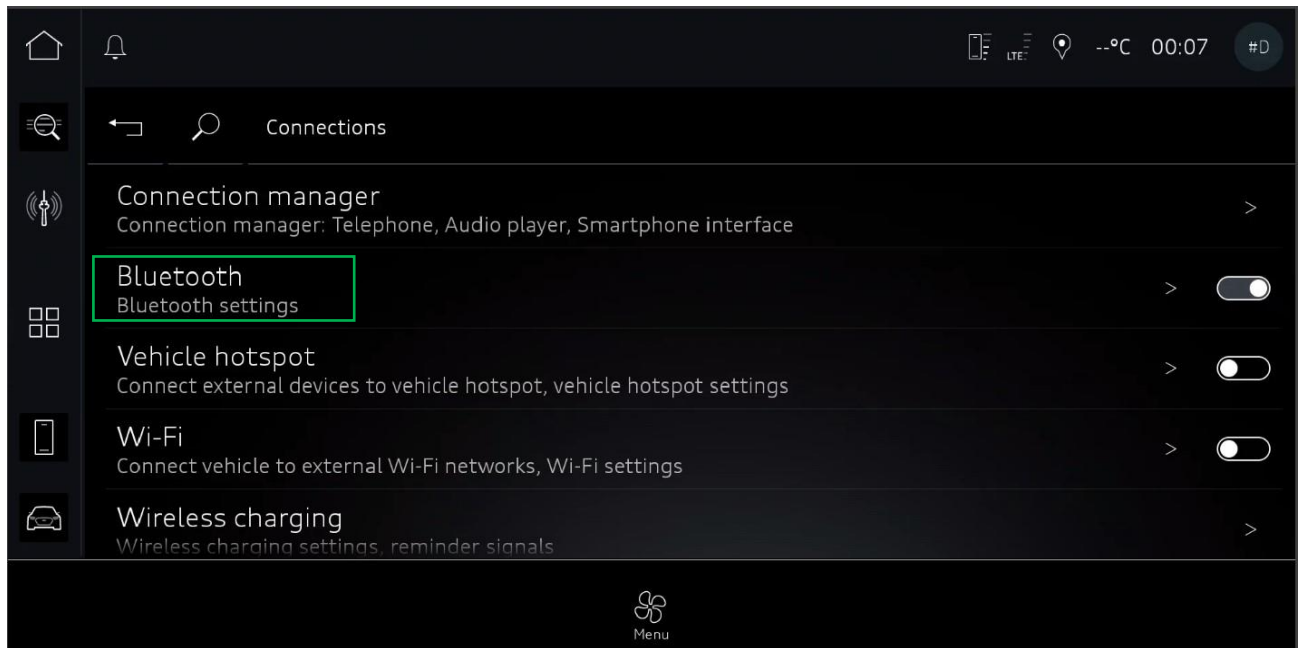
