


III Turning on/off headset


	How to act	Tones	Indicators
Turning on headset	Press and hold the Multi-function Button for approximately 3 seconds.	Turn-On melody	The Blue indicator light will flash while the power is on.
Turning off headset	Press and hold the Multi-function Button for approximately 7 seconds.	Turn-Off melody	The Blue indicator light will stop flashing after Red flashing.

IIII Wearing a headset

Bluetooth Headset can be worn on either ear, giving great comfort by the air-cushioned ear-piece that comes with the product.

To place the headset in your ear, please follow the simple instruction as provided.

A. Wearing on the right ear.



NOTE: Record voice tag from headset for better reception.

- *Last number dialing -Press the Multi-function button short. -You can hear connection melody when the connection is made.

Press the Multi-function button short or end a call with a keypad of the mobile phone

IIII Reject an incoming call

Press and hold multi-function button for 2 seconds and release button when you hear beep sound

IIII Answering a call

Press the Multi-function button short when you receive an incoming call.

Answer the call with your phone's keypad. You may then need to transfer the call to the headset by pressing and holding the Multi-function button.(for about 2 seconds)



IIII Transfer a call

If you want to transfer the call from headset to phone (or from phone to headset), press and hold the multi-function button for about 2 seconds until you hear beep.

IIII Call-Waiting (3way calling)

Before using 3 way calling with headset, make sure that a phone supports the Hands-free Profile. And it is always assumed under the condition that the service operator provides "call hold and/or multiparty" services through the mobile network.

Press and hold volume down(v) button until you hear short beep 3 times (approximately 5 seconds), then you can accept waiting call and release active call.

Press and hold volume up(A) button until you hear short beep 3 times (approximately 5 seconds), then you can accept waiting call and hold active call.

Standby Mode	Blue flashes 1 time every 7 second	
Active Mode/On call	Blue flashes 3 times every 5 second	
Charging	Red solid light	
Charging Complete	Red Light off	
Low Battery	Blue changes to Red	Double tones repeated 3 times every 28 second
Pairing Mode	Blue and Red flashing repeatedly	

IIII Multi-Point function

1. What is Multi-Point

- What is Multi-Point
 You can connect your headset to 2 bluetooth devices. And you are able to use them simultaneously.
 Control 2 bluetooth devices with 1 headset.
 You can identify which mobile is ringing with different melody (Note: Multipoint connection cannot be worked some mobile phone.
