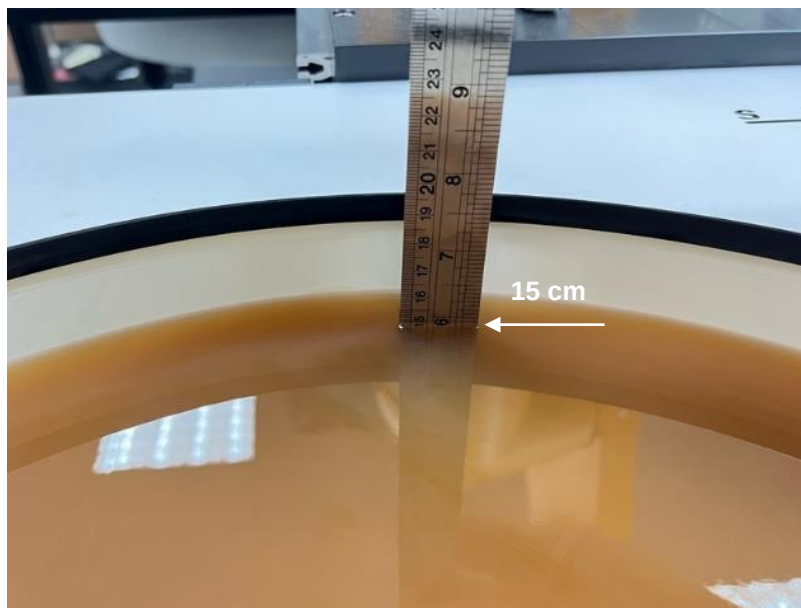


Fig.2 Photograph of the tissue simulant fluid liquid depth

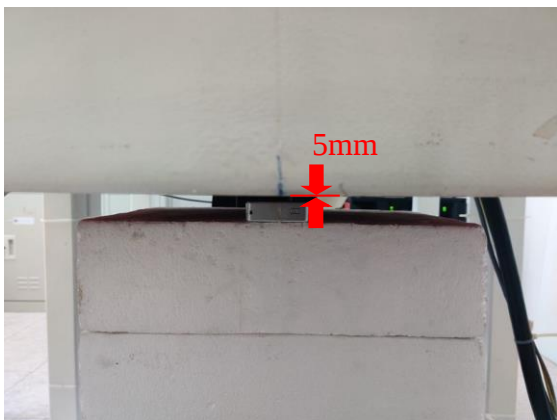

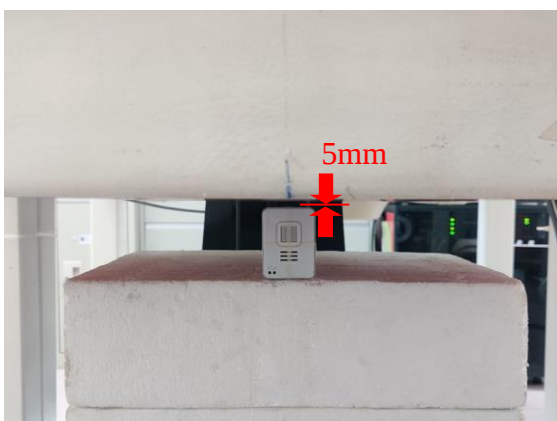
Photograph 2. Body, Front Surface, 5mm



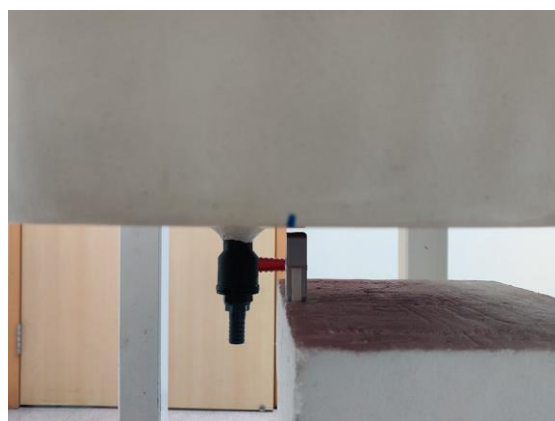
Photograph 3. Body, Back Surface, 5mm

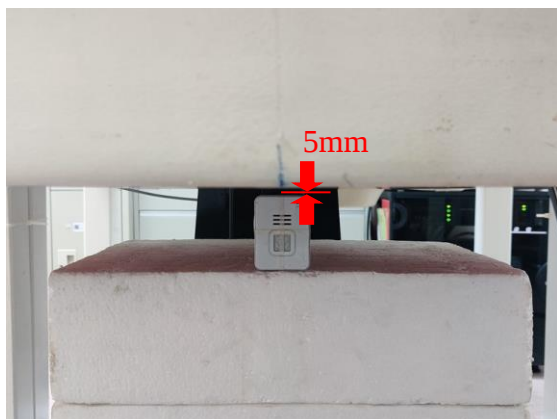
Photograph 5. Body, Top Edge, 5mm

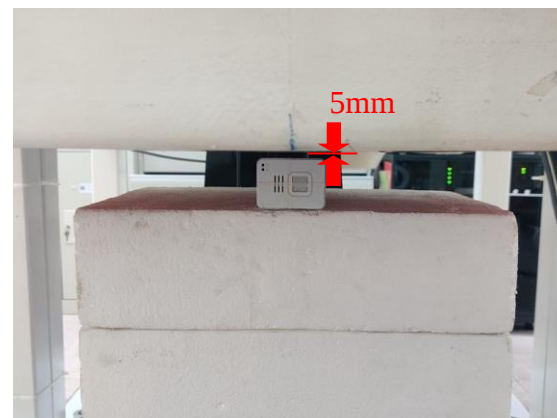

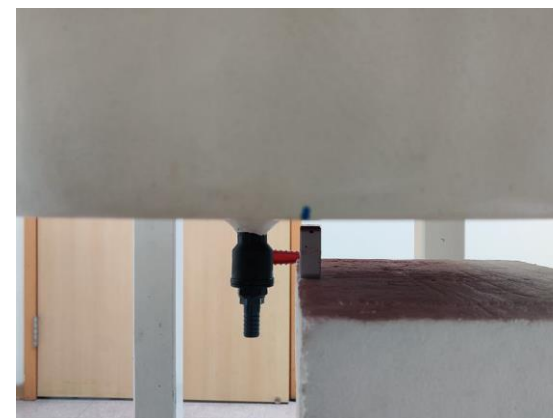

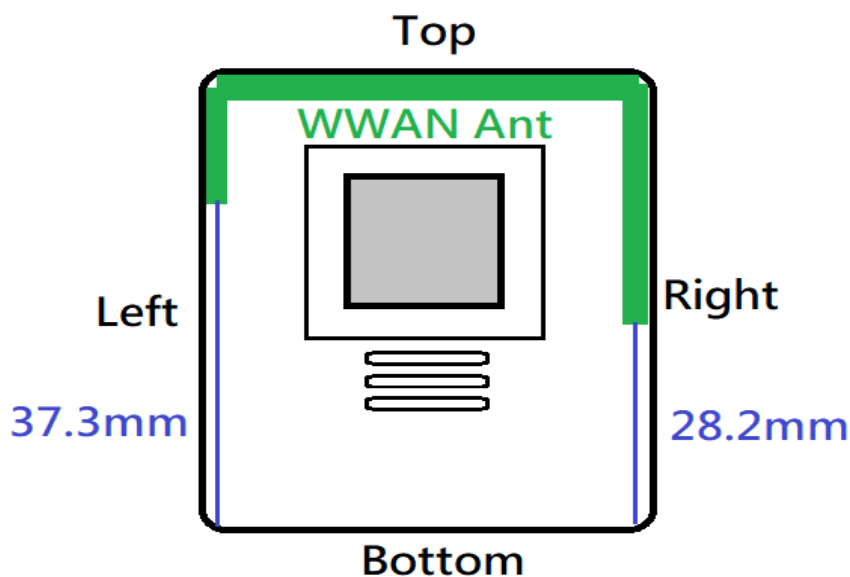
Photograph 13. Front view of EUT
