2) User manual RF exposure body-worn instructions are not consistent with OET 65 Suppl. C, i.e., more details are needed about whatever separation distance is applicable for accessories not designated for or furnished with the product

<Response> Page 10 of user manual has been revised to include following warning message:

“This phone has been tested and meets the FCC RF exposure requirements when used with those supplied accessories designed for this product. Third-party belt-clips, holsters, and similar accessories, if used, should not contain any metallic components and **must keep at least 14mm from your body** as the original supplied accessory. Body-worn accessories that ...”

3) User manual mentions Bluetooth (WPAN) is optional - please note this FCC ID TQ2-SC600PDT-BWG is applicable only for products containing all three transmitters (WPAN, WLAN, WWAN). Please explain Certification status for "depopulated" products, e.g., versions containing only WLAN + WWAN, etc., and/or submit separate FCC ID applications for such other versions if appropriate.

<Response> this is typo. Both Bluetooth and WLAN are default to the product and will be shipped with product. Wording “optional” has been removed from manual. Please refer to Page 7 and 16 or revised user manual.

4) Perhaps due to display scaling issues, filing seems unclear whether both "long" and "short" models have same display-screen size or not - please explain

<Response> both long and short models have same LCD size. The difference is due to the different scaling factor during the photo taking. Please refer to uploaded photo “LCD

size comparison between two models.pdf” which has both units sit side by side to show the actual relevant size.

5) Please describe whether device has built-in speaker and microphone functions to support held-to-ear voice-mode operations (eg "1.5W speaker")

<Response> No, this product doesn't have built-in speaker and microphone. The only way to use phone function is use supplied external earphone/Microphone. Please refer to user manual page 49 for related info.
