 **This device needs to be upgraded to RouterOS v6.47.2 or the latest version to ensure compliance with local authority regulations!**

This Device accepts input of a 24V DC power adapter, together with PoE Injector, which is provided in the original packaging of this device.

First steps:

- Connect the device to the included PoE injector with Ethernet cable;
- Connect the PoE injector into the computer;
- Connect the power adapter to the PoE injector;
- Download WinBox configuration tool <https://mt.lv/winbox>;
- Default IP: 0.0.0.0, user name: *admin* and there is no password, or use the Neighbors tab and connect through MAC address;
- Once connected configure the device, so it has an active Internet connection <https://mt.lv/configuration>;
- Upgrade the RouterOS software to the latest version <https://mt.lv/upgrade>;
- In the "QuickSet, CPE" menu set up the following: Choose your country, to apply country regulation settings;
- Set the antenna gain, depending on the antenna used;
- Set up your router password in the bottom field.
