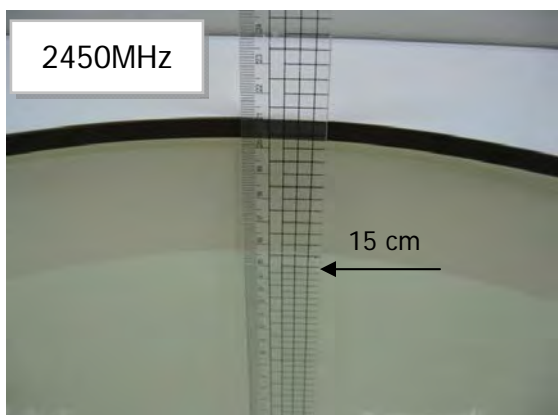

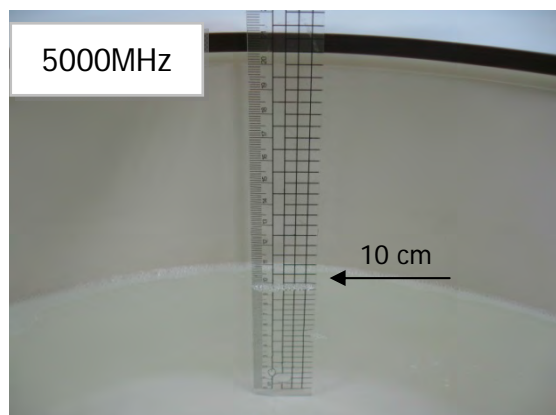

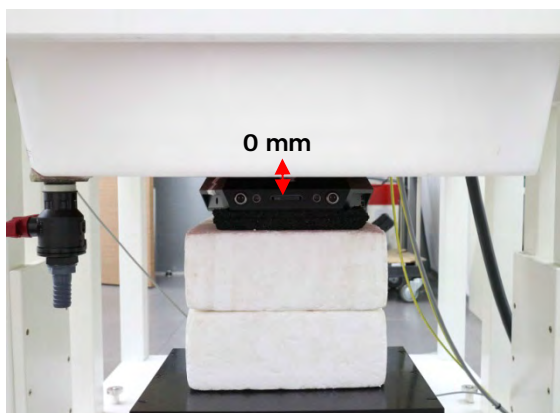


Fig.3 EUT position(1) to flat phantom

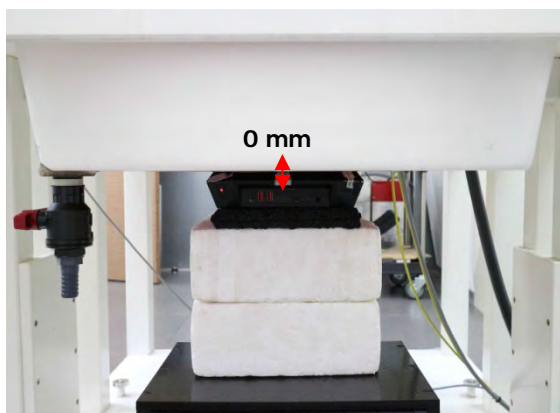


Fig.6 EUT position(2) to flat phantom

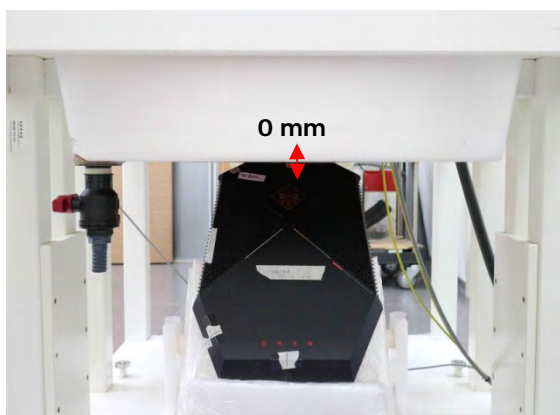


Fig.7 EUT position(2-2) to flat phantom

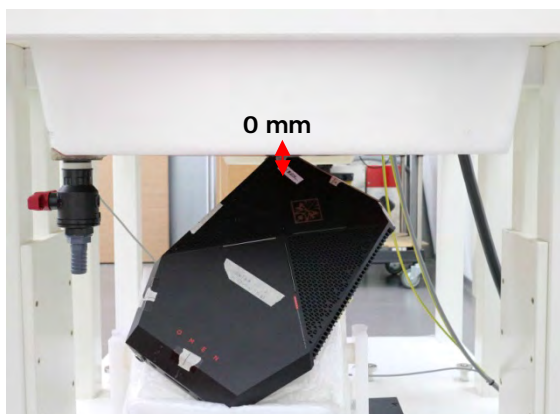


Fig.8 EUT position(2-3) to flat phantom

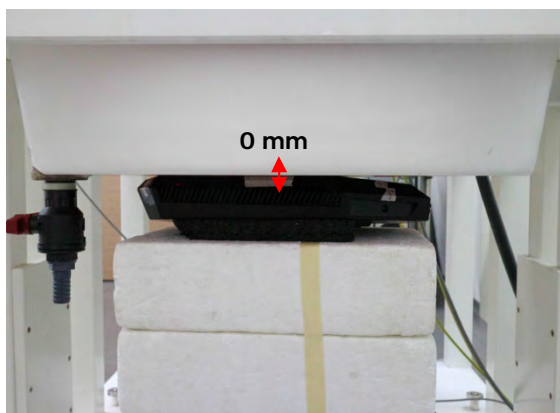


Fig.9 EUT position(2-4) to flat phantom

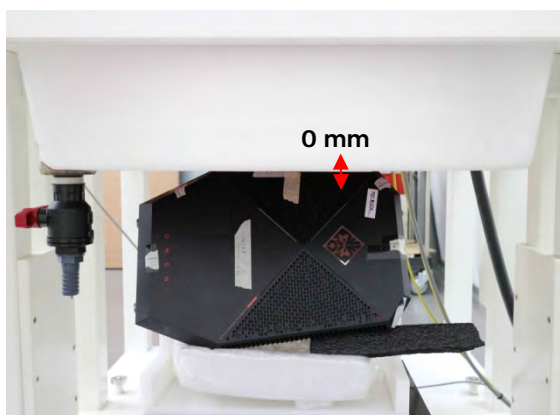


Fig.10 EUT position(2-5) to flat phantom

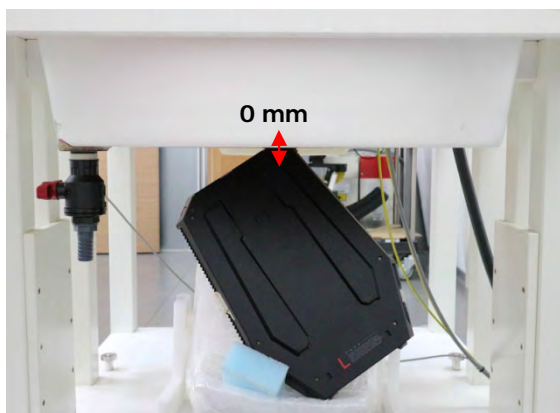


Fig.12 EUT position(2-7) to flat phantom

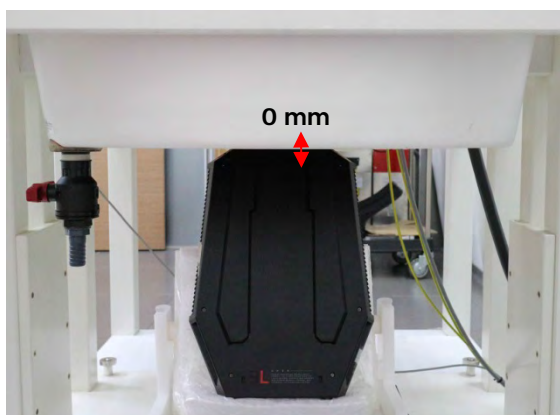


Fig.14 EUT position(3-1) to flat phantom

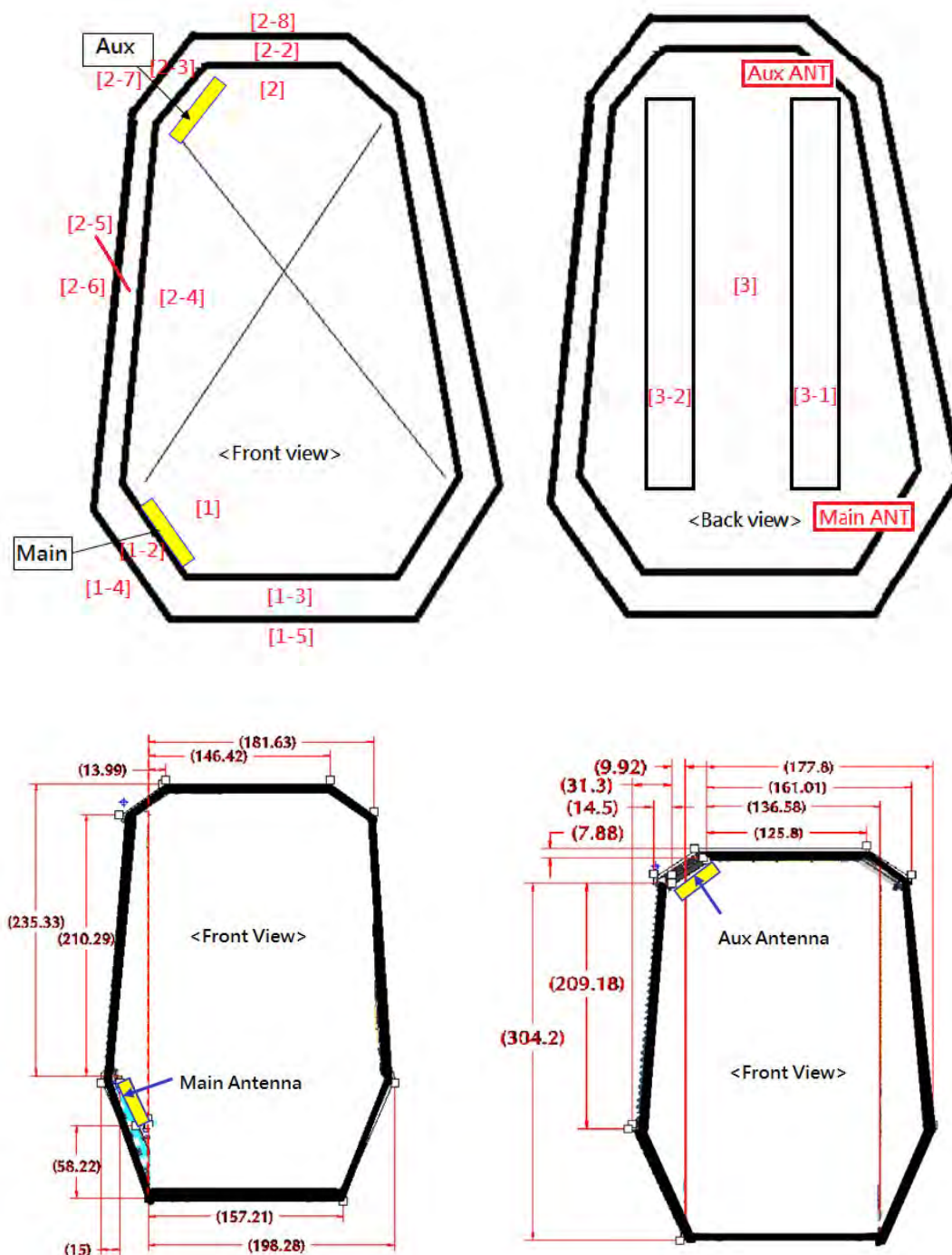


Fig.17 Antenna position of EUT

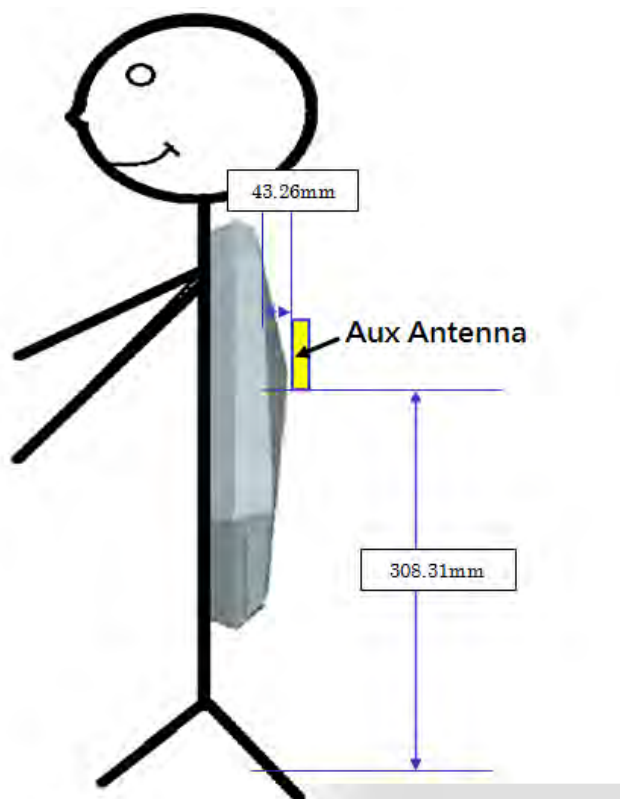


Fig.18 Antenna position of EUT
