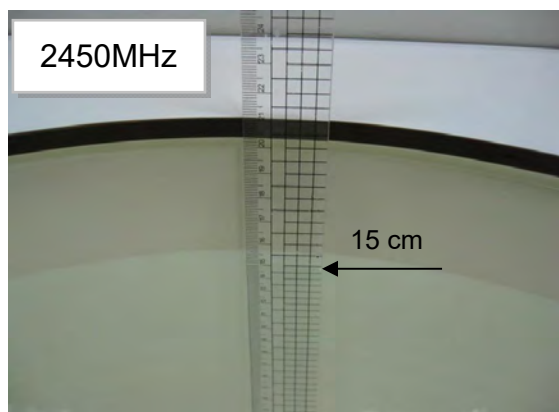

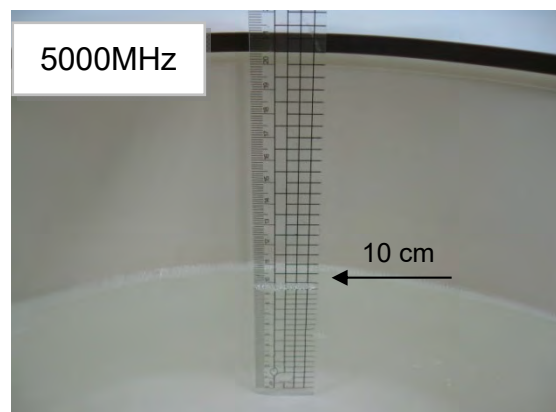

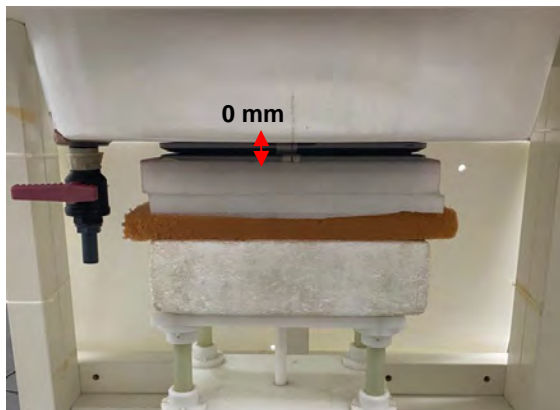

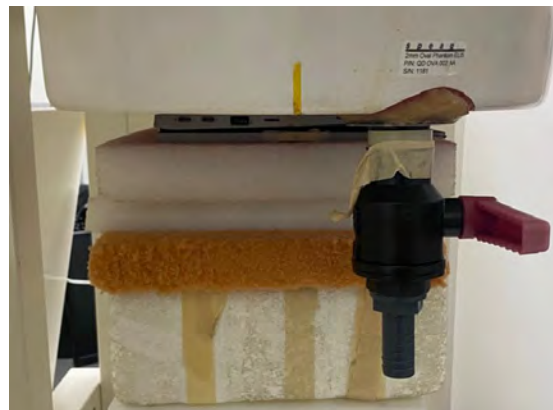

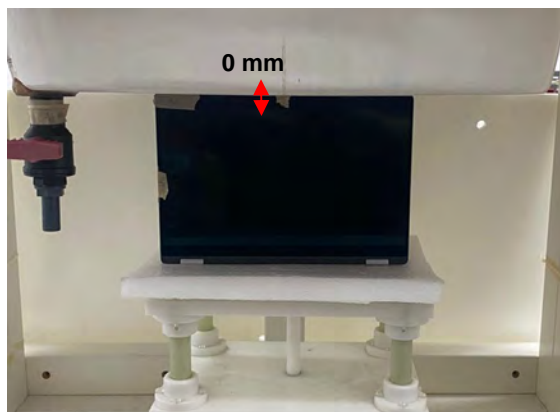

**Photograph 1. Body, Back Surface, 0mm**



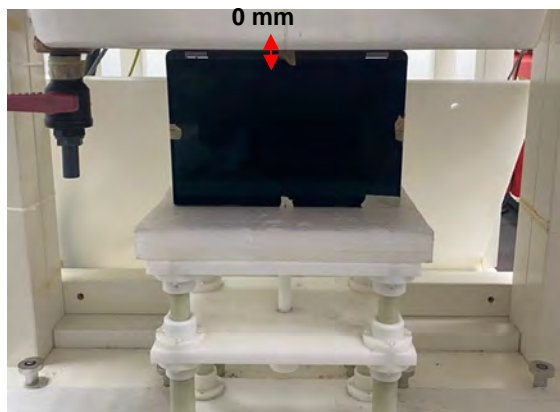
**Photograph 2. Body, Back Surface, 0mm**

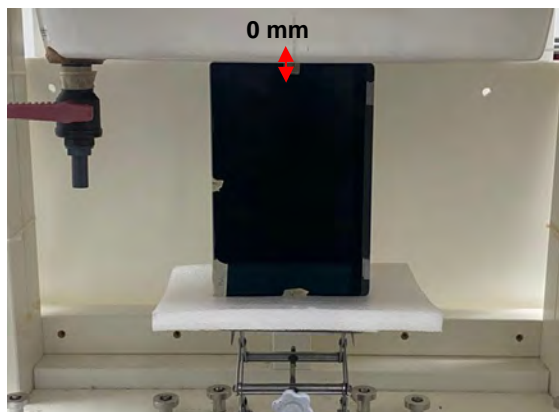

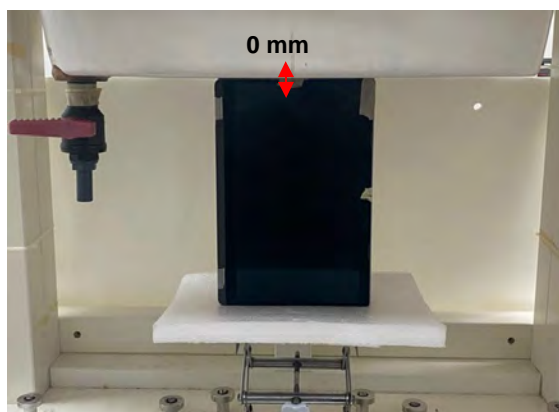

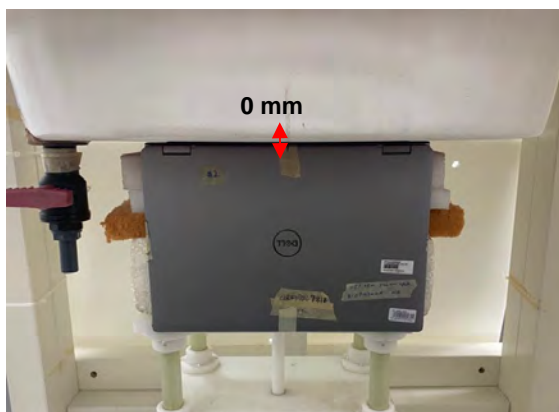
**Photograph 8. Body, Right Edge, 0mm**

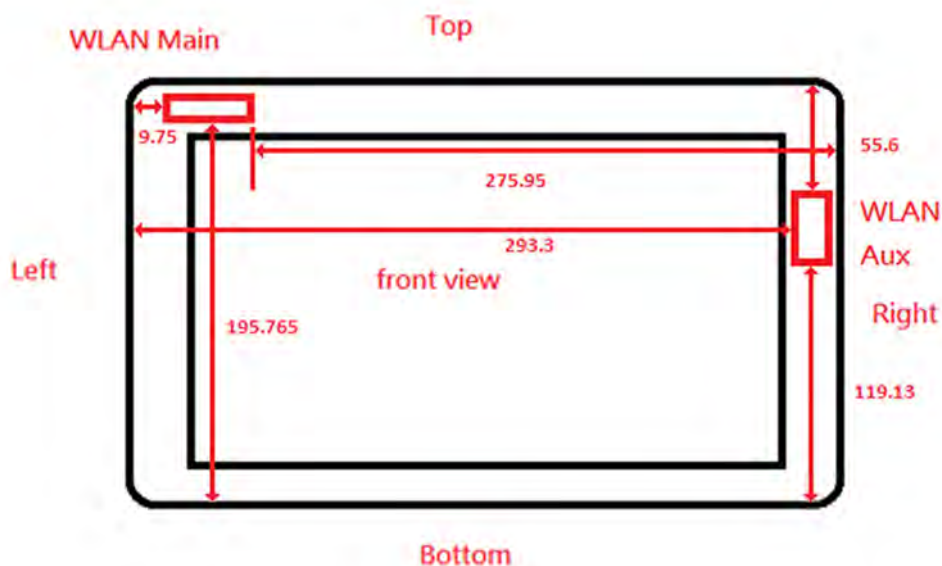
Photograph 13. Front view of EUT



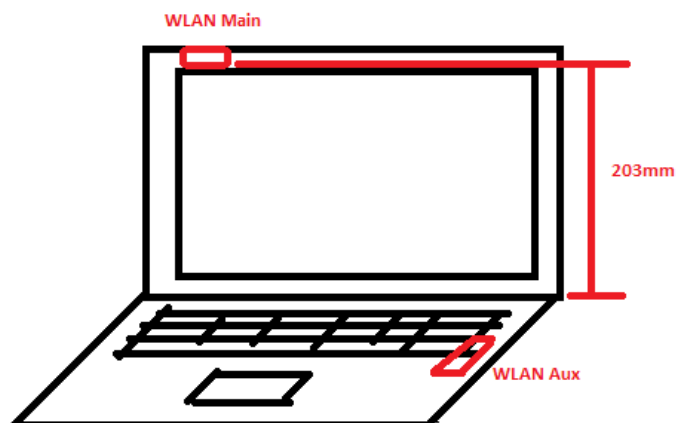
Photograph 14. Back view of EUT
