2.6 Transmit Power Control (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an e.i.r.p. of less than 500 mW.

The EUT can adjust a transmitter's output power based on the signal level present at the receiver. TPC is auto controlled by software.

2.7 Statement of Manufacturer

Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.

Three subsets of trials will be performed with a minimum of ten trials per subset. The subset of trials differ in where the Long Pulse Type 5 Signal is tuned in frequency.

- a) the Channel center frequency
- b) tuned frequencies such that 90% of the Long Pulse Type 5 frequency modulation is within the low edge of the EUT Occupied Bandwidth
- c) tuned frequencies such that 90% of the Long Pulse Type 5 frequency modulation is within the high edge of the EUT Occupied Bandwidth

It include 10 trials for every subset, the formula as below,

For subset case 1: the center frequency of the signal generator will remain fixed at the center of the EUT Channel.

For subset case 2: to retain 90% frequency overlap between the radar signal and the EUT Occupied Bandwidth, the center frequency of the signal generator will vary for each of the ten trials in subset case 2. The center frequency of the signal generator for each trial is calculated by:

$$FL + (0.4 * \text{Chirp Width [in MHz]})$$

For subset case 3: to retain 90% frequency overlap between the radar signal and the EUT Occupied Bandwidth, the center frequency of the signal generator will vary for each of the ten trials in subset case 3. The center frequency of the signal generator for each trial is calculated by:



5. Test Procedure

5.1 DFS Measurement System

A complete DFS Measurement System consists of Radar signal generate system to generating the radar waveforms in Table 10, 11 and 12. The traffic monitoring system is specified to the type of unit under test (EUT).

Channel Loading


System testing will be performed with channel-loading using means appropriate to the data types that are used by the unlicensed device. The following requirements apply:

a)	The data file must be of a type that is typical for the device (i.e., MPEG-2, MPEG-4, WAV, MP3, MP4, AVI, etc.) and must generally be transmitting in a streaming mode.	
b)	Software to ping the client is permitted to simulate data transfer but must have random ping intervals.	
c)	Timing plots are required with calculations demonstrating a minimum channel loading of approximately 17% or greater.	✓
d)	Unicast or Multicast protocols are preferable but other protocols may be used. The appropriate protocol used must be described in the test procedures.	

5.2 Calibration of DFS Detection Threshold Level

The measured channel is chosen from the operating channels of the EUT within the 5.25-5.35 GHz band and the 5.47-5.725 GHz and using the all bandwidth mode available for the link. The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The Master antenna gain is 2.97dBi and required detection threshold is -60.03 dBm (= -64 +1 +2.97). The calibrated conducted detection threshold level is set to -60.03 dBm.

Conducted Setup Configuration of Calibration of DFS Detection Threshold Level




This test was investigated for different bandwidth (20/40/80/160 MHz).

The Required detection threshold is -60.03 dBm (= -64 +1 +2.97).







Channel Closing Transmission Time & Channel Move Time @ CH114 - 5570MHz







Non - Occupancy Period @ CH114 - 5570MHz




6.2.4 Non-Associated Test


