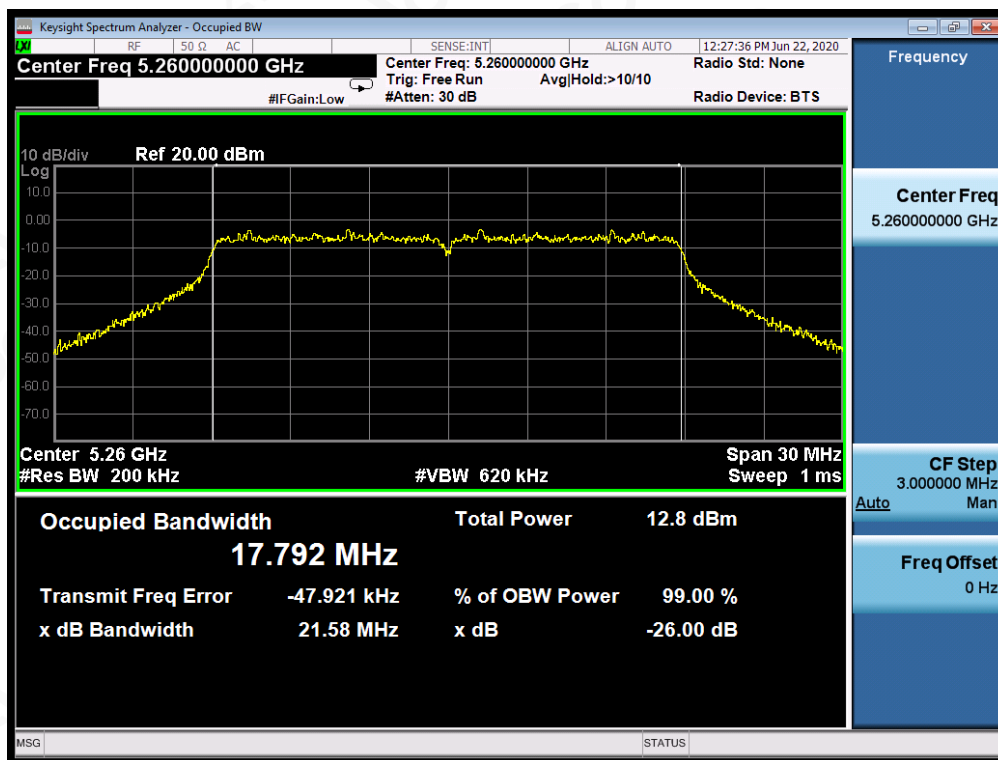
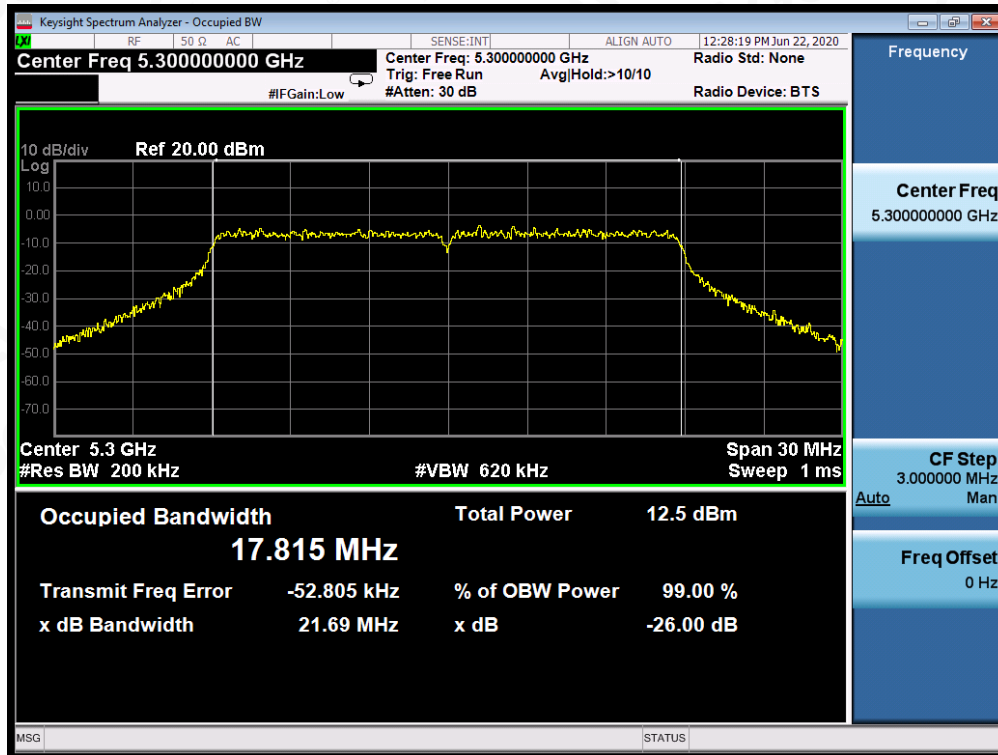


### TEST PLOT OF BANDWIDTH FOR 5260MHz



### TEST PLOT OF BANDWIDTH FOR 5300MHz

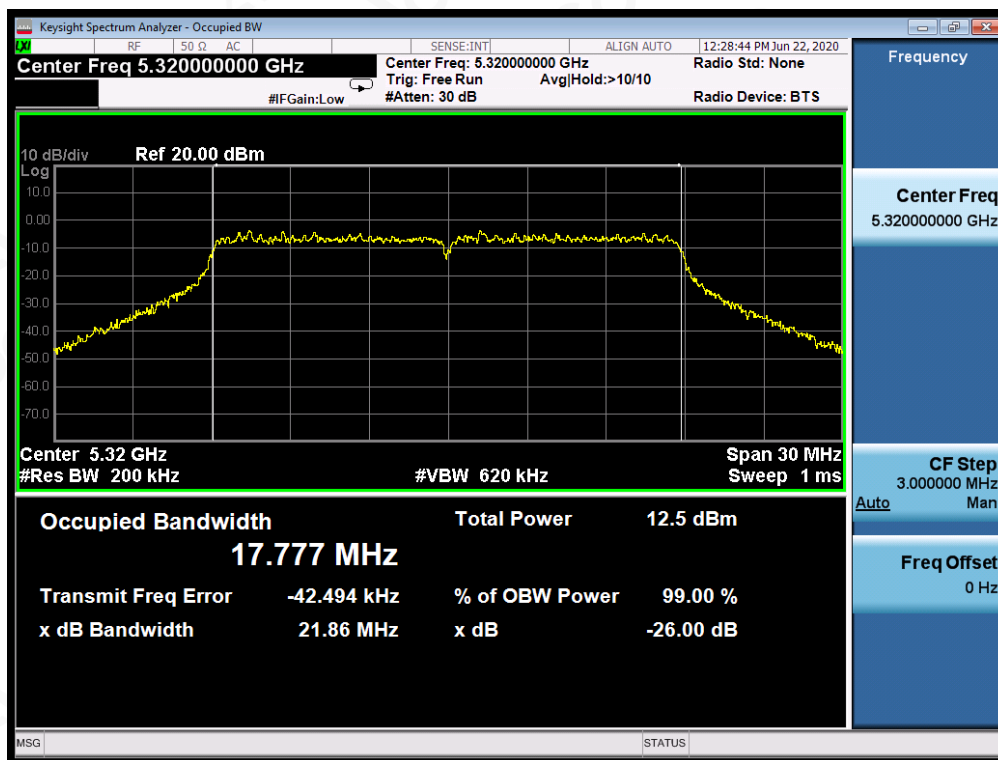

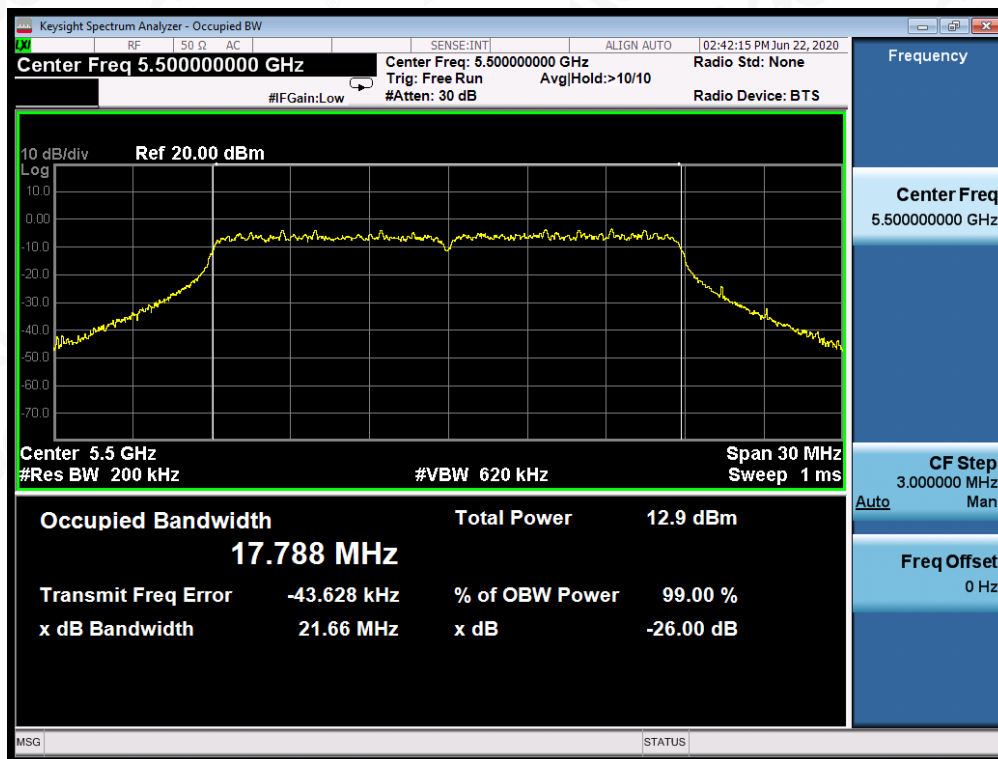

### TEST PLOT OF BANDWIDTH FOR 5500MHz

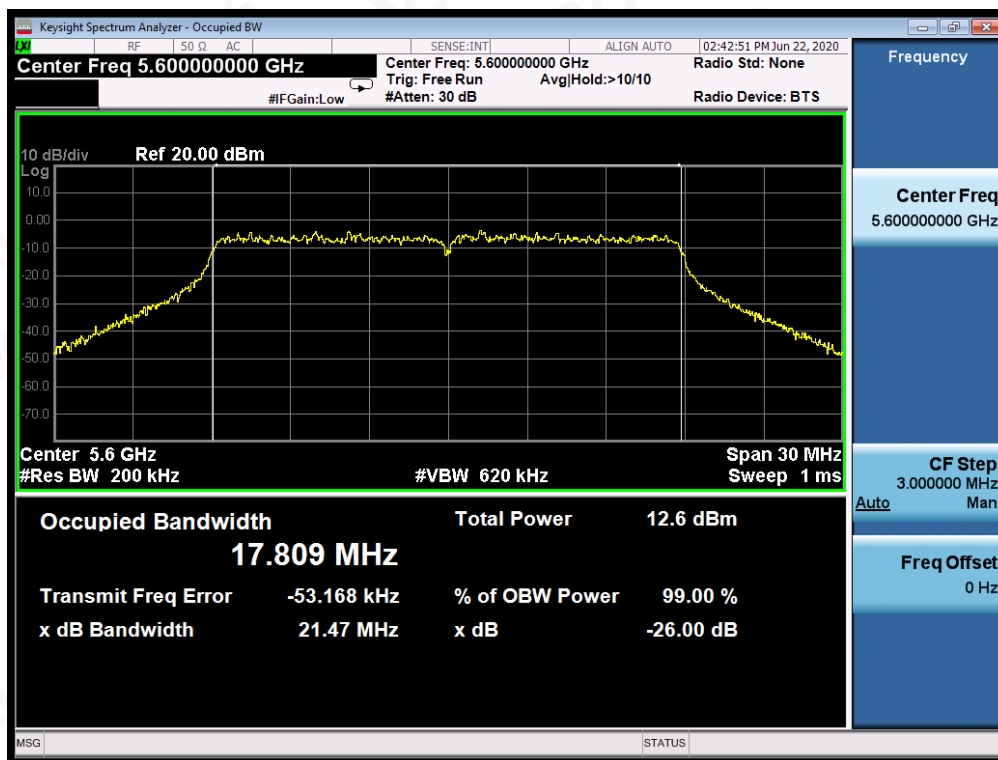

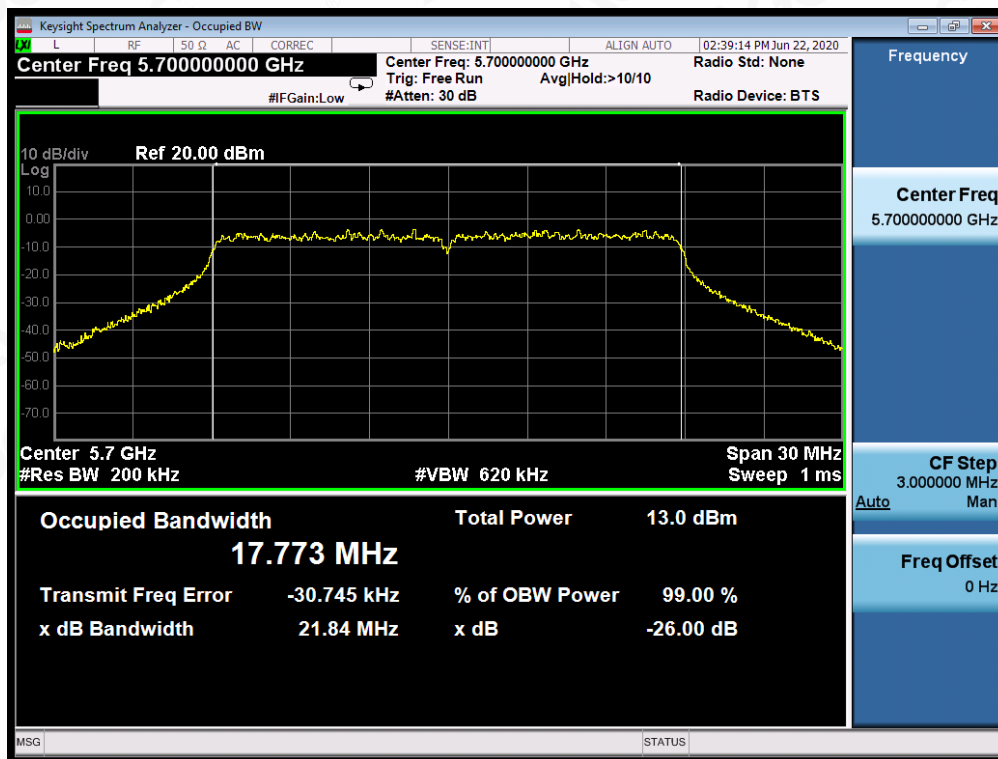

### TEST PLOT OF BANDWIDTH FOR 5700MHz



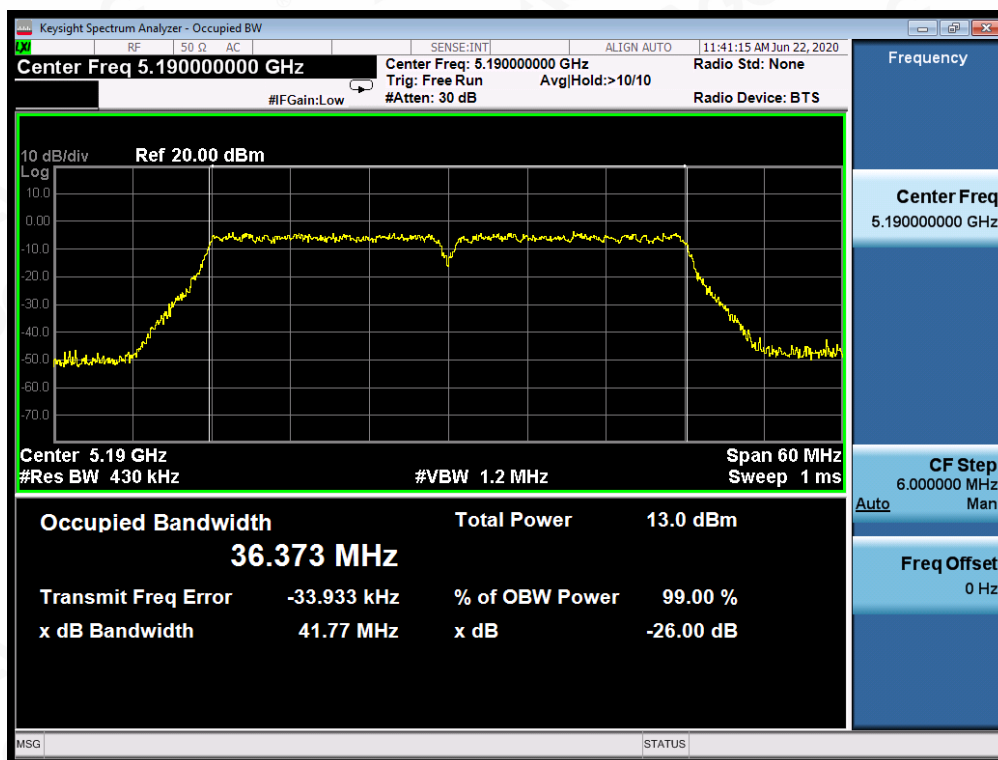

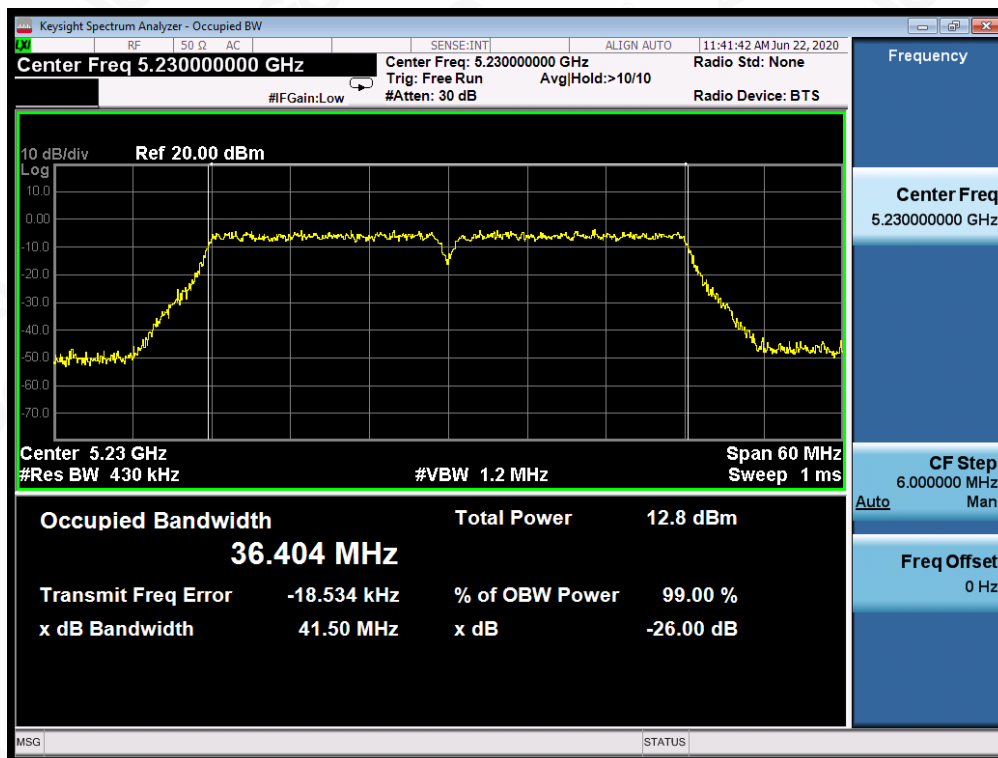

### TEST PLOT OF BANDWIDTH FOR 5230MHz



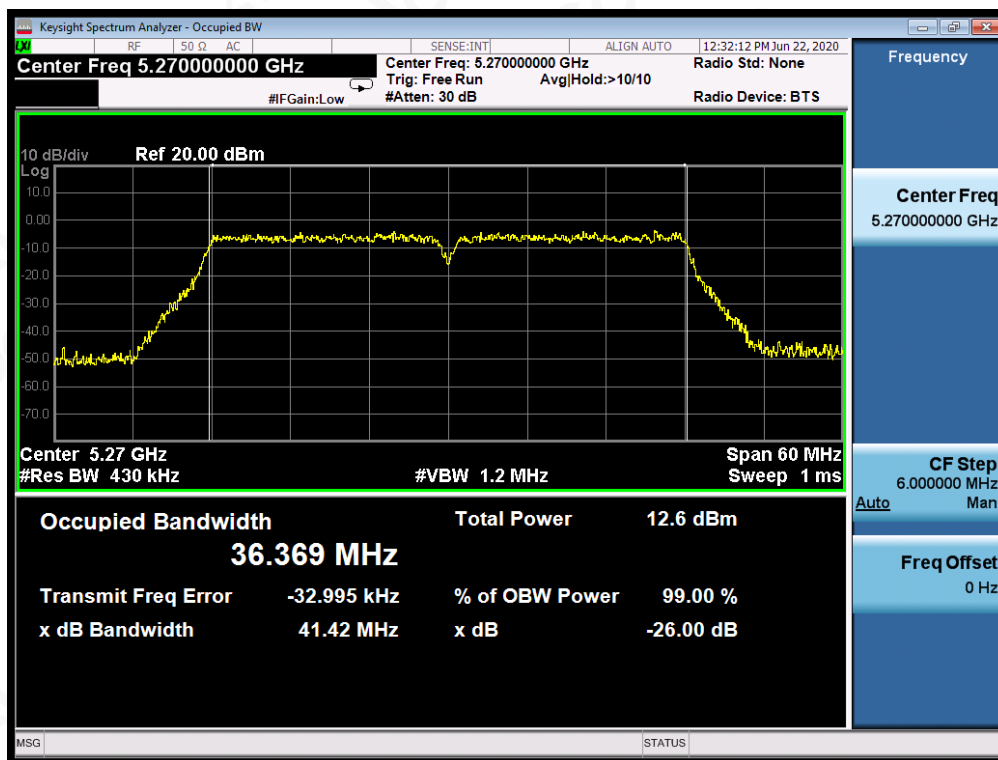

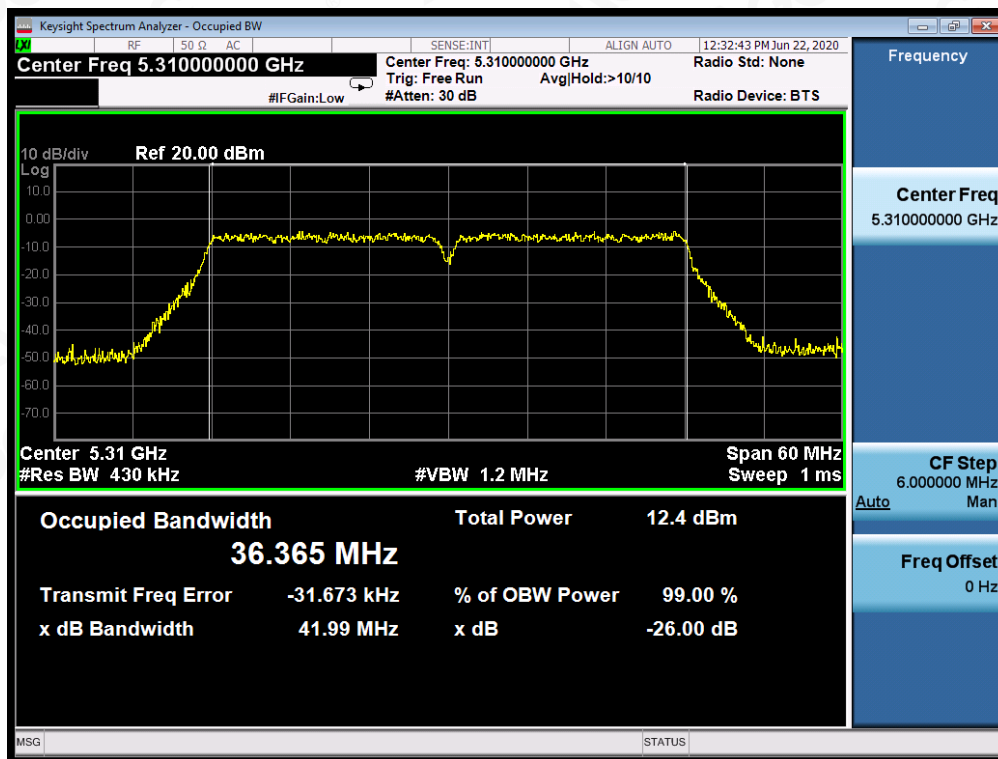




### TEST PLOT OF BANDWIDTH FOR 5270MHz



### TEST PLOT OF BANDWIDTH FOR 5310MHz

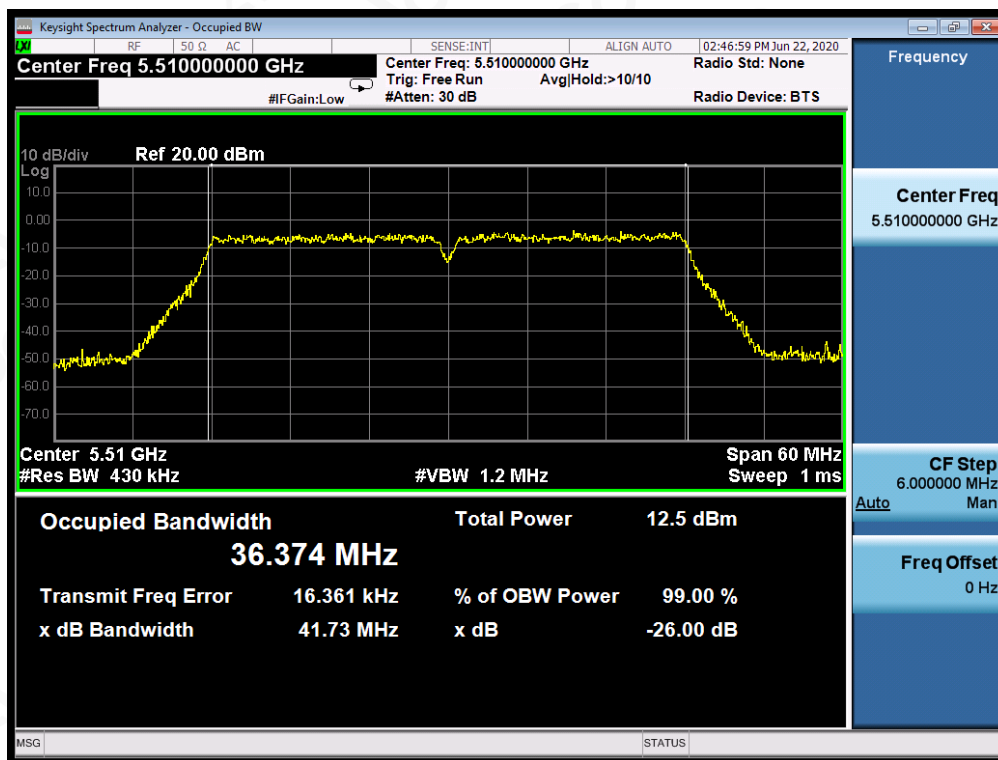

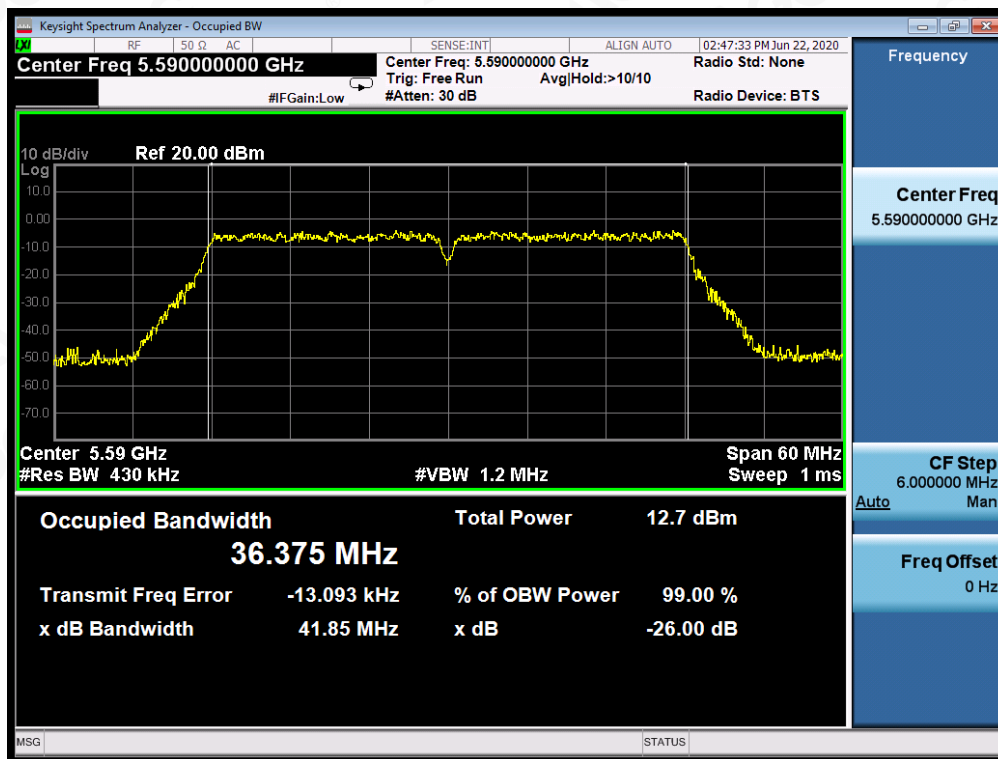

### TEST PLOT OF BANDWIDTH FOR 5590MHz

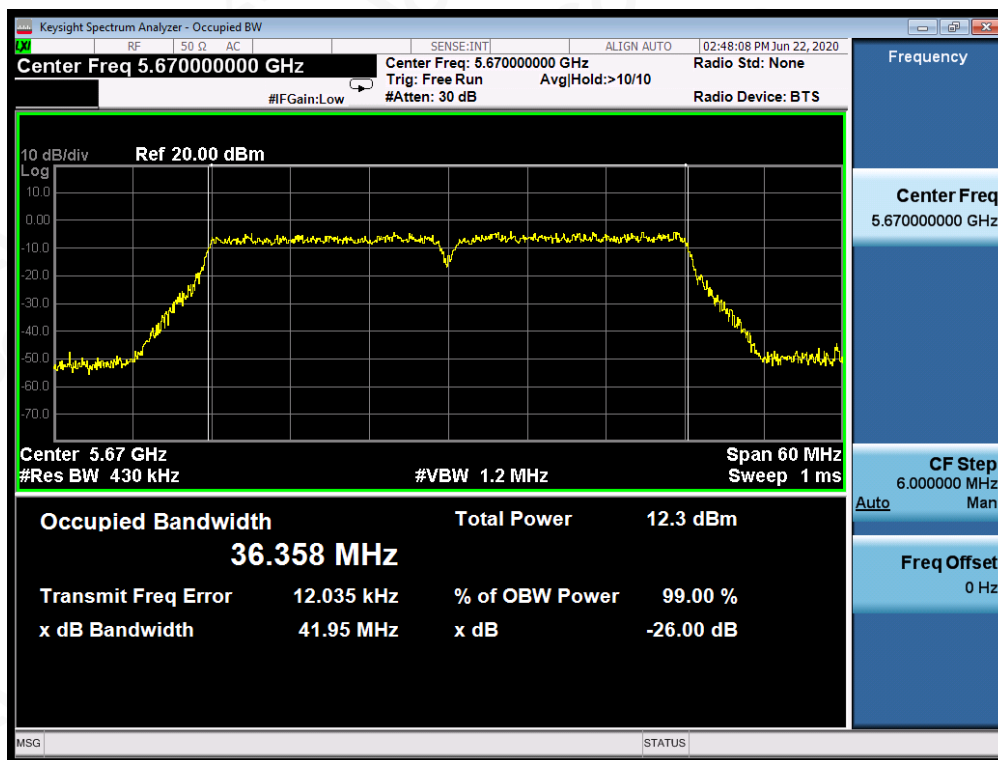

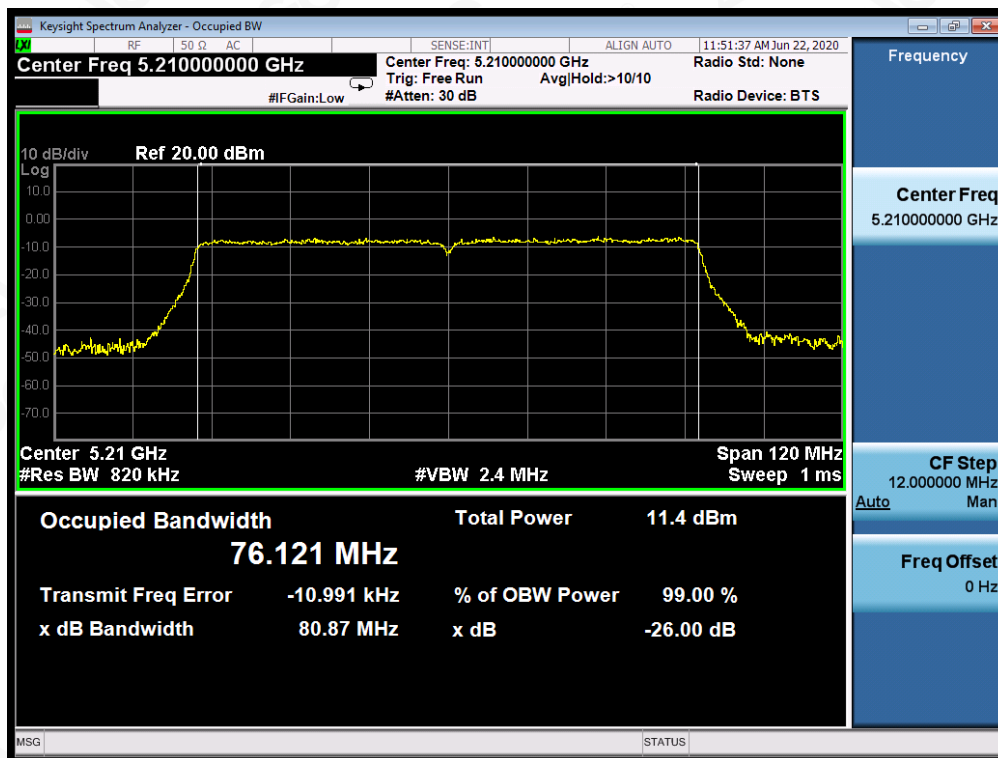


### TEST PLOT OF BANDWIDTH FOR 5670MHz

### TEST PLOT OF BANDWIDTH FOR 5210MHz

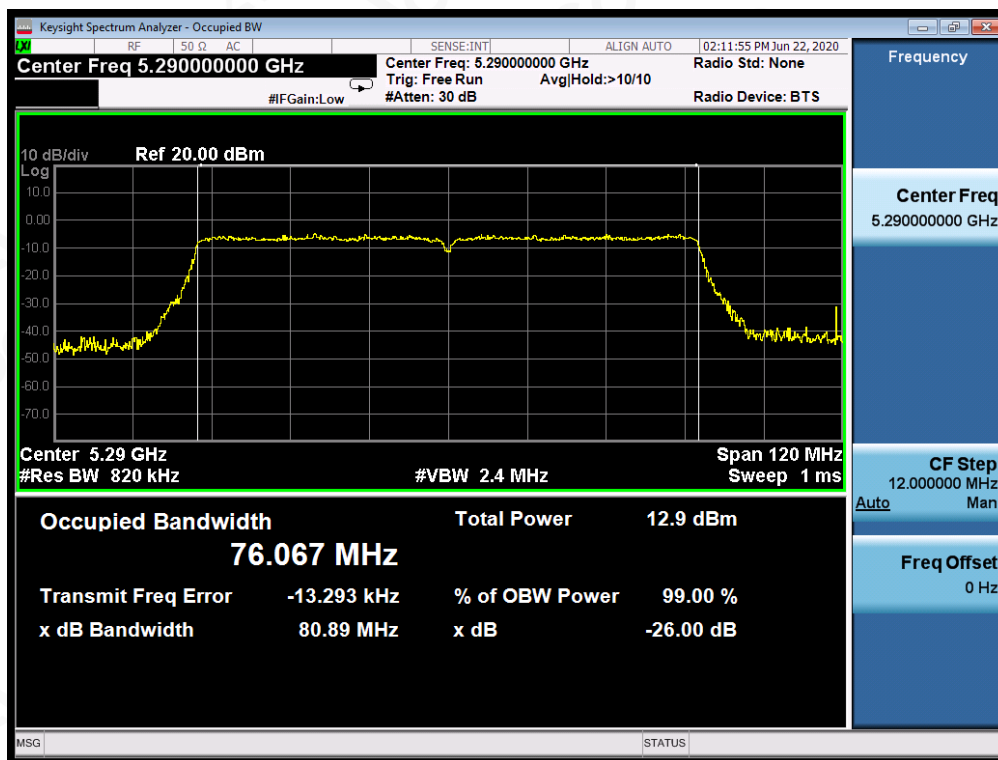

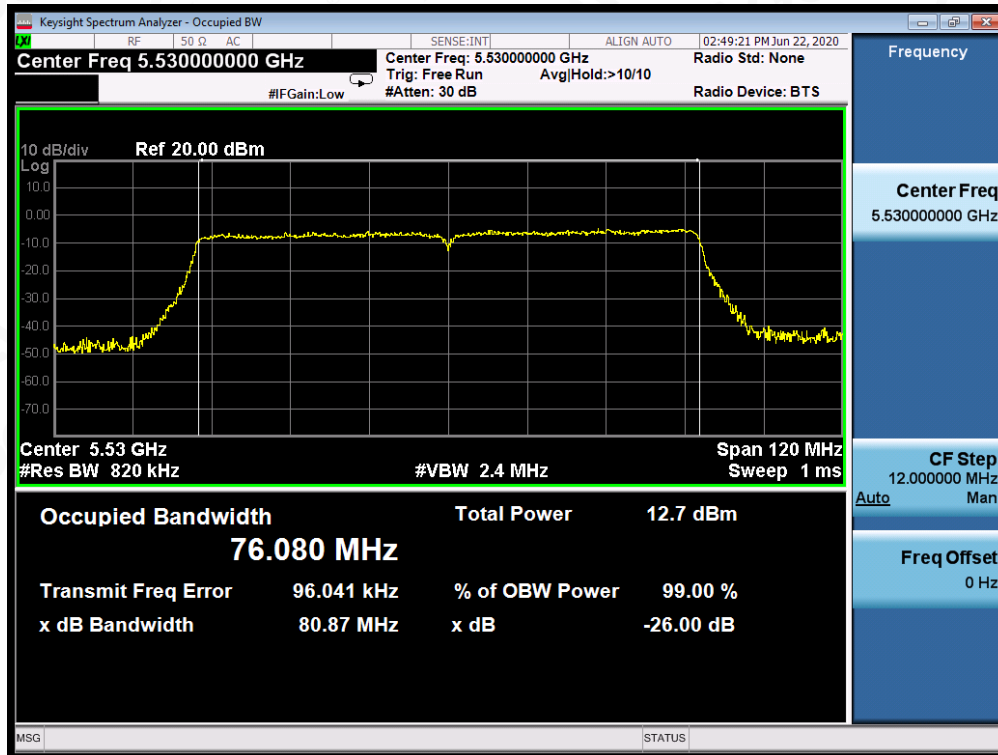

### TEST PLOT OF BANDWIDTH FOR 5530MHz



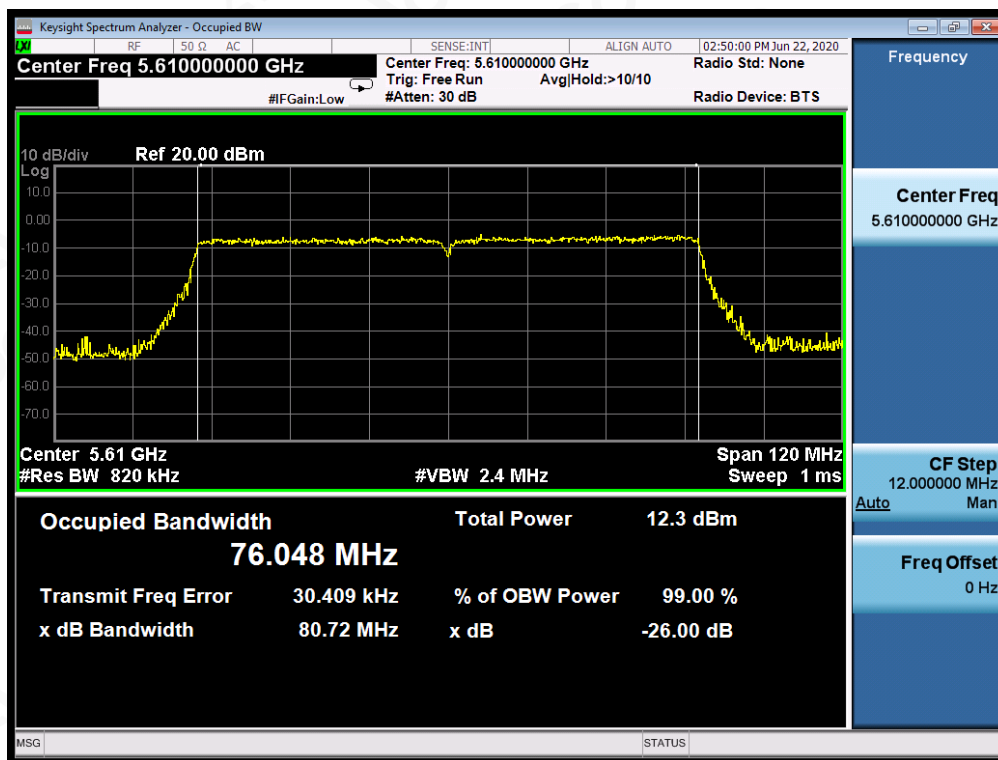

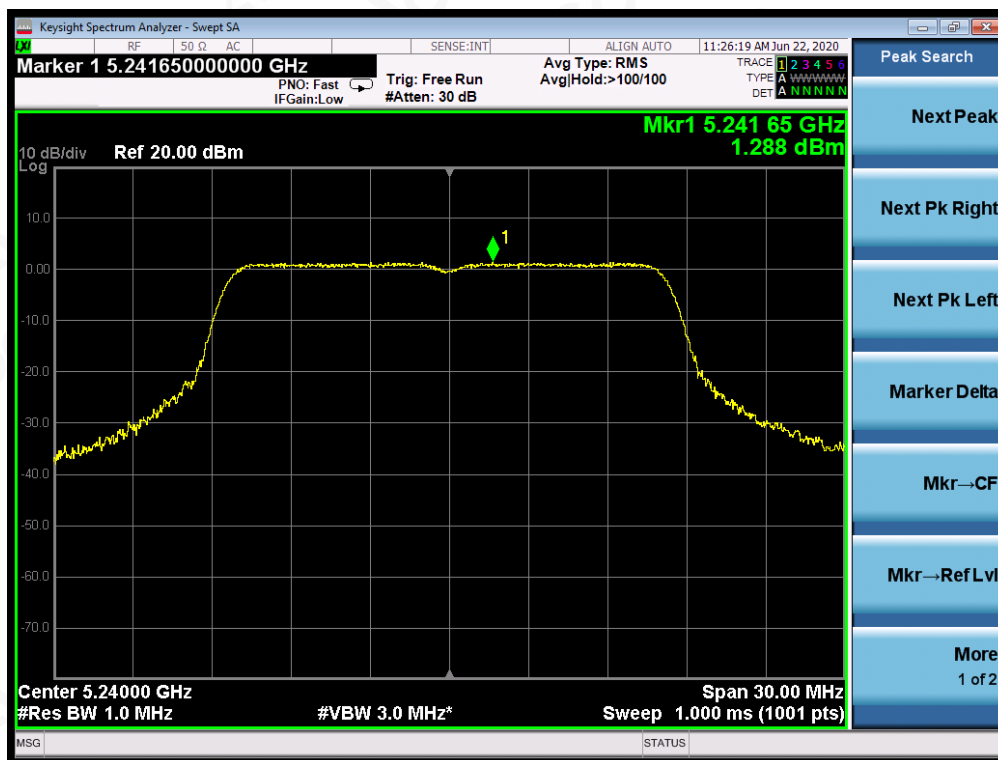

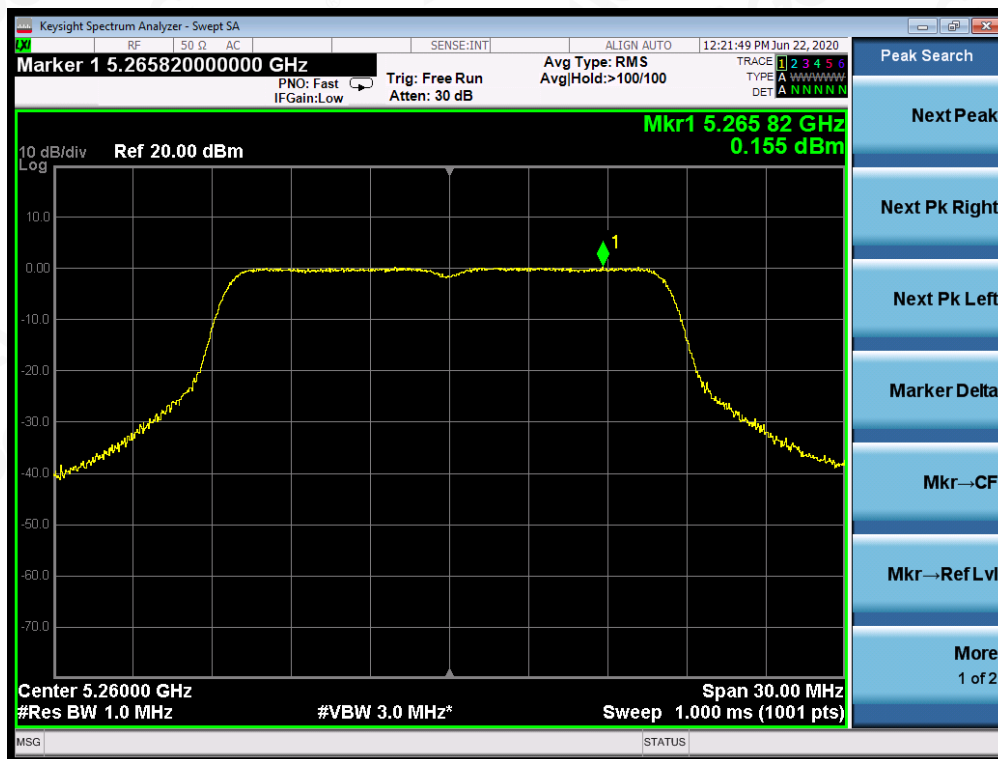

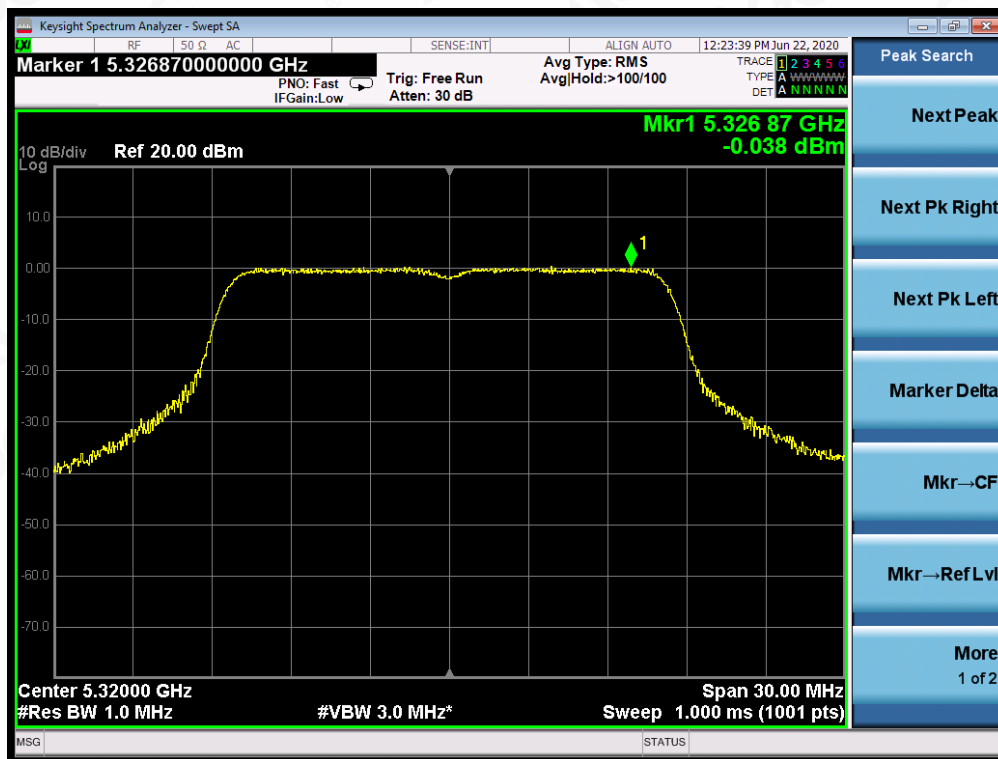




### TEST PLOT OF SPECTRAL DENSITY FOR 5300MHz



### TEST PLOT OF SPECTRAL DENSITY FOR 5320MHz

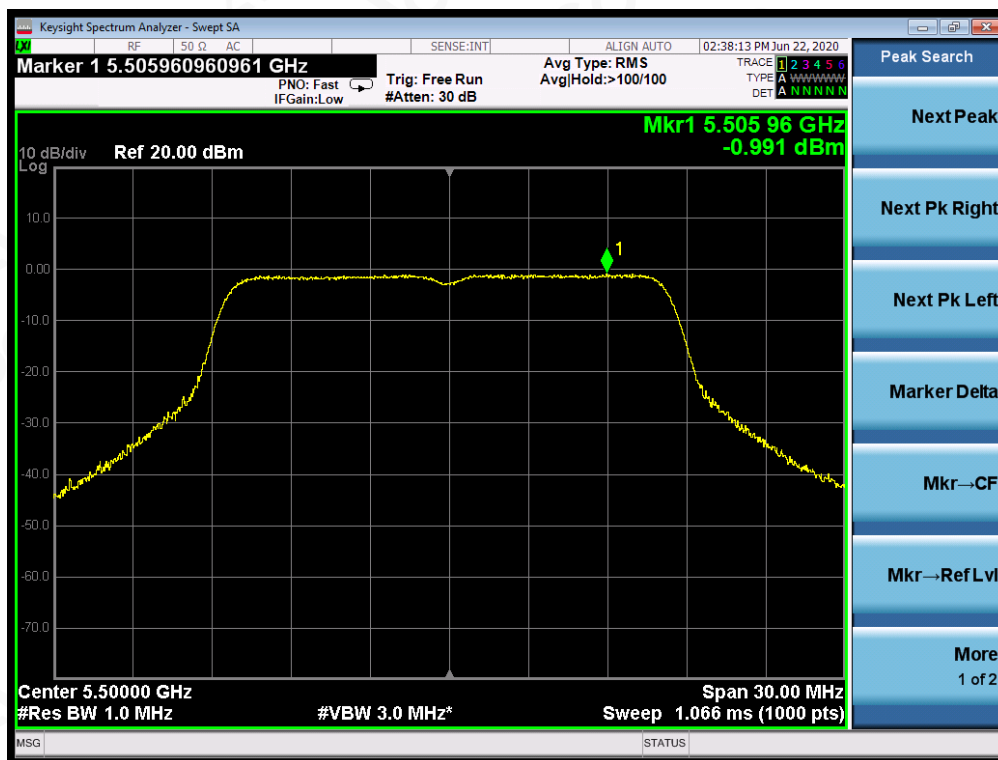

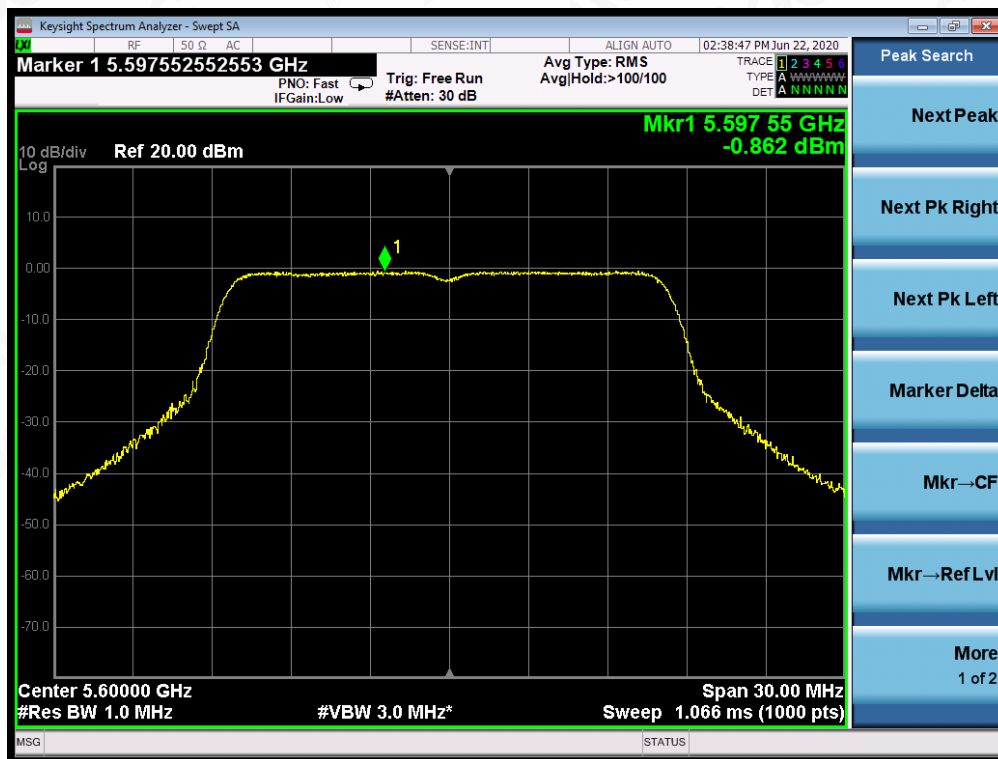

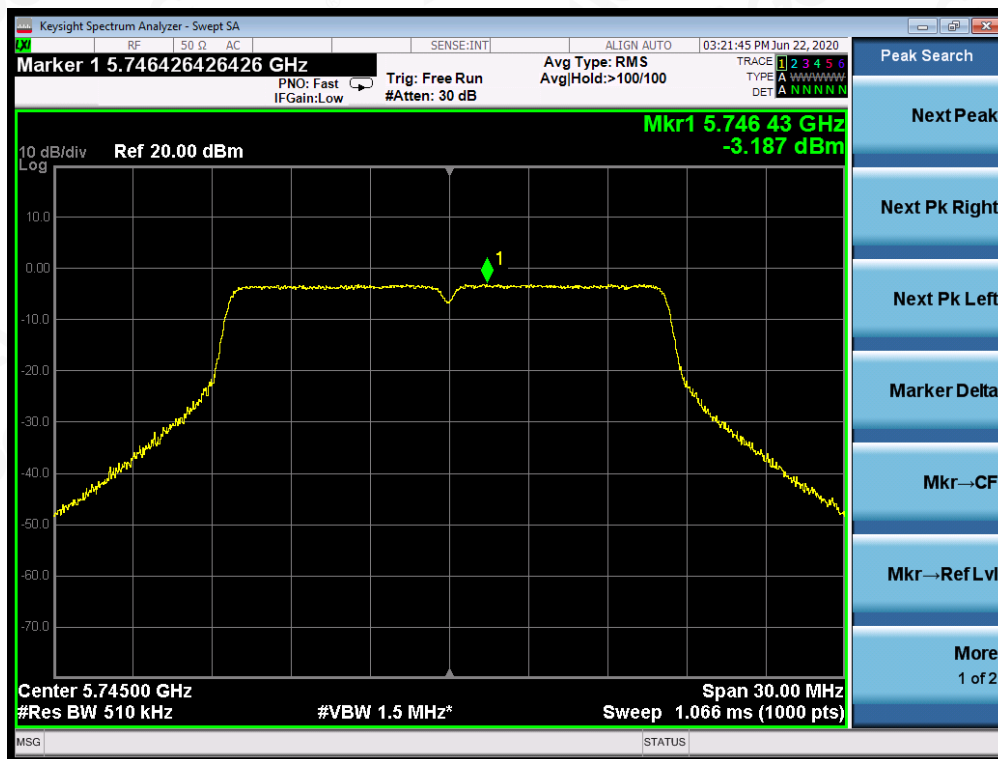

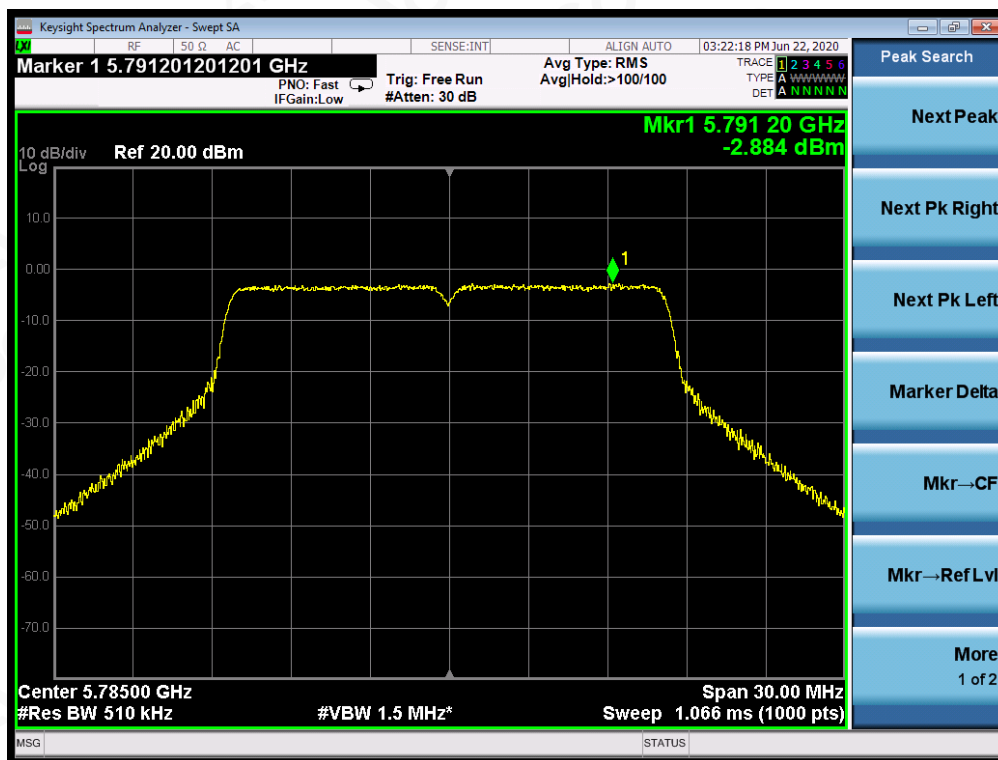

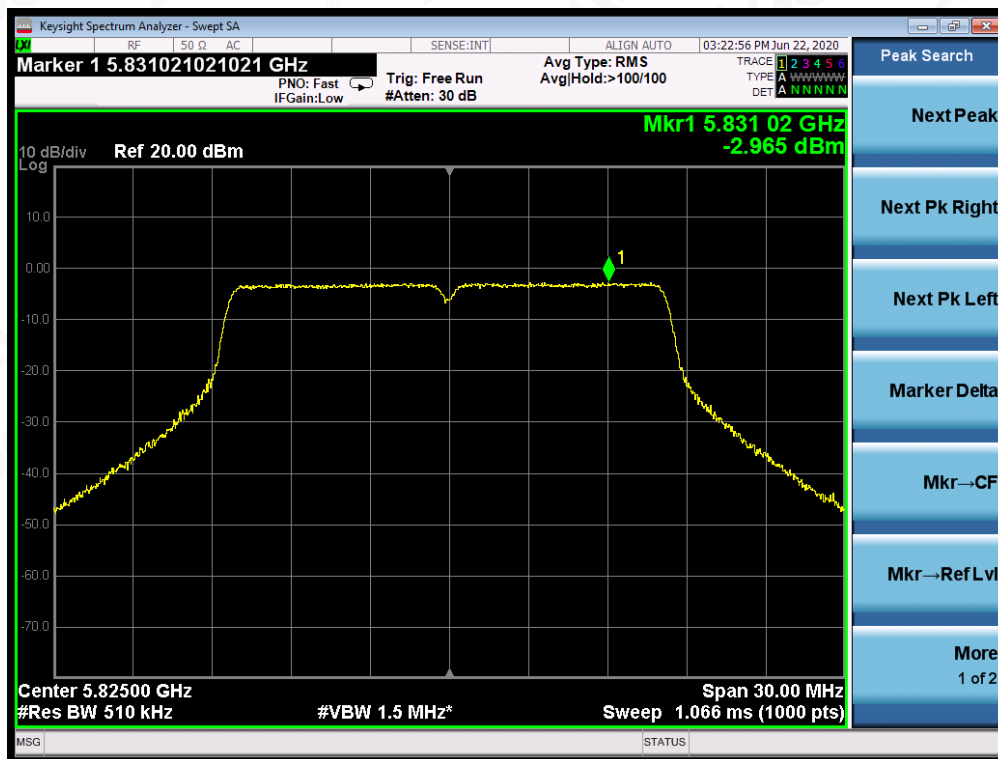

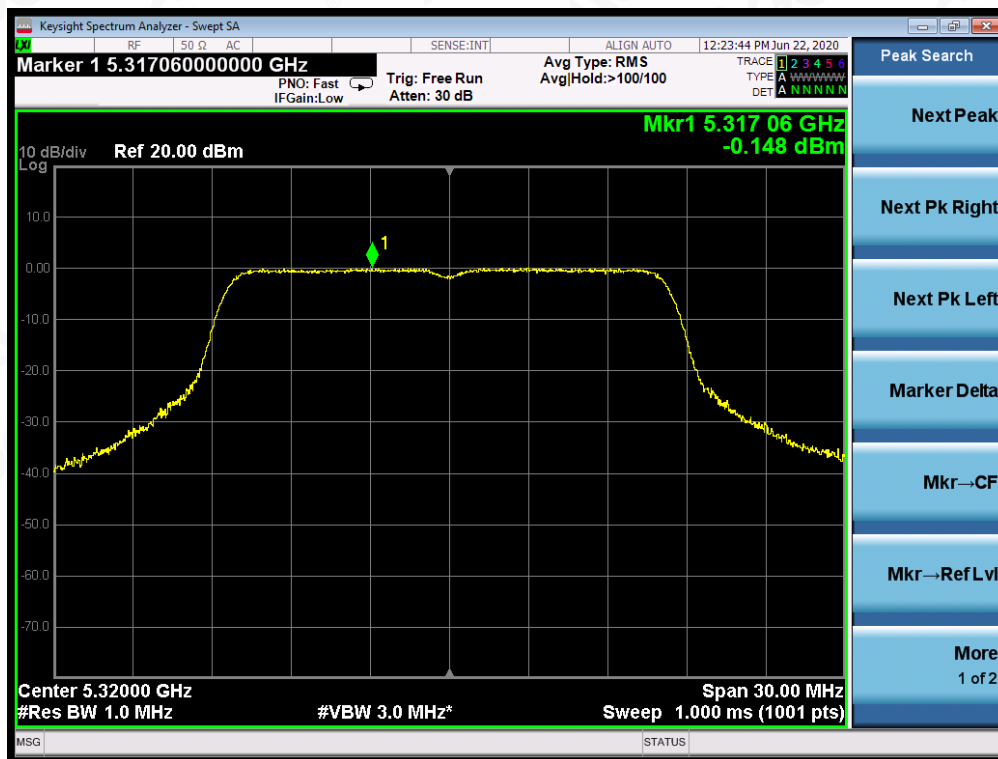

### TEST PLOT OF SPECTRAL DENSITY FOR 5320MHz

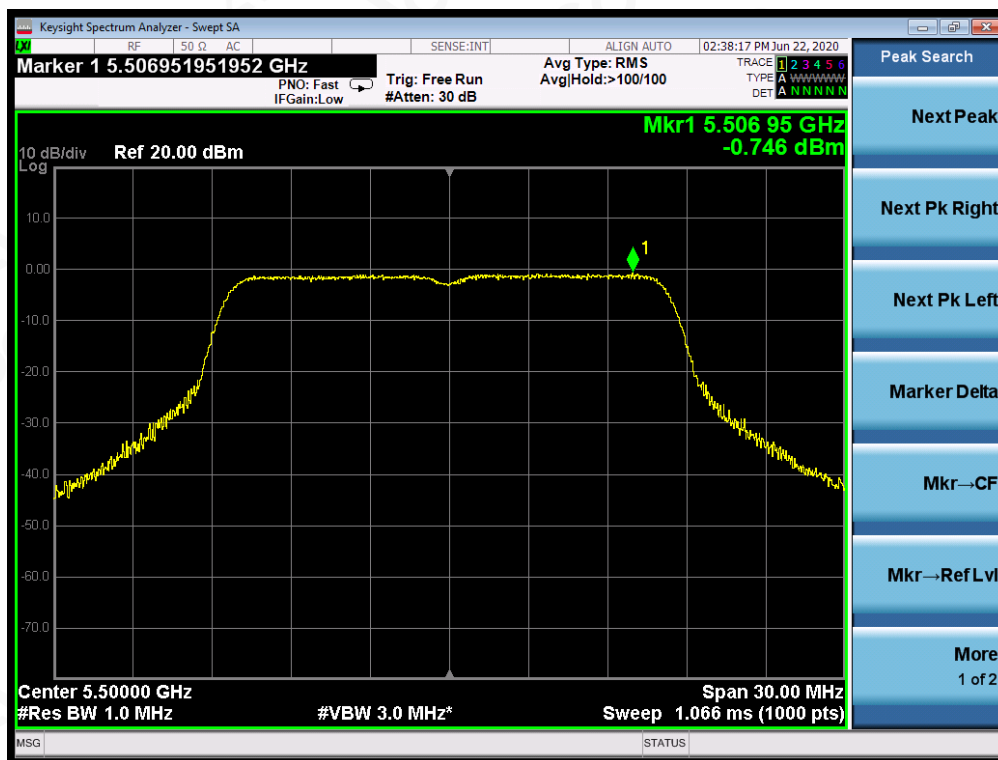

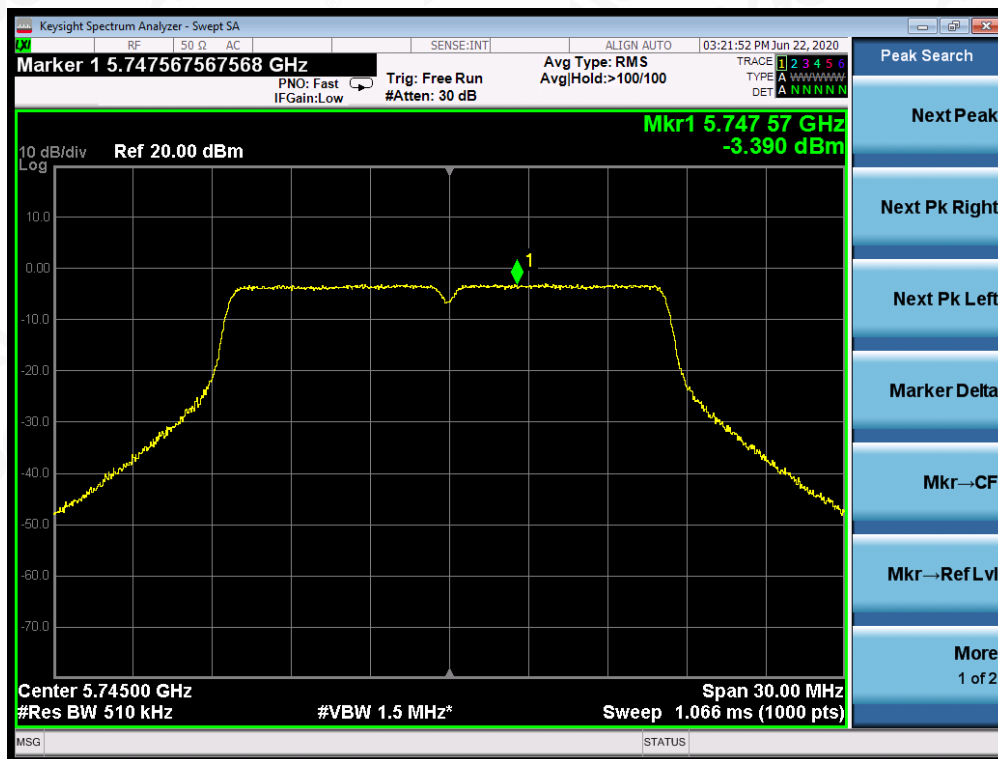




### TEST PLOT OF SPECTRAL DENSITY FOR 5700MH

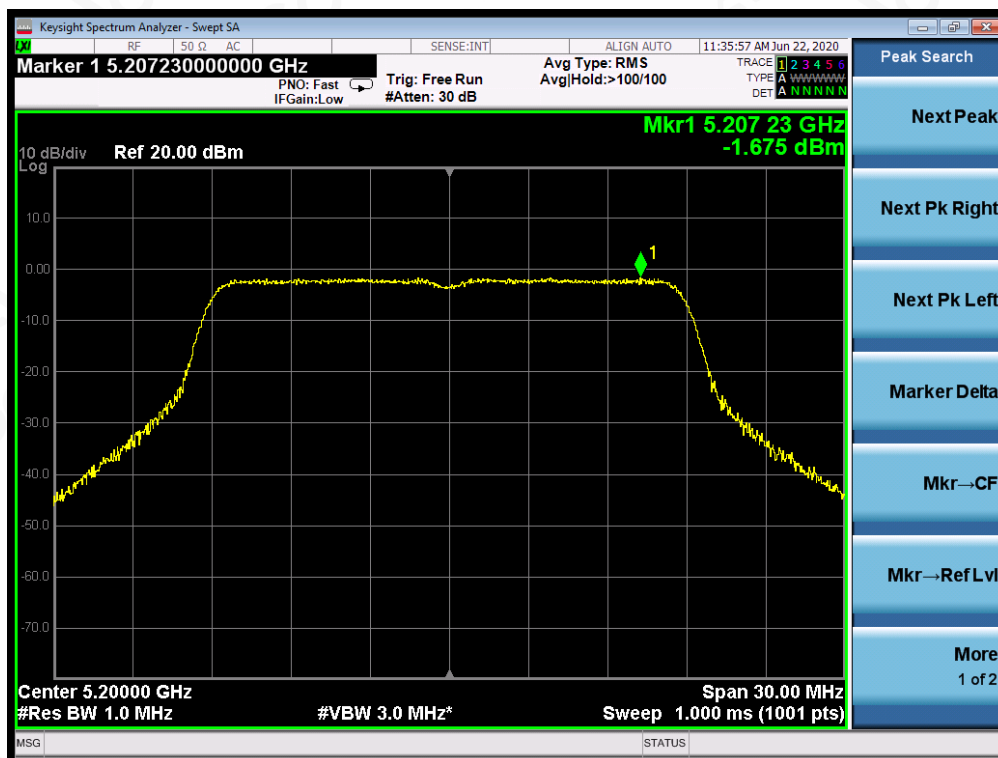

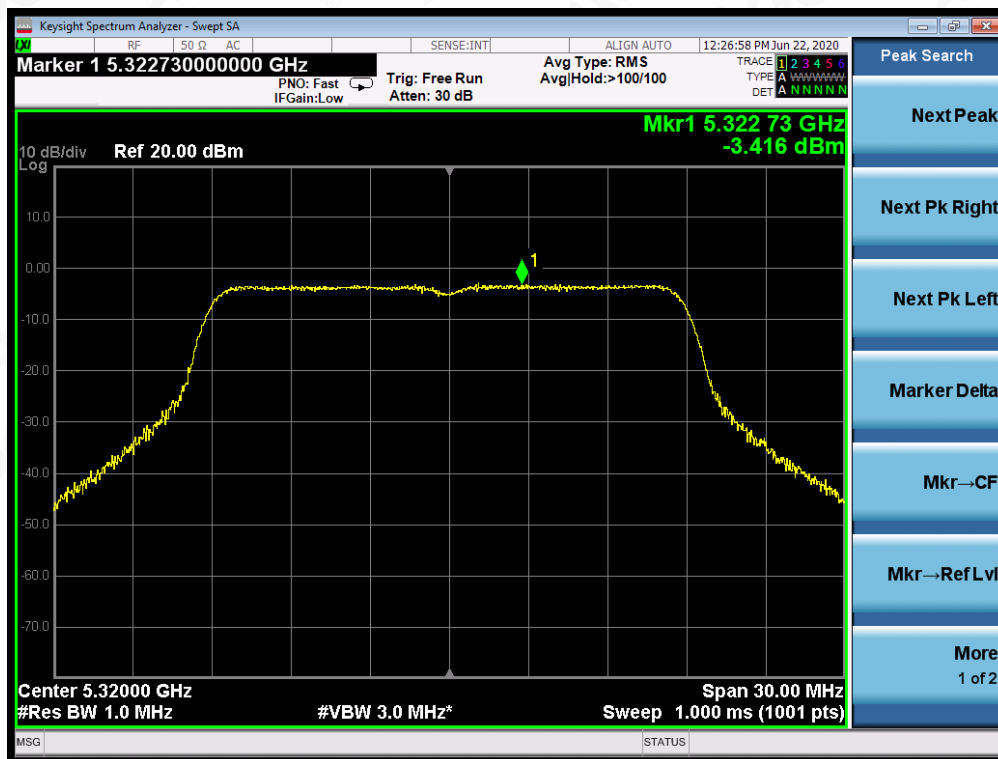




### TEST PLOT OF SPECTRAL DENSITY FOR 5300MHz



### TEST PLOT OF SPECTRAL DENSITY FOR 5320MHz

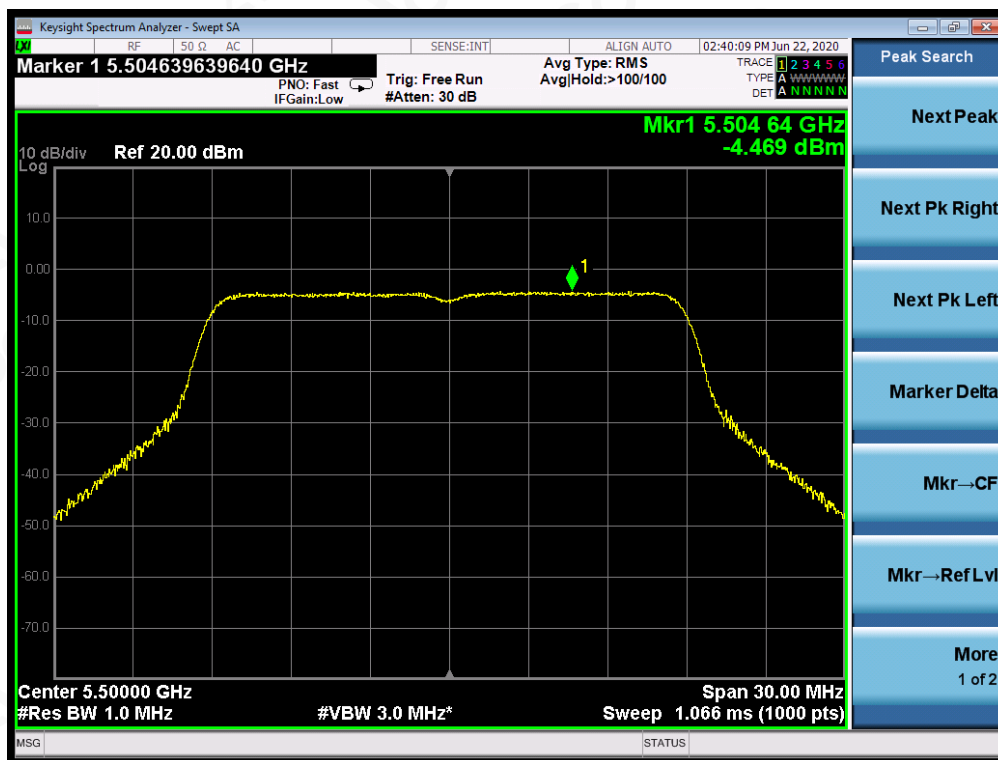

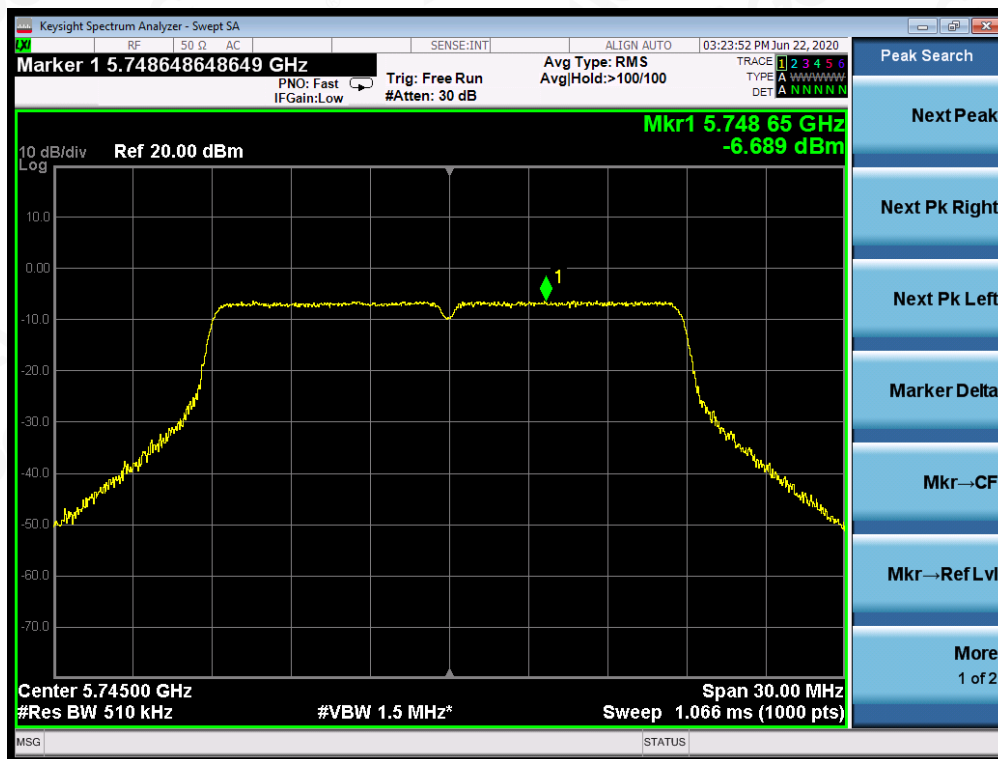




### TEST PLOT OF SPECTRAL DENSITY FOR 5700MH

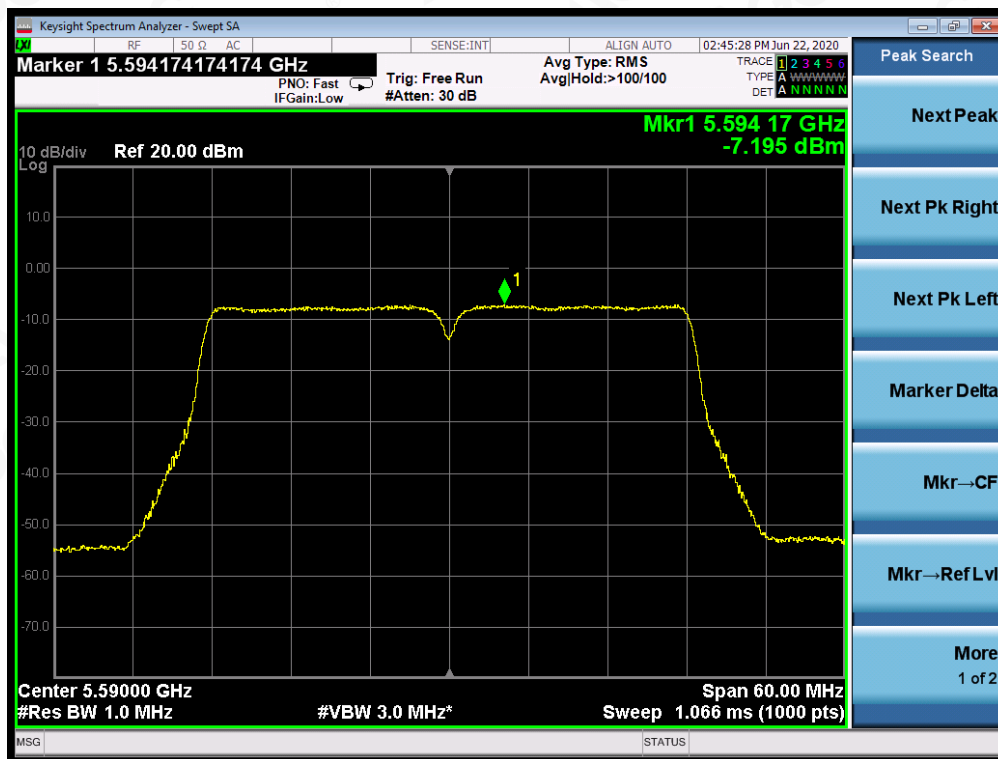




### TEST PLOT OF SPECTRAL DENSITY FOR 5510MHz

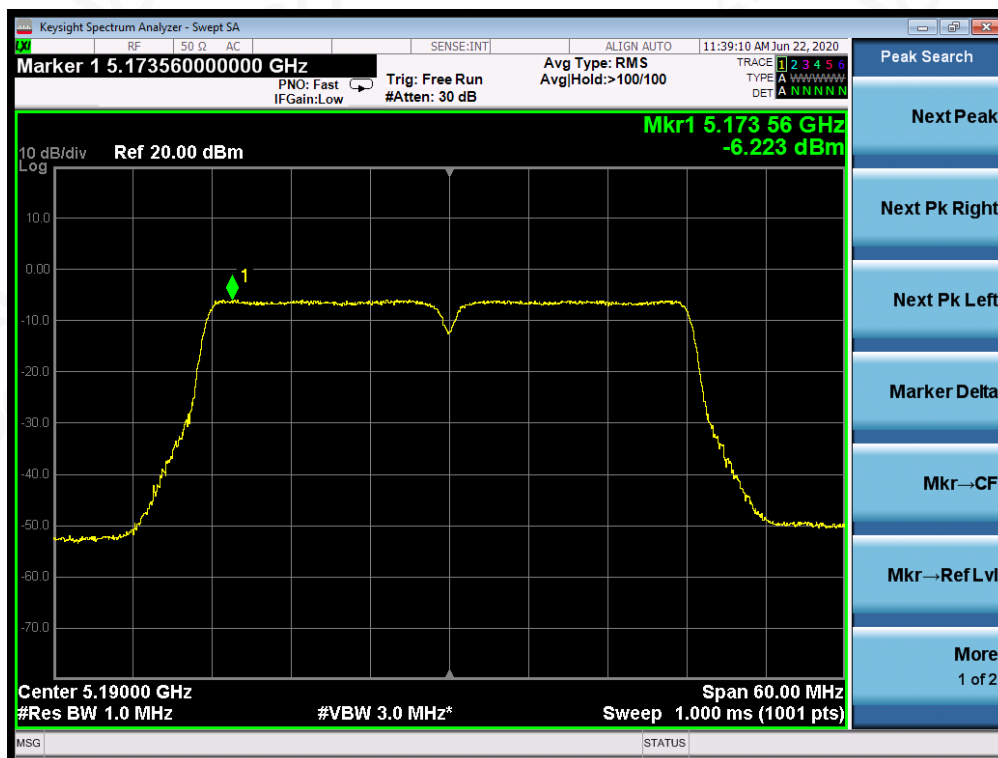


### TEST PLOT OF SPECTRAL DENSITY FOR 5795MHz
