I hope you have been well since we last spoke. I have had a chance to review the Permissive Change filing and have the following comments:

- 1) The external photos show that the enclosure has changed in shape. Please submit a new label exhibit, showing the text and placement of the FCC label with the two-part interference statement on the new enclosure.
- 2) Please submit a new user manual exhibit.
- 3) The internal photos show that the PCB layout has changed significantly. Please submit a new schematic exhibit.

4) The test data provided looks promising, but is incomplete with the test stopping at 1 GHz. The fundamental and the harmonics should be measured to show that they have not changed, and the full frequency range of test for a 2.4 GHz transmitter should be investigated for emissions.
