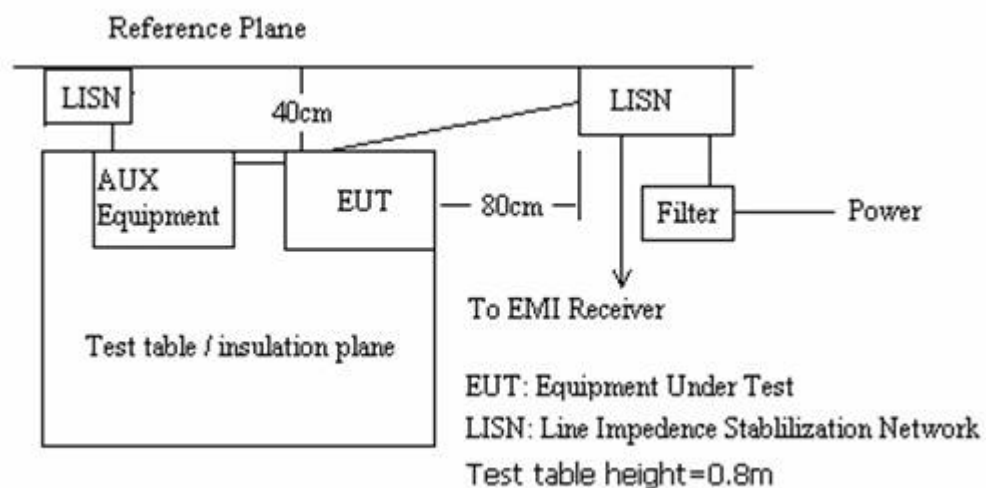

#### 6.1.2 Plan View of Test Setup



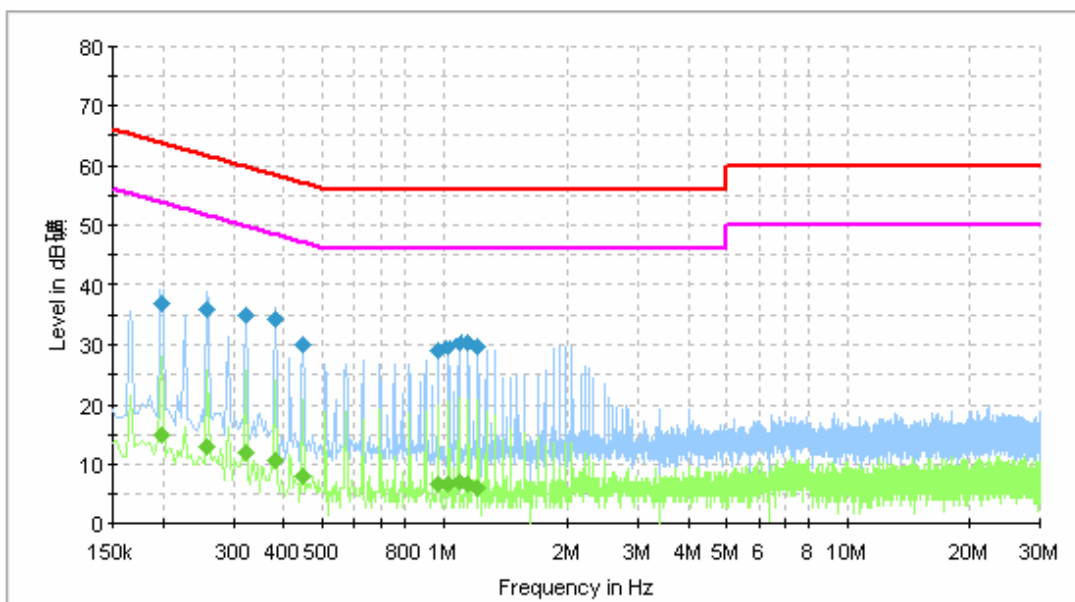

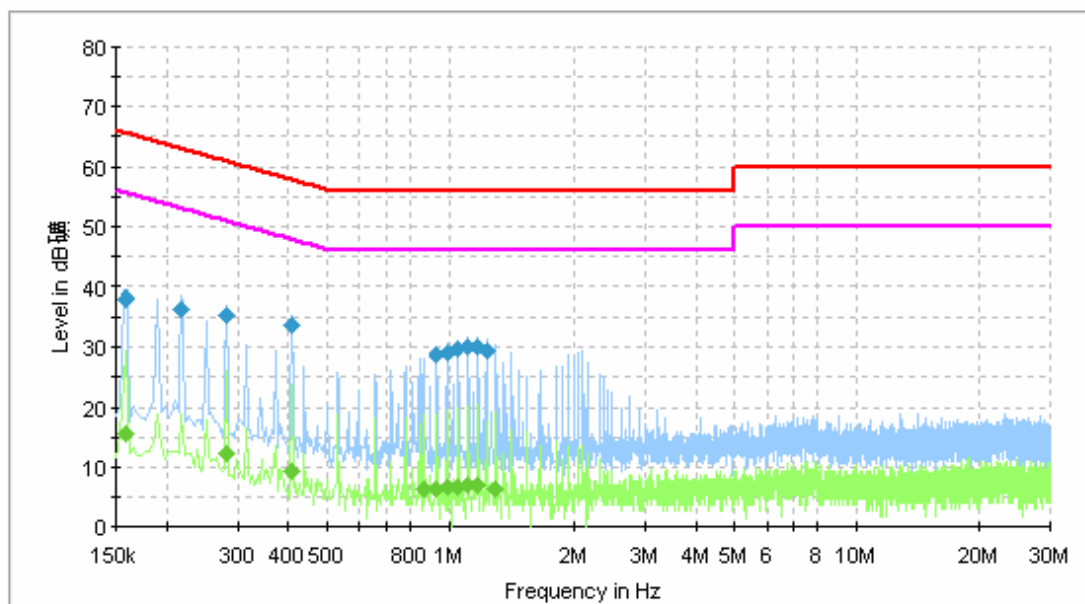

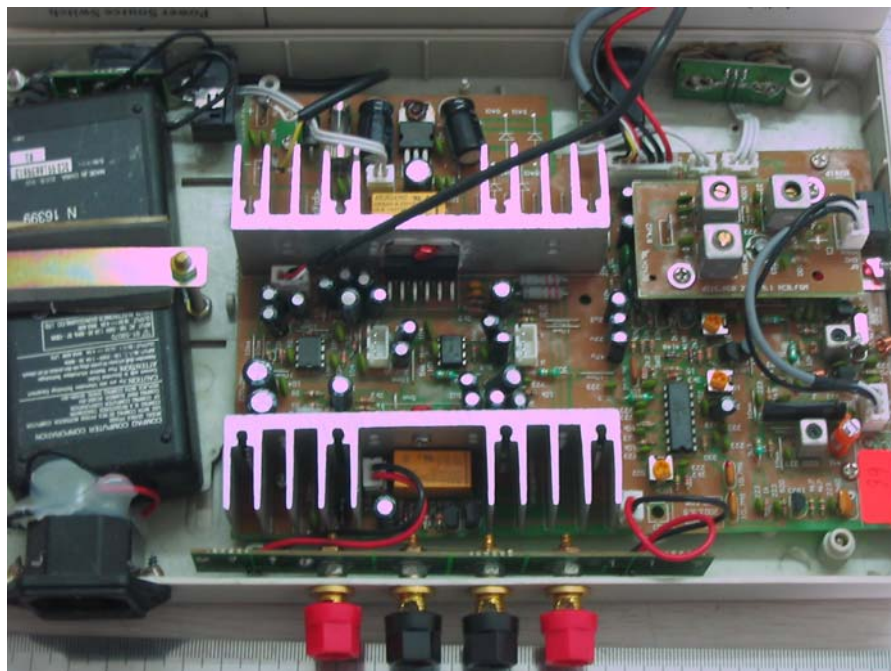
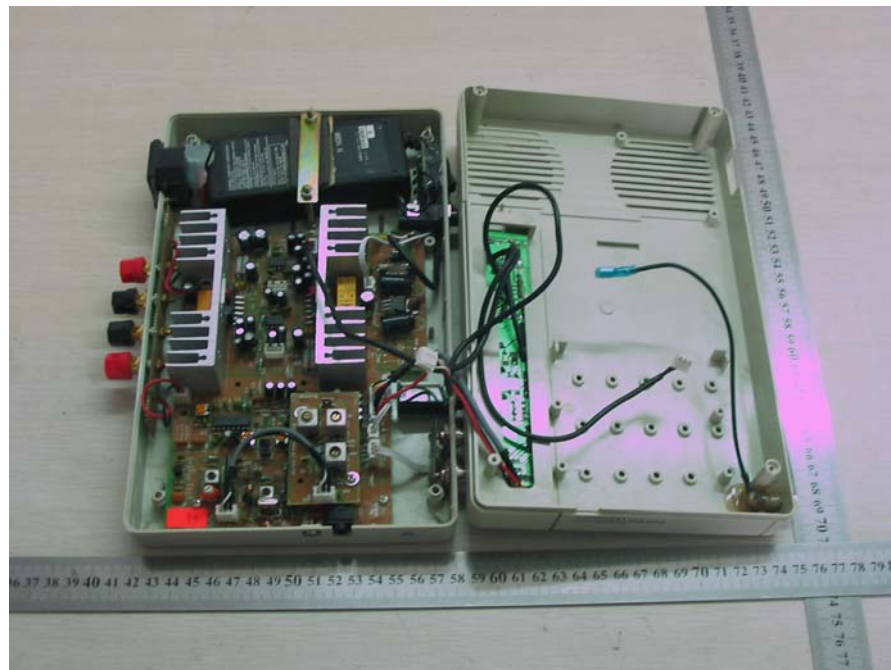
