Question #2: The FCC ID label format shows "UGJ SJ-5286AIII" instead of ""UGJSJ-5286AIII". Please remove the space between "HGJ" and "SJ-5286AIII".

Question #3: The FCC ID label format shows a FCC DoC logo, please explain why this device is subject to FCC DoC, for example, does the EUT have any port that can be connected to PC?

Question #4: Please check your report format, it happened before, the Dwell time plots are wrongly organized. Channel Low DH1, Channel Low DH3, Channel Low DH5 are actually Channel Low DH1, Channel middle DH1, channel High DH1... Please reorganize all the dwell time plots.

Question #5: Please check if the card shown on page 3 of the setup photos belongs to this EUT, if any test kit is used, please indicate clearly on the test report.

Question #6: This device is a hand-held device. The test report does not

show
that the device has been evaluated when placed in three orthogonal
planes. Please
explain.
