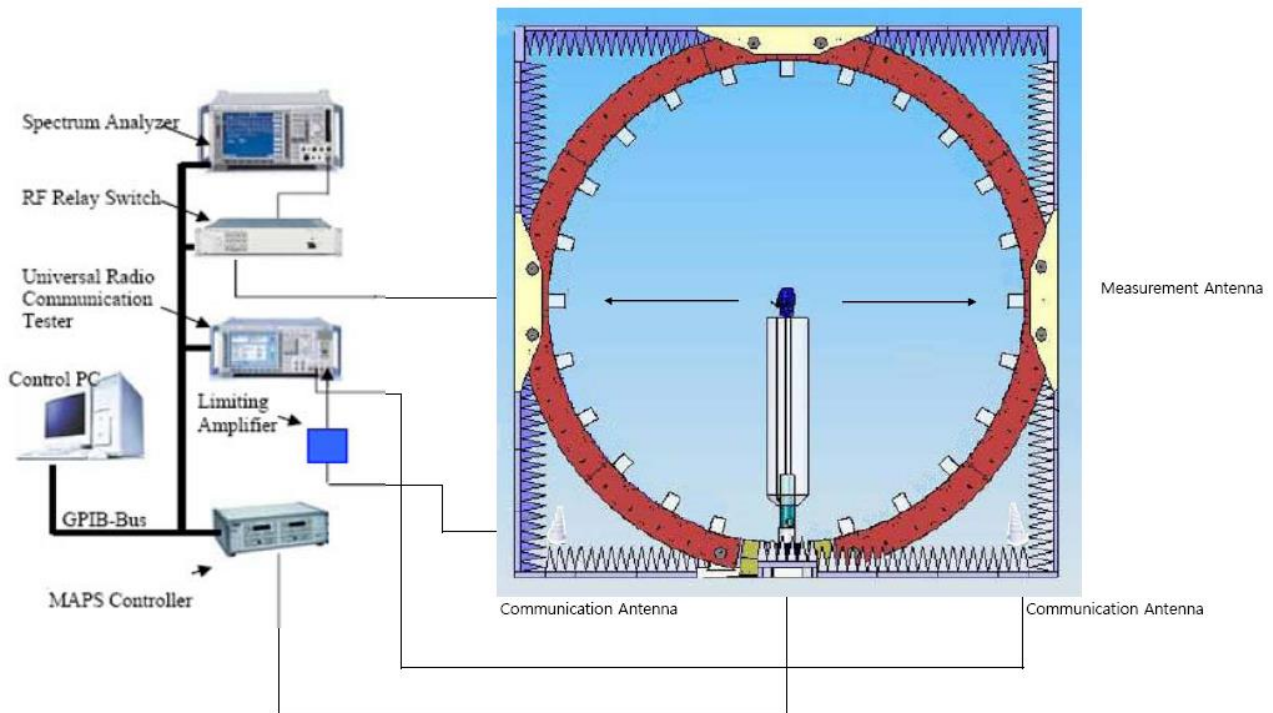

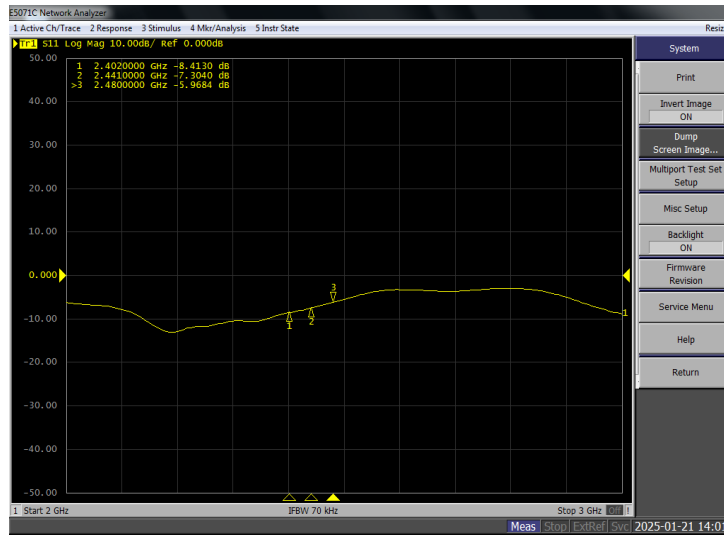

Free Space One Stick Controller

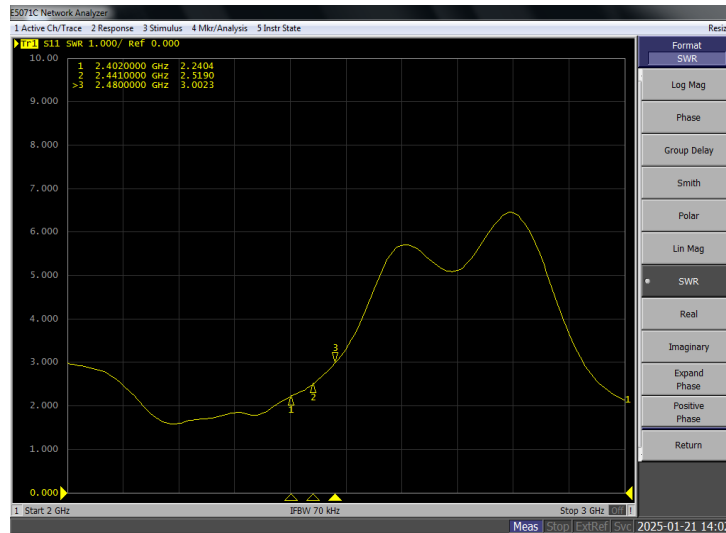

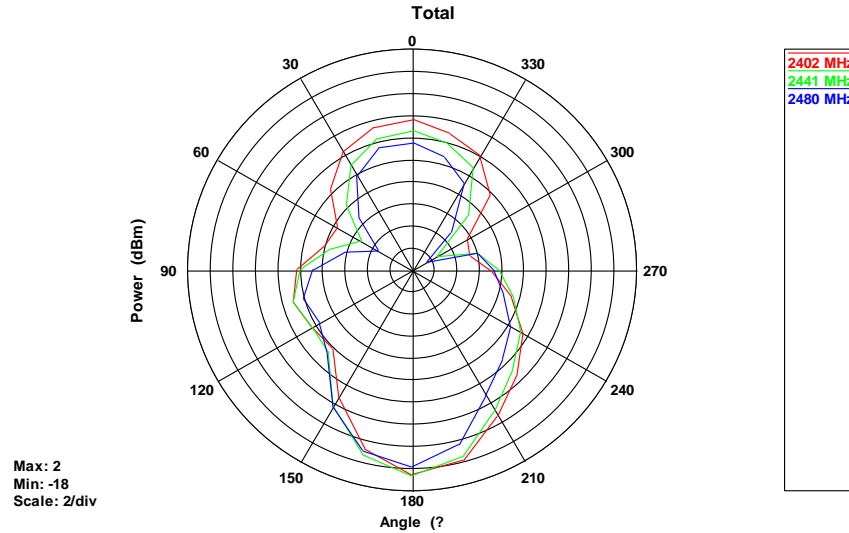

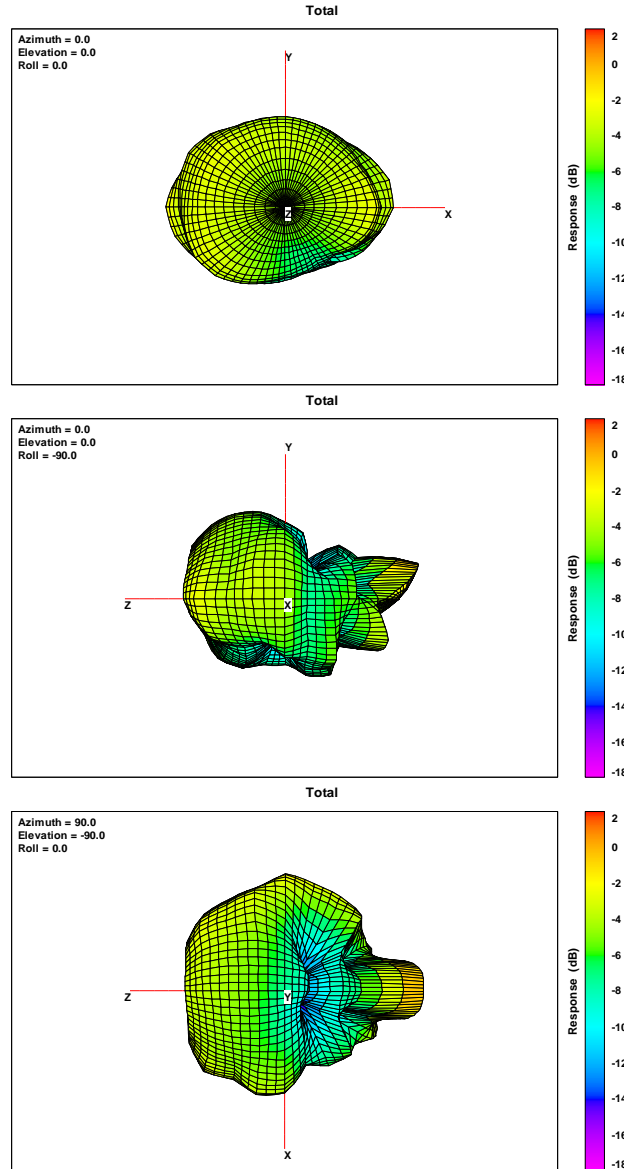
