

Where F is the frequency in MHz, The formulas for calculating the maximum permitted fundamental

field strengths are as follows: for the band 130-174MHz, μ V/m at 3 meters=56.81818(F)-6136.3636; For the band 260-470MHz, μ V/m at 3 meters=41.6667(F)-7083.3333. The maximum permissible unwanted emission level is 20dB below the maximum permitted fundamental level.

3.4.Operating Condition of EUT

3.4.1. Setup the EUT and simulator as shown as Section 3.1.

3.4.2. Turn on the power of all equipment.

3.4.3. Let the EUT work in measuring modes (TX) measure it.

3.5.Test Procedure

The EUT and its simulators are placed on a turntable, which is 0.8 meter high above ground. The turntable can rotate 360 degrees to determine the position of the maximum emission level. EUT is set 3.0 meters away from the receiving antenna, which is mounted on an antenna tower. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Broadband antenna (calibrated bi-log antenna) is used as receiving antenna. Both horizontal and vertical polarizations of the antenna are set on measurement. In order to find the maximum emission levels, all of the EUT location must be manipulated according to ANSI 63.4 on radiated emission measurement.

The bandwidth of test receiver (R&S ESI26) is set at 120KHz in 30-1000MHz, and 1MHz in above 1000MHz.

The frequency range from 30MHz to 3200MHz is checked.

Measurements were made using a peak detector and average detector. Any emission Above

1000MHz and falling within the restricted bands of FCC Part 15 Section 15.205 were compliance with the emission limit of FCC Part 15 Section 15.209.

2. The field strength is calculated by adding the antenna factor, high pass filter loss(if used) and cable loss, and subtracting the amplifier gain(if any)from the measured reading. The basic equation calculation is as follows:

$$\text{Result} = \text{Reading} + \text{Corrected Factor}$$

Where Corrected Factor = Antenna Factor + Cable Loss + High Pass Filter Loss – Amplifier Gain



4.2. The Bandwidth of Emission Limit According To Section 15.231(c)

The bandwidth of emission shall be no wider than 0.25% of the center frequency. Therefore, the bandwidth of the emission limit is $315\text{MHz} \times 0.25\% = 787.5\text{KHz}$. Bandwidth is determined at the two points 20 dB down from the top of modulated carrier.




6.1. Block Diagram of Test Setup

6.2. Average factor Measurement

Average factor in dB = $20 \log (\text{duty cycle})$

6.2.1. The specification for output field strengths in accordance with the FCC rules specify measurements with an average detector. During testing, a spectrum analyzer incorporating a peak detector was used. Therefore, a reduction factor can be applied to the resultant peak signal level and compared to the limit for measurement instrumentation incorporating an average detector.

6.6. Measurement Result

The duty cycle is simply the on time divided by the period:

The duration of one cycle = 4.4ms


Effective period of the cycle = $(2 \times 0.92) + (2 \times 0.44)$ ms = 2.72ms

$$DC = 2.72\text{ms}/4.4\text{ms} = 0.62$$

Therefore, the average factor is found by $20\log 0.62 = -4.2\text{dB}$



Radiated Disturbance


















