•Sensor advertises for 2 minutes looking for a connection before sensor powers off automatically.

After sensor is connected with App, sensor will then blink solid green light every 5 seconds.

Sensor starts transmission data to App after connection.

Sensor can be shut down by holding the sensor button for 3 seconds

- ·Sensor will flash red LED two time upon successful shutdown and power off.
- •Sensor will flash green two times and return to the current state if the button is not held for a long enough period of time.

When sensor disconnects with iOS device unexpectedly under below events, sensor will go into broadcast mode for 2 minutes looking to reconnect.

- •Turn off the Bluetooth radio for iOS device
- ·Force shut down app
- ·Take sensors out of range of iOS device
- ·Shut off iOS device
