If you consider the submitted operational description confidential, leave it on the letter requesting confidentiality but supply a cover letter exhibit for the FCC and IC explaining the differences in the original and modified devices. The address on these letters must agree with the address of record for the FCC and IC.

3. ATCB Comments: The agent letter for this application has a different address than the address of record in the FCC and IC databases. This letter shows 8300 89th Avenue North, Brooklyn Park, MN as the company address. Either have the FCC and IC databases corrected as suggested in item 1 and 2 or provide a new agent letter with the correct address.
