

- 2. Enable AP service from Ruckus Cloud management
- 3. Check EUD Tx Frequency and power
- 4. Disable AP service from Ruckus Cloud management
- a. Check EUD stops transmission within 10seconds.
- 5. Configure SAS granted CBSD to operate at frequency 3670-3690MHz & power level 8dBm/MHz
- 6. Enable AP service from Ruckus Cloud management
- 7. Check EUD Tx Frequency and power
- 8. Disable AP service from Ruckus Cloud management
- a. Check EUD stops transmission within 10seconds.






[Step 7] Check EUD Tx Frequency and power
