Dear Lee Eun-Won,

The review of your application is complete. There are a few items that need to be addressed. Items 1-3 require action by you. Items 4-5 are for information. If you have questions, please send email.

1. In addition to the 20 dB bandedge conducted measurements, compliance with the radiated emission limits of 15.209 is required at the restricted band edges at 2390 and 2483.5 MHz. Please add these measurements to the test report or in a separate report addendum

2. Per FCC 15.35(b) radiated emission limits above 1 GHz are based on use of an average detector. In this case a Quasi-Peak detector was used. This is acceptable provided the 1 MHz RBW and VBW were used. Please confirm the bandwidths used for the QP measurements. If the required RBW cannot be used, then peak or average measurements are necessary.

3. In addition to the data in item 2, peak data must be included to show compliance

limit on peak radiated emissions (20 dB above the average limit). Please revise the report or provide an addendum including the peak data.

4. As a point of information, in the future for measurements above 1GHz may be made with a Peak detector under the conditions of 15.35(b). If the average limits are met by the peak detector, then neither QP or average measurements are required.

5. The proper FCC equipment code for an FHSS system is DSS. This has been included in your application.
