

- 1. The EUT is placed on a turntable, which is 0.8m above the ground plane.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission.
- 4. Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:
 - (a) PEAK: RBW=VBW=1MHz / Sweep=AUTO
 - (b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO
- 5. Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.





Detector mode: Average Polarity: Vertical








8.2. POWER LINE CONDUCTED EMISSIONS MEASUREMENT

8.2.1. LIMITS OF CONDUCTED EMISSIONS MEASUREMENT

According to §15.207(a), except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). • The EUT and Support equipment, if needed, was placed on a non-conducted table, which is 0.8m above the ground plane and 0.4m away from the conducted wall.


- The test equipment EUT installed received AC main power, through a Line Impedance Stabilization Network (LISN), which supplied power source and was grounded to the ground plane. All support equipment power received from a second LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- The EUT test program was started. Emissions were measured on each current carrying line of the EUT using an EMI Test Receiver connected to the LISN powering the EUT.
- The frequency range from 150 kHz to 30 MHz was searched. The test data of the worst-case condition(s) was recorded. Emission levels under limit 20dB were not recorded.





Below 30MHz




Below 1 GHz
